Opinion

NOTE A – DESCRIPTION OF PLAN

The trust agreement establishing the Dearborn Schools Employee Healthcare Program Voluntary Employee Benefit Association (the Plan) was dated March 26, 2014, and the Plan began operating on April 1, 2014.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan provides health benefits covering substantially all active employees of the Dearborn Federation of Teachers, Association of Dearborn Schools Administrators, Dearborn Schools Operating Engineers Association, and Dearborn Federation of School Employees (the sponsoring organizations). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees of the Plan oversees governance of the Plan.

Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, dental, vision, and life) to all eligible employees of the sponsoring organizations and to their beneficiaries.

Current health claims of active participants and their beneficiaries are provided under group insurance contracts with various carriers, which are experience rated after the anniversary dates of the policies (generally July 1).

Contributions

The Dearborn Public Schools (employer) has agreed to make employer contributions and to remit employer contributions to be held in trust by the Plan in amounts established by collective bargaining agreements between the employer and each of the participating unions (sponsoring organizations).

Other

Although it has not expressed any intention to do so, the Board of Trustees is empowered to amend or terminate the Plan and related programs, procedures, rules, regulations, forms, and conditions, from time to time as it considers necessary or appropriate.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year. Purchases and sales of securities are recorded on a trade-date basis.

Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in GAAP more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings.

All investments of the Plan are stated at fair value. The plan reports its fair value measures using a three-level hierarchy that prioritizes the inputs used to measure fair value. This hierarchy, established by GAAP, requires that entities maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs used to measure fair values are as follows:

- *Level 1* – Quoted prices for identical assets or liabilities in active markets to which the organization has access at the measurement date.
- *Level 2* – Inputs other than quoted prices included in level 1 that are observable for the asset or liability, either directly or indirectly.
- *Level 3* – Unobservable inputs for the asset or liability. Unobservable inputs should be used to measure the fair value to the extent that observable inputs are not available.

When available, the Plan measures fair value using level 1 inputs as they generally provide the most reliable evidence of fair value.

NOTE C – LIABILITIES

Deferred Contributions

Deferred contributions represent contributions received prior to December 31 of each year for insurance premiums due in January for January coverage.

Binder Deposit from Employer

The Dearborn Public Schools (employer) has \$1,879,367 on deposit with the Plan to fund payment of current insurance premiums in the event the employer's monthly contribution is not timely received. The binder deposit is refundable in full to the employer in the event the Plan and union bargaining agreements are terminated.

NOTE D – BENEFIT OBLIGATIONS

Health costs incurred by participants and their beneficiaries are covered by insurance contracts maintained by the Plan. It is the present intention of the sponsor organization and the Plan to continue obtaining insurance coverage for benefits.

NOTE E – INVESTMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash and cash equivalents: Valued based on the published value of the underlying assets adjusted for distributions, reinvested dividends, and expenses. The net asset value (NAV) of the units of the accounts is used to determine fair value.

The fair value methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE G – TAX STATUS

The trust agreement establishing the Plan to hold the Plan's net assets is intended to qualify pursuant to Section 501 (c)(9) of the Internal Revenue Code, and, accordingly, the Trust's net income is exempt from income taxes. The Trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the Plan sponsor believes that the Trust and the Plan, as amended, continue to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities, generally for a period of three years after the filing date of annual tax returns. There are currently no audits for any tax periods in progress, and in the opinion of the Plan administrator there are no uncertain positions.

NOTE H – RISKS AND UNCERTAINTIES

The Plan has balances of cash held at a bank in excess of federally insured amounts. The Plan holds all funds in Federated Government Obligations Funds which are fully guaranteed against default. The Plan administrator does not believe the assets of the Plan are at risk as a result.

NOTE I – SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued. Events occurring after that date have not been evaluated to determine whether a change in the financial statements would be required.
