## Independent Auditor’s Report

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### Note 1: PLAN DESCRIPTION

The following description of Buchanan Group, Inc. 401(k) Retirement Plan (the Plan), is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Summary Plan Description.

#### General

The Plan is a voluntary 401(k) Plan sponsored by Buchanan Group, Inc., (the Company) for the benefit of their employees who become eligible the first day of the quarter following 90 days of employment. The Plan includes the following employers: Washington Park Cemetery Association, Inc., Catholic Cemeteries Association, Inc., Washington Park Services, Inc., Flanner and Buchanan, Inc., Buchanan Group, Inc., and Buchanan Group Services, LLC. The Plan is subject to the provisions of ERISA.

#### Contributions

Once an employee meets the eligibility requirements, they can participate in the Plan with Pretax and Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a group annuity contract and mutual funds. The Company contributes 100% of the first 4% that a participant contributes to the Plan. Contributions are subject to certain statutory limits.

The Plan follows Financial Accounting Standards Board's (FASB) Accounting Standards Codification (ASC) Topic 326, *Financial Instruments – Credit Losses*. The standard requires recognition of an allowance that reflects a current estimate of credit losses expected to be incurred over the life of the asset. As of December 31, 2024 and December 31, 2023, there were no allowances for uncollectible receivables for either year end.

#### Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in accordance with procedures established by the Plan administrator. Participants may then invest any portion of their account in specific assets or funds as permitted by the investment procedures.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Companies' contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in all contributions made to their accounts.

#### Plan Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested portion of his or her account in a lump-sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan also allows for hardship distributions.

The Plan agreement includes provisions authorizing loans from the Plan to active eligible participants. The amount of a loan shall be \$1,000, up to \$50,000, not to exceed 50% of the participant's vested account balance, net of any outstanding loans. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with local prevailing rates as determined by the Plan administrator. Interest income from participant loans was \$33,586 and \$22,704 for the years ended December 31, 2024 and December 31, 2023, respectively.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive investment contracts, are stated at fair value based on quoted market prices in an active market. Purchases and sales of securities are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Nationwide Life Insurance Fixed Select Annuity Contract is a fully benefit-responsive investment contract and is reported at contract value in the statements of net assets available for benefits.

#### Risks and Uncertainties

The Plan provides for certain investment options. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

#### Administrative Expenses

During the years ended December 31, 2024 and December 31, 2023, all professional fees for the administration and audit of the Plan were paid by the Plan or the Company.

The Plan's investments in mutual funds and an annuity contract (including investments bought, sold, and held during the year) reported net appreciation on investments of \$3,302,080 and \$3,615,978, for the years ended December 31, 2024 and December 31, 2023, respectively. Net appreciation on investments includes interest, dividends, and capital gains, and net appreciation in fair value of the Plan's investments.

### Note 4: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the assets or liabilities have a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Mutual funds are valued at the closing price reported in the active market in which the individual fund is traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and December 31, 2023, there were no significant transfers between levels.

### Note 5: INVESTMENT CONTRACT WITH INSURANCE COMPANY

At July 1, 2018, the Plan entered into an investment contract with Nationwide Fixed Select Contract. Nationwide Financial Services, Inc. maintains the contributions in a pooled account. The account was credited with earnings from underlying investments and charged for Plan withdrawals and administrative expenses charged by Nationwide. The contract was included in the financial statements at contract value, (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is fully benefit responsive. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and December 31, 2023 was \$962,265 and \$925,075, respectively. The contract does not have a maturity date but will continue in force until all assets have been distributed or no further payments are due.

### Note 6: PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. All professional fees for the administration and audit of the Plan are paid by the Plan or the Company. Fees paid by the Plan during the years ended December 31, 2024 and December 31, 2023, for services rendered by parties-in-interest, as defined by ERISA, were based on contractual and reasonable rates for their services.

The Plan invested in an investment contract managed by Nationwide Financial Services, Inc. as of December 31, 2024, and December 31, 2023, and as such, the investment qualifies as a party-in-interest investment.

Additionally, the Plan held notes receivable from participants totaling \$463,940 and \$445,264 at December 31, 2024 and December 31, 2023, respectively, which qualify as party-in-interest transactions.

### Note 7: TAX STATUS

In a letter dated March 31, 2014, the Internal Revenue Service (IRS) has determined and informed that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to examinations for a period of three years from the date the Form 5500 was filed.

### Note 8: INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, Note 3, and the supplemental Schedule H, line 4i - Schedule of Assets (Held at End of Year) at December 31, 2024; and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and December 31, 2023.

### Note 9: SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through the date of the Independent Auditor's Report, the date the financial statements were available to be issued, and has determined that no material events occurred that would require disclosure in the financial statements.
