We have performed audits of the financial statements of e.l.f. Cosmetics, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of the Plan

The following description of e.l.f. Cosmetics, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan sponsored by e.l.f. Cosmetics, Inc. (the Company). The Plan covers substantially all employees of the Company, except for part-time employees, and nonresident aliens. There is no age or service requirement to become eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants may also choose to contribute to the Plan on an after-tax basis, by designating a portion or all of their salary deferrals as Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes fixed matching contributions equal to 50% of each participant's deferrals up to a maximum of 4% of gross compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may also make profit sharing contributions, subject to certain statutory limits. The Company's Board of Directors determines any profit sharing contributions annually at its discretion. Participants must be employed by the Company on December 31 of each plan year to receive their portion of any profit sharing contributions, unless termination is due to death, permanent disability or the attainment of age 65 (the Plan's normal retirement age). No profit sharing contributions were made to the Plan for the year ended December 31, 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions, gains and losses on investments in the participant's account balance and allocations of (a) the Company's contributions and (b) administrative expenses that are paid by the Plan, if applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$500 up to 50% of the value of their vested account balance, or \$50,000, whichever is less. Note terms range from one to five years, except for notes used to purchase a primary residence, which have a higher maximum term. The notes are secured by no more than 50% of the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the note originates. The interest rates on the participant notes as of December 31, 2024, range from 4.25% to 9.50%, and mature through November 2034. Principal and interest are paid in equal installments through payroll deductions.

**Vesting:** Participants are immediately vested in their voluntary contributions and the Company's matching contributions, plus actual earnings thereon. Profit sharing contributions, plus actual earnings thereon, vest on a three-year cliff schedule. Participants also become fully vested upon death, permanent disability, plan termination or attainment of normal retirement age.

#### Note 1. Description of the Plan (Continued)

**Payment of benefits:** On termination of service, or upon attainment of age 59½, death, permanent disability or retirement, participants may elect to receive a lump-sum amount or installment payments equal to the value of their vested account balance. Hardship distributions are permitted if certain criteria are met. The vested account balances of terminated participants are automatically distributed if the vested account balance does not exceed \$5,000.

**Forfeitures:** On termination of service, unvested account balances are immediately forfeited. The Plan provides for forfeitures of terminated participants' nonvested accounts to be used to fund future employer contributions. For the year ended December 31, 2024, there were no forfeitures used to fund employer contributions. There were no forfeited, nonvested accounts as of December 31, 2024 and 2023.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Contributions:** Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Valuation of investments and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies using information provided by the Plan's trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the notes are fully secured by the participants' account balances. Delinquent loans are treated as distributions based upon the terms of the plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and accordingly have been included as an investment on the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

**Benefits:** Benefits are recorded when paid.

**Administrative expenses:** Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain record keeping fees paid by the Plan. Investment-related expenses are charged against net appreciation in fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Information Certified and Provided by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year), which was prepared by or derived from information provided by Fidelity Management Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year), related to the following assets at December 31:

#### Note 4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820, Fair Value Measurement and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

#### Note 4. Fair Value Measurements (Continued)

- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

**Mutual funds (registered investment companies):** Mutual funds are reported at fair value based on the quoted market prices of the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market funds:** Money market funds are valued based on the NAV of shares held by the Plan at year-end based on the publicly quoted market prices of these funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions used to determine the fair value could result in a different fair value measurement at the reporting date.

#### **Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 6. Tax Status**

The Plan has adopted a non-standardized pre-approved plan sponsored by FMR LLC. FMR LLC has received an opinion letter dated June 30, 2020, from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Related-Party and Party-in-Interest Transactions**

Fees incurred by the Plan for the investment management services are charged against net appreciation in fair value of investments. Fees paid to the recordkeeper were approximately \$1,200 for the year ended December 31, 2024.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the 2024 statement of net assets available for benefits.

#### **Note 9. Delinquent Participant Contributions**

During the 2023 plan year, the Company inadvertently failed to deposit \$89,741 of participants' contributions within the required time frame as stated by the DOL regulations, as such, these qualify as prohibited transactions. The Company deposited these participant contributions during the 2023 plan year with lost earnings deposited in 2024. These contributions were reported as delinquent contributions in 2023 on Form 5500.

No plan assets were used to correct these delinquent contributions.
