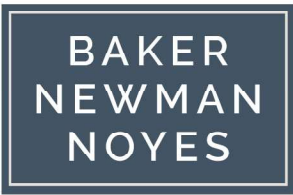

INDEPENDENT AUDITORS' REPORT

To the Plan Committee and Participants
Optima Dermatology Partners Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Optima Dermatology Partners Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

1. Description of the Plan

The following description of Optima Dermatology Partners Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan of Optima Dermatology Holdings, LLC (the Company) (formerly known as Summit Dermatology Partners, LLC) and was established effective January 1, 2003. Participating employers include The Indiana Clinical Trials Center, PC, The Dermatology Center of Indiana, Indiana Skin Care Center, P.C., and Advanced Dermatology & Skin Care Center, LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan is a defined contribution plan qualified under Section 401(a) and 401(k) of the Internal Revenue Code (IRC) covering eligible employees of the Company.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Eligibility and Participation

All employees, excluding union employees, nonresident aliens and leased employees, are eligible to participate in the Plan. In order to participate in employer contributions, an employee must also complete one year of service, as defined.

Contributions

Participants may elect to contribute pre-tax or Roth dollars, or both, up to 100% of their eligible compensation to the Plan, up to the Internal Revenue Service (IRS) limitation. Participants may elect to rollover distributions from other qualified retirement plans.

The Company provides for employer safe harbor matching contributions, discretionary matching contributions and non-elective profit-sharing contributions. The safe harbor matching contribution is equal to the sum of 100% of the amount of a participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of a participant's elective deferrals that exceed 3% of a participant's compensation, but do not exceed 5% of the participant's compensation. There were no employer discretionary matching contributions or non-elective profit-sharing contributions during the year ended December 31, 2024.

Rollover contributions are subject to conditions stated in the Plan and in the appropriate sections of the IRC.

1. **Description of the Plan (Continued)**

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, as well as all employer contributions, and earnings or losses thereon.

Plan Termination

Although it has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Participant Withdrawals

The Plan provides for participants to withdraw their funds at any time after reaching normal retirement age. Such withdrawals are based on the amount in the participant's account as of the valuation date coinciding with or immediately after the participant's retirement date. The Plan provides for in-service withdrawals after reaching 59 1/2 years of age, consistent with IRS regulations. Additionally, in-service withdrawals may be permitted from specific account types once a participant reaches the age of 35, subject to certain conditions as defined in the Plan document. The Plan also provides for withdrawals in the event of death, disability or termination, as well as hardship distributions. Vested account balances greater than \$1,000 and up to \$5,000 may be automatically distributed to an IRA on the participant's behalf upon termination of employment unless the participant elects a direct distribution to an eligible retirement plan. Vested account balances of \$1,000 or less may be automatically distributed to the participant in a lump sum on the participant's behalf upon termination of employment. Effective January 1, 2024, the cash-out limit increased from \$5,000 to \$7,000.

Included in the SECURE 2.0 Act provisions was a required change to the age at which required minimum distributions must commence from 72 to 73 for individuals who attain age 72 on or after January 1, 2023, and from age 73 to 75 for individuals who attain age 73 on or after January 1, 2033.

Notes Receivable from Participants

New loans are not permitted under the Plan. The outstanding notes receivable at December 31, 2023 were not significant and were grandfathered into this Plan as a result of a merger in a prior year. There are no outstanding notes receivable at December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions are recorded in the period in which payroll deductions are made; employer contributions are recorded in the year to which the contributions relate.

Investment Options

All contributions to the Plan are invested in the various investment options offered by the Plan at the election of the participants. Each participant selects the fund(s) to which contributions will be allocated. Participants also have the option to invest assets in a self-directed brokerage account (SDBA).

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes will materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

Preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 5 for further discussion and disclosures related to fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Administrative Expenses

Administrative expenses for the Plan are paid by the Plan Sponsor to the extent they are not paid by the Plan.

Reclassification

Certain prior year amounts have been reclassified to conform to the current year presentation.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

3. **Income Tax Status**

The Plan has adopted a pre-approved plan document sponsored by Sponsel CPA Group, LLC. The pre-approved plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements at December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. **Information Certified by the Custodian**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by Ascensus, LLC (Ascensus) (as agent for Ascensus Trust Company), the Plan's custodian, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedules. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan Administrator has obtained certifications from the custodian as of and for the year ended December 31, 2024 and as of December 31, 2023 stating that the information provided to the Plan Administrator by the custodian is complete and accurate. Such information includes investments, investment income, including interest and dividends and net appreciation in fair value of investments, investment transactions, notes receivable from participants and related transactions. The self-directed brokerage accounts totaling \$300,890 and \$710,844 at December 31, 2024 and 2023, and the related investment income for the year ended December 31, 2024, were not certified and were subject to audit procedures under auditing standards generally accepted in the United States of America. The related investment income was not significant for the year ended December 31, 2024.

Collective Trust Fund

The Plan holds an investment in the Goldman Sachs Stable Value Collective Trust (Goldman Fund), which is a stable value collective trust. The Goldman Fund seeks to earn current income, while seeking to preserve capital and stability of principal. The Goldman Fund seeks to maintain a stable net asset value (NAV) of \$1.00 per unit. The Goldman Fund invests in stable value investment contracts (Stable Value Contracts) and in fixed income instruments which underlie Stable Value Contracts as well as in money market instruments. Investments underlying Stable Value Contracts may be purchased directly or accessed via commingled vehicles and accounts that invest in such instruments. There are no restrictions on participant redemption, which may occur daily. If the Plan were to initiate a full redemption of the collective trust fund, then the issuer reserves the right to require twelve months' advance notice. There are no unfunded commitments related to this collective trust fund at December 31, 2024.

5. **Fair Value Measurements**

Fair value is defined as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

The fair value hierarchy for valuation inputs prioritizes the inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable for the asset and liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the quoted net asset value of shares held by the Plan at year end, which are traded in an active market and are classified as Level 1.

Self-directed brokerage accounts: Accounts primarily consist of cash funds and equities, including, common stocks, American depository receipts and exchange-traded funds that are valued at the closing prices reported on the active market.

Collective trust fund: Valued at the NAV of units of a bank collective trust held by the Plan at year end (see Note 4). The net asset value is used a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Party-in-Interest Transactions

The Plan is responsible for administrative fees to the extent they are not paid by the Plan Sponsor. Administrative fees consist of amounts paid to the recordkeeper and investment advisor. Such direct fees totaled \$53,004 for the year ending December 31, 2024. These transactions qualify as party-in-interest transactions. Additionally, fees paid by the Plan for investment management services are paid indirectly by Plan participants as a reduction of the return earned on each fund.

7. **Reconciliation of the Financial Statements to Form 5500**

Notes receivable from participants are reflected as receivables on the financial statements at December 31, 2023, which is different from the Form 5500 presentation. On Form 5500, notes receivable are classified as investments under the caption “participant loans.”

8. **Late Remittance of Participant Contributions**

During 2024, the Company was late in remitting certain participant contributions totaling \$312,526 within the timeframe required by the DOL. During 2024, the Plan corrected a portion of the late contributions totaling \$176,171 and remitted the related lost earnings of \$1,200. The Company intends to correct the remaining lost earnings as soon as possible.
