### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Chemours Company Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

### 1. Plan Description

#### *General*

The Chemours Company Retirement Savings Plan (the Plan) is a defined contribution plan established for the benefit of certain eligible employees of The Chemours Company and affiliates (Chemours or the Company) who elect to participate in the Plan with an effective date of July 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of Plan provisions.

The Plan covers substantially all employees of the Company and its participating subsidiaries. Eligible employees may participate in the Plan on the date they are hired (or rehired) by the Company.

#### *Plan Administration*

The Chemours Company administers the Plan and has appointed a Retirement Plan Committee responsible for development of Plan investment policies and guidelines; currently comprised of Company management.

Bank of America, N.A. is the Plan trustee, and also serves as record keeper.

#### *Eligibility*

Employees of the Company are considered eligible for participation, except for: (1) employees covered by a collective bargaining agreement that does not provide for participation in the Plan; (2) Temporary Employees.

An eligible participant can enter the Plan immediately upon meeting the eligibility requirements.

#### *Contributions and Vesting*

Participants are eligible to contribute from 1 to 90 percent of their eligible compensation to the Plan, in increments of whole percentages, up to the Internal Revenue Service (IRS) maximum. Unless Participants elect otherwise, they are automatically enrolled to defer 6% of their eligible compensation (automatically increasing 1% per year to a maximum of 15%). The Plan allows participants who will attain age 50 in the current Plan year to make catch-up contributions into the Plan up to the IRS maximum. Participants may also contribute amounts into the Plan from other qualified employer plans in which they had previously participated (rollovers). The Company makes a safe harbor matching contribution on behalf of each Participant after the Participant has commenced their employment. This matching contribution is 100% on the first 6% of a Participant's contributions. Employee deferrals and matching contributions and related earnings vest immediately. The Plan allows the Company to make a non-elective contribution (retirement savings contribution) to the Trust for each Plan year such amount as it shall determine in its discretion. The Company makes retirement savings contributions at the last day of each Plan year to all covered employees who received compensation, as a percentage of their compensation (for retirement savings contributions only, both required and discretionary, compensation is limited to \$100,000) between 1% and 3%. The annual contribution percent is based on the sum of each participant's age and years of service at the last day of the Plan year, such that a total sum of 90 or more is allocated

3%, a sum between 75-89 is allocated 2% and a sum below 75, allocated 1%. The required annual retirement savings contribution for the year ended December 31, 2024, amounted to \$5,024,015, which is included in employer contributions receivable in the accompanying statement of net assets available for benefits and was paid in spring of 2025.

The Company may also make a discretionary retirement savings contribution to the Plan each year. Discretionary retirement savings contributions to the Plan, if any, are divided among the accounts of all participants who are eligible to share in contributions in proportion to their total compensation from the Company for the portion of the determination period during which they are eligible to participate. No discretionary amounts were contributed in 2024.

Participants will have a 100% vested interest in their accounts related to retirement savings contributions after being credited with three years of service. Participants that are still employed by the Company at age 65, become totally disabled, die or have their employment terminated, will be 100% vested in their retirement savings contributions, regardless of service length.

### ***Forfeitures***

As of December 31, 2024 and 2023, the unused, unallocated forfeitures totaled \$643,851 and \$229,247, respectively. During the year ended December 31, 2024, \$144,551 of forfeitures were used to cover Plan administrative expenses.

### ***Investment Elections***

The Plan offers a variety of investment options selected by the Retirement Plan Committee. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants make investment elections in increments of 1% and may change these elections at any time. If a participant does not make an investment election, contributions will be made to the default investment chosen by the Retirement Plan Committee.

### ***Participant Accounts***

Each participant's account is credited with the Participant's and the Company's contributions and an allocation of net Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which Participants are entitled is the vested portion of their accounts.

### ***Notes Receivable from Participants***

Participants may generally borrow a minimum of \$1,000 from their account balance and up to 50% of their vested benefit to a maximum of \$50,000. Participants may have no more than two loans outstanding at any time. The term of a loan will be one to five years, at the election of the Participant, except for a loan to purchase the Participant's principal residence, which can be repaid over 10 years. Loans are secured by the Participant's account balance, bearing interest at the rate that is commensurate with rates charged by those in the business of lending money for loans that would be made under similar circumstances, and are repaid through automatic payroll deductions. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the Internal Revenue Code (IRC).

### ***Payment of Benefits***

Participants may withdraw funds from their accounts upon retirement, disability, separation from employment, attainment of age 65, and certain other times as specified in the Plan document. Distributions shall be made in any of the following manners: a lump sum in cash, in variable periodic payments, lifetime periodic payments or fixed payments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Once per year, a participant may change their election and select another periodic payment option.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ significantly from those estimates.

### ***Investment Valuation and Income Recognition***

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Retirement savings and discretionary contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### *Benefit Payments*

Benefits are recorded as distributions when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America N.A., the trustee of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

## **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Valuations based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Valuations based on inputs that are unobservable and significant to the fair value measurement.

The financial instrument's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Common/Collective Trusts (CCTs):** Common/Collective Trusts are a general investment type. Specifically, they can also be referred to as common trust funds or collective trust funds depending on their nature. Common/collective trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, Plan investments consisted of CCTs measured at fair value using the NAV per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023 respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

### 6. Related-Party Transactions and Party-In-Interest Transactions

Plan investments are managed by the Plan Trustee, Bank of America, N.A. and its affiliates. Transactions with the Plan Trustee qualify as party-in-interest transactions. There is a revenue sharing agreement between Bank of America, N.A. affiliates and the Plan that permits revenue to be used to pay Plan expenses, as defined, or to be allocated to participants. These revenues were de minimis in 2024. Fees incurred by the Plan for the investment management services are partially included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, the Plan paid the record keeper and custodian fees of \$338,437 which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts.

These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 7. Income Tax Status

The IRS has determined and informed the Plan by a letter dated June 22, 2017 that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions, however there are currently no such examinations for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan provides for various investment options. Such investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances. The Plan maintains a cash account, which, at times, may exceed federally insured limits. The Plan has not experienced any losses from maintaining cash accounts in excess of insured limits. Plan management does not believe that the Plan is exposed to any significant credit risks on its cash account.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date these financial statements were available to be issued.
