### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of SunEnergy1 LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the SunEnergy1 LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the SunEnergy1, LLC (the "Company"). The Plan was amended on September 8, 2023 to allow all employees to enter the Plan who had completed 30 days of service, as defined in the Plan, and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan administrator.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also make qualified Roth contributions to the Plan and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company offers automatic enrollment at 4% for employees, unless otherwise elected by the participants. The Plan provides for automatic increase of deferrals by 1% on January 1st of each year up to 16% of eligible compensation.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, collective investment trust funds, and a guaranteed investment contract as investment options for participants.

After completing one year of eligible service, the Company makes safe harbor matching contributions equal to 100% of the first 4% of the participant's eligible compensation. The Company may make discretionary profit sharing contributions. There were no discretionary profit sharing contributions made during the Plan years ended December 31, 2024 and 2023. Contributions are subject to certain limitations as determined by the Internal Revenue Code ("IRC").

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions, including amounts rolled over from other qualified plans, and Company safe harbor matching contributions plus actual earnings thereon.

##### **Vesting (Continued)**

Vesting in the Company's discretionary profit sharing contribution portion of their accounts is based on years of service. A participant is 100% vested after 6 years of credited service by which a participant vests 20% each year beginning in year two.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50 percent of their vested account balance. A participant may have one outstanding loan at a time. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate at the time of issuance, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through regular payroll deductions.

##### **Payment of Benefits**

The Plan permits withdrawals when a participant terminates employment, reaches normal retirement age or becomes disabled or deceased. Upon termination, participant consent is not required for distributions of an account balance less than \$5,000. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 1/2. Benefits are payable in lump-sum or partial payments.

##### **Forfeited Accounts**

Forfeited nonvested accounts totaled \$196 and \$-0- as of December 31, 2024 and 2023, respectively. These accounts may be used to pay administrative expenses or to reduce future employer Company contributions. During 2024, there were no reductions in employer contributions and/or reduction in plan expenses from forfeited nonvested accounts.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### **Investment Valuation and Income Recognition (Continued)**

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

##### **Contributions**

Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Expenses relating to specific transactions, such as loan set up, loan maintenance and distribution fees, are paid directly by the participant and are included in administrative expenses.

##### **Subsequent Events**

The Plan has evaluated events and transactions for potential recognition or disclosure through October 15, 2025, which is the date the financial statements were available to be issued.

#### NOTE 3 - INFORMATION CERTIFIED BY QUALIFIED INSTITUTION (Unaudited)

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Principal Life Insurance Company.

#### NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust funds:* Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There are certain participant redemption restrictions for the investment with respect to exchanges in investment options. Participants are allowed a maximum of 1 exchange per calendar month. There are no participant redemption restrictions over withdrawals for these investments; the redemption notice period is applicable only to the Plan.

#### NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a separate investment contract that meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan without limitations or restrictions. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and any applicable administrative expenses.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The Contract issuer maintains the contributions in a general account. The contract value of the fully benefit-responsive investment contracts at December 31, 2024 and 2023 are \$80,449 and \$63,554, respectively.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The interest rate is based on a formula established by the contract issuer. The interest rate may not be reduced for at least a 12-month period from the most recent rate reset date (when the declared rate becomes effective), but can be increased at any time. The declared interest rate cannot be less than the Minimum Guaranteed Interest rate of 1%. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

There are certain participant redemption restrictions for these investments with respect to exchanges in investment options. Transferred investment funds must be held in a non-competing investment option for 90 days before subsequent transfer to a competing fund can occur. Any amounts withdrawn by participants for benefit responsive reasons defined by the contract are fulfilled without restriction or adjustment. Any amounts withdrawn over 15% of the investment's contract value from the fund due to an event initiated by the Company, or by participants for non-benefit responsive reasons as defined by the contract, or by participants to a competing fund within the 90-day period, are subject to a market value adjustment. There are no participant redemption restrictions for the investment with respect to exchanges in investment options.

#### NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

#### NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fund management, custodial services, recordkeeping, transactions processing, loan maintenance services, and shares of the collective investment trust funds, and a guaranteed investment contract held in a general account are provided by Principal Life Insurance Company, subsidiaries, and affiliated companies, therefore, these transactions qualify as party in interest transactions. Investment advisor services were provided by Kestra Investment Services, LLC, therefore fees associated with this service qualify as party-in-interest transactions. These fees are included in net appreciation in fair value of investments and are paid through revenue sharing and realized investment gains rather than direct payment. Fees in excess of the revenue sharing are allocated to participant accounts and expensed.

#### NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

#### NOTE 9 - TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan received an opinion letter dated June 30, 2020 from the Internal Revenue Service that the prototype plan and related trust are designed in accordance with applicable sections of the IRC.

#### NOTE 9 - TAX STATUS (Continued)

Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 12 - NONEXEMPT TRANSACTIONS

During the 2020 plan year, the Company inadvertently failed to remit \$73,388 in participant contributions within the timeframe required by Department of Labor ("DOL") regulations. The Plan Sponsor fully corrected this failure by remitting the associated lost earnings during the year ended December 31, 2024.

During the 2024 plan year, the Company failed to timely remit \$712,833 in participant contributions. All late contributions and related lost earnings were fully funded and remitted during the year ended December 31, 2025. The lost earnings were paid from the Company's assets, not from Plan assets.

The Plan Sponsor intends to file a Form 5330 in 2025 to pay the applicable excise taxes. These late remittances are considered prohibited transactions under the ERISA and the IRC.
