Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Empire Recycling Corporation Employees' Deferred Savings and Profit Sharing Plan, an employee benefit plan subject to the Employees Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Empire Recycling Corporation Employees' Deferred Savings and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - Description of Plan:

The following description of the Empire Recycling Corporation (“Company”) Employees’ Deferred Savings and Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering all eligible employees of the Company and its wholly owned subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.
- B. Eligibility – Employees are eligible to participate in the Plan upon completing three months of service and have attained age eighteen.
- C. Contributions - Participants may contribute up to 100% of pre-tax annual compensation to a maximum of \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year may make “catch-up” contributions of up to \$7,500. Participants may also make “rollover” contributions from other qualified plans. The Company contributes a “safe harbor” matching contribution equal to 100% of the first 3% of employee deferrals plus 50% of the next 2% (maximum 4%). Additional discretionary matching and/or profit-sharing contributions may be made, as determine by the employer. The Company’s safe harbor match contributions were approximately \$340,000 for both years presented. No additional discretionary contributions were made in any of the years presented.
- D. Participant Accounts - Each participant's separate account is credited with the participant's contribution, their share of Company contributions and earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, see Note 2 (F). Participants’ direct investment of their account into various investment choices selected by the Plan's Administrator. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Upon an account reaching a predetermined amount, participants can direct their investment into an individual managed account.
- E. Vesting - Participants are immediately 100% vested in their contributions, employer safe harbor and non-elective contributions and earnings thereon. Employer matching and profit-sharing contributions, and earnings thereon, are vested 20% per year starting after the employee completes two years of service and are 100% vested after six years of service (Six year graded schedule). A participant is also 100% vested upon reaching normal retirement age, or in the event of death or disability while employed by the Company.
- F. Payment of Benefits - Upon termination of service due to death, disability, or retirement, a participant (or their beneficiaries) will receive a lump sum distribution unless they elect to receive distributions in the form of an annuity as soon as administratively feasible following the date on which a distribution is requested or otherwise payable.
- G. Participant Loans - Participants may borrow a minimum of \$1,000 up to a maximum of one-half of their vested accounts (not to exceed \$50,000). Repayments are to the participant’s account and interest is determined on a semi-annual basis for interest rates charged by local financial institutions for similar amounts and similar purposes.

NOTE 1 - Description of Plan (Continued):

- H. Forfeited Accounts – Forfeited nonvested accounts will be used to reduce future Company contributions. Amounts used to reduce Company contributions were immaterial for all years presented.
- I. Withdrawals – The Plan allows for financial hardship withdrawals for college education, purchase of a primary residence, prevention of eviction or foreclosure, and medical expenses. The Plan also allows for in-service withdrawals to participants attaining age 59 ½.

NOTE 2 - Summary of Significant Accounting Policies:

A. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles.

B. Use of Estimates

The preparation of financial statements in conformity with U.S. accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of Fair Value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments sold during the year as well as the unrealized gains and losses on investments held at year end.

D. Notes Receivable from Participants

Loans to participants are reported at their outstanding balance plus any accrued interest.

E. Payments of Benefits

Benefits are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, such as investment management fees, benefit payments and participant loans fees. They are charged directly to the participant's accounts and are included in administrative expenses. Expenses that are paid by the Company, such as audit fees are excluded from these financial statements.

NOTE 2 - Summary of Significant Accounting Policies (Continued):

G. Date of Management's Review of Subsequent Events:

Subsequent events were evaluated through October 9, 2025, the date the financial statements were available to be released. There were no subsequent events requiring recording or disclosure in the financial statements.

NOTE 3 - Fair Value Measurement:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy give the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are describe as follows:

- Level 1 - Input consist of unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Inputs consist of quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for assets.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan will maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used:

Pooled Separate Accounts: Are based upon the accumulation unit value, which is a combination of the fund's net asset value and separate account charges held by the Plan at year end (Level 2 Inputs).

Unallocated Fixed Contract: Is based upon the communicated guaranteed interest rates credited daily (Level 2 Inputs).

NOTE 4 - Tax Status:

The Plan adopted a prototype plan which received its latest favorable opinion letter on June 30, 2020. The letter stated that the Plan as designed was exempt from income taxes. Therefore, no provision for income taxes has been included in the plan's financial statements. Although the Plan has been amended since receiving that determination letter, the Plan administrator and the Company believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

The tax status of the Plan is subject to audit. Generally, years after January 1, 2022 are open to audit.

NOTE 5 Inactive Accounts:

Accounts of participants who have withdrawn from participation but for whom distribution from the Plan has not been made, totaled approximately \$1,620,000 and \$1,130,000 at December 31, 2024 and 2023, respectively.

NOTE 6 - Plan Termination:

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination participants will become 100% vested in their accounts.

NOTE 7 - Related-Party and Party-In-Interest Transactions:

Certain Plan investments are funds managed by VOYA Financial. VOYA is the custodian as identified by the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participant's accounts. Therefore, these transactions qualify as party-in-interest transactions.

NOTE 8 – Risks, Uncertainties and Concentrations:

The Plan's investments are exposed to various risks such as interest rate, credit, and overall market risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and possible that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The Plan's investments, although diversified through several different funds, are held by a single custodian, VOYA. The Plan is dependent on this Custodian for the safeguarding of its assets.

NOTE 9 - Legal Proceedings/Contingencies:

The Plan may engage legal counsel to defend it against potential litigation matters whether asserted or anticipated as the Plan's management judges necessary in the circumstances. The Plan does not believe that the outcome of any of those actions are either not covered by insurance or would have a material effect on its financial condition.

NOTE 10 - Financial Information Certified by the Custodian:

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA Retirement Insurance and Annuity Company (the Plan Trustee and Custodian).
