Their report dated August 8, 2024, indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Plan Description

The following description of the Bank of the James Financial Group, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Bank of the James Financial Group, Inc. and subsidiaries, Bank of the James, BOTJ Investment Group, and BOTJ Insurance, Inc., aside from union employees, leased employees, and nonresident aliens with no U.S. source income. Employees are automatically enrolled in the Plan at 7% on the first day of the month after satisfying eligibility requirements, unless they elect otherwise. The Plan also has an auto-escalation provision, where on January 1 of each year, participants’ deferrals increase automatically by 1% each year up to a 15% maximum, unless they elect otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute any percentage up to 90% of annual compensation on a pre-tax or Roth basis, as defined by the Plan, up to the maximum allowed by law. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct their contributions into various investments offered by the Plan. The Plan Sponsor provides a safe harbor employer matching formula of 100% of the first 2% of eligible compensation deferred, plus 50% of eligible compensation deferred between 2% and 6%, as defined. Additional amounts for the Plan Sponsor’s profit-sharing program may be contributed at the option of the Bank’s Board of Directors. There were no profit-sharing contributions for 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Bank’s matching and profit-sharing contributions, and allocations of Plan earnings and administrative fees. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the Bank’s safe harbor matching contributions, plus actual earnings thereon. Vesting in the Bank’s discretionary profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after two years of credited service.

Notes from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, with an interest rate equal to the Prime Rate. Repayment terms are not to exceed 5 years but may be extended up to 10 years for principal residence loans, as defined by the Plan. Loan payments are made by direct, after-tax payroll deductions. Participants may not have more than one outstanding loan at a time, and loans may not be paid out from Roth deferral balances. The loans are secured by the balance in the participant's account and bear interest at rates that ranged from 3.25% to 8.50% at December 31, 2024.

Payment of Benefits

Upon attainment of normal retirement at age 65, termination of employment, or in the case of death or disability, a participant or their beneficiary will receive the vested portion of the amount credited to the participant's account. Employees aged 55 or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to the provisions described in the Plan document. The participant may elect to receive a lump sum distribution, or periodic payments as defined in the Plan provisions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$4,896, respectively. Forfeitures may be used to reduce future employer contributions, reduce Plan expenses, or be allocated to eligible participants in the Plan. In 2024, \$5,248 in forfeitures were used to reduce employer contributions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Plan fees and administrative expenses are paid by the Plan or Bank on a discretionary basis.

Subsequent Events

Subsequent events have been evaluated through October 13, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

At December 31, 2024 and 2023, the Plan held investments in the Standard Insurance Company Stable Asset Fund II. Included in this group annuity contract are fixed income securities, mortgage loans, and other investments. The objective of the Standard Insurance Company Stable Asset Fund II is to provide plan participants with a guaranteed return of principal, along with competitive crediting rates and 100% liquidity. The average yield for this fund was 3.05% and 2.80% for the years ended December 31, 2024 and 2023, respectively. This contract is presented at fair value. The percentage of contributions allocated to the Standard Insurance Company Stable Asset Fund II is determined by the participants.

Note 4 – Related Party Transactions

Certain administrative functions are performed by employees of the Bank. These employees are also Plan participants. No such employee receives compensation from the Plan.

Plan investments were managed by Ascensus Trust Company during the year ended December 31, 2024, and therefore, these transactions are considered to be related party transactions. Fees paid by the Plan to Ascensus Trust Company for investment management and recordkeeping services for the year ended December 31, 2024, were \$22,886.

Ascensus Trust Company receives revenue from registered investment companies and collective trust service providers for service provided to the funds. This revenue is used to offset certain amounts owed to Ascensus Trust Company for its administrative services to the Plan. If the revenue is received by Ascensus Trust Company from such fund service providers exceeds the amount owed under an agreement between Ascensus Trust Company and the Company, Ascensus Trust Company will remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Ascensus Trust Company for administrative expenses not covered by revenue sharing.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 – Tax Status

The Plan is adopted under a prototype plan sponsored by Ascensus, LLC. The Internal Revenue Service (IRS) has determined and informed the Bank by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
