Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Metropolitan Companies, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 Description of Plan

The following description of The Metropolitan Companies, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of The Metropolitan Companies, Inc. and certain affiliates (collectively the “Sponsor”). There are no age requirements. Employees must have one year of service to participate in the Plan, however employees subject to the McNamara-O’Hara Service Contract Act are eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Substantially all of the Plan’s administrative costs are absorbed by the Sponsor.

Contributions

Each year, participants may contribute up to Internal Revenue Service dollar limitations as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor may make a discretionary matching contribution equal to a uniform percentage of salary deferrals that the participants have contributed. No discretionary contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

The Sponsor includes a prevailing wage contribution to the Plan for employees subject to the McNamara-O’Hara Service Contract. The prevailing wage contribution is made if the participant is not enrolled in the Employer’s Health and Welfare Plan. If the participant is enrolled in the Employer’s Health and Welfare Plan, then a prevailing wage contribution shall be made only to the extent that amounts remain after first offsetting the Employer’s: (1) payment of premiums for the participant’s insurance under the Employer’s Health & Welfare Plan and (2) payments, if any, that are necessary to maintain three months of reserves in the participant’s account in the Employer’s Health & Welfare Plan. This contribution is 100% vested. Contributions made in connection with the prevailing wage contract were \$1,093,259 and \$1,281,198 for the years ended December 31, 2024 and 2023, respectively.

Participant’s Individual Accounts

Each participant’s account is credited with the participant’s contribution, prevailing wage contribution (if applicable), Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contribution, prevailing wage contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their account is based on years of continuous service. A participant is 100% vested after five years of continuous service.

Payment of Benefits

On termination of service, death or upon reaching normal retirement age, a participant or beneficiary, at their discretion, will receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or installments over a period of not more than their assumed life expectancy, as determined at the time of distribution. Financial hardship withdrawals are permitted pending submission of verification to the Plan Administrator warranting the financial hardship.

Funding Policy

The Company remits employee deferral contributions to the Plan on a weekly basis. Prevailing wage contributions are made monthly.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$480 and \$461, respectively. Unvested portions of forfeited accounts shall be allocated in the same proportion as Sponsor profit sharing contributions. During the years ended December 31, 2024 and 2023, there were no forfeited non-vested accounts used.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America except for benefit payments which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Participant contributions are recorded when the Sponsor makes payroll deductions from eligible Plan participants. Prevailing wage contributions are accrued in the period in which they become obligations of the Sponsor.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies using information provided by the investment advisors and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to investment management services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3 Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023.

Following is a description of the valuation methodology used for investment assets measured at fair value.

Pooled Separate Accounts: Valued based on the daily net asset value ("NAV") of the units held by the Plan at year end, which is used as a practical expedient to approximate fair value. Investments in pooled separate accounts represent a unit of account whose per unit value is the result of the accumulated values of the underlying investments determined at their fair value (NAV). The pooled separate accounts are comprised of mutual funds. Certain of the Plan's assets are held in target date accounts based on a participant's anticipated year of retirement, focusing on delivering consistent risk-adjusted returns throughout a participant's retirement investment horizon. The remaining pooled separate account strategies are identified by the name of the investment.

The preceding method described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 Information Prepared and Certified by Trustee

Accordingly, as permitted under such election, Empower Annuity Insurance Company of America, trustee of the plan, certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 5 Party-In-Interest

All investments of the Plan are managed by an affiliate of the Plan's trustee, Empower Life and Annuity Insurance Company of New York. Transactions involving these investments are considered party-in-interest transactions. These transactions are, however, considered exempt under ERISA Section 408 and related regulations.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will be 100% vested in their accounts.

Note 7 Tax Status

The Plan Sponsor has adopted a prototype plan, in which the IRS has stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC requirements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by federal, state and/or local taxing authorities. Plan Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 9 Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date that the financial statements were available for issuance, for disclosure and/or recognition in the financial statements.
