## **INDEPENDENT AUDITOR'S REPORT**

To the Retirement Plan Committee of  
**U.S. Silica Retirement Savings Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of U.S. Silica Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the U.S. Silica Retirement Savings Plan (the “Plan”) provides only general information. U.S. Silica Company is the plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all eligible salaried and hourly employees of U.S. Silica Company and related companies who have adopted the Plan (the “Company”) excluding leased employees, nonresident aliens, and part-time or temporary employees who complete less than 1,000 hours of service. The Plan is administered by the U.S. Silica Retirement Plan Committee (the “Committee”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan’s assets.

Participation in the Plan is voluntary. All employees of the Company become eligible to participate in the Plan immediately following the completion of one hour of service, except as follows. Truck drivers of SandBox Enterprises, LLC are eligible to participate in the Plan after six months of service. Union employees of EP Engineered Clays Corporation hired after July 15, 2017 are eligible to participate in the Plan after 150 days of service. Employees of Fernley Boilermakers and seasonal workers are eligible to participate in the Plan on the first day of each month after completion of 30 days of service.

The Plan is participant directed and participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

**Contributions**

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to 100% of eligible compensation, subject to certain limitations provided under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible employees are automatically enrolled in the Plan at a pre-tax salary deferral rate of 3% unless they opt out or elect a different percentage. The Plan was amended effective January 1, 2024, to change to a qualified automatic contribution arrangement (QACA). Automatically enrolled participants under QACA will have their deferral rate increased by 1% annually on January 1 until a deferral rate of 10% is reached or they elect a different percentage. Prior to January 1, 2024, automatically enrolled participants had their deferral rates increased by 1% annually on June 2. The Plan also allows rollover contributions from other qualified retirement plans.

The Plan document provides for the following employer contributions to be made by the Company:

- Safe harbor matching contributions are made to all non-union participants in an amount equal to 100% of the first 6% of a participant's eligible compensation contributed to the Plan. The Plan was amended effective January 1, 2024 to change the contribution period from each pay period to each plan year.
- Discretionary additional matching employer contributions (Discretionary Match) may be made to non-union participants at year-end in an amount equal to a percentage of eligible contributions made by each participant during the plan year up to 4% of the participant's eligible compensation for the plan year. Union participants are eligible to the extent provided for in their union agreements. For 2024, the Company did not make a Discretionary Match.
- Discretionary nonelective contributions (Gainsharing Contribution) may be made to certain non-union, hourly participants employed on the last day of the plan year, allocated based on the ratio that each eligible participant's compensation bears to the total eligible compensation paid to all eligible participants. No Gainsharing Contributions were made during 2024.
- Discretionary nonelective contributions (DC Contribution) may be made to certain union participants employed on the last day of the plan year based on their union agreements. Participants with a current or earned pension benefit are not eligible for this contribution. DC Contributions totaling \$745,792 were made during 2024.
- Discretionary matching employer contributions (Basic Match) may be made to non-union hourly participants based on a percentage of the participant's salary deferral contributions made to the Plan each pay period. Union participants are eligible to the extent provided for in their union agreements. No Basic Match contributions were made during 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are at all times fully vested in their contributions, safe harbor matching contributions, and certain additional discretionary matching employer contributions, as defined in the Plan document, plus the appreciation or depreciation thereon. Other matching and nonelective contributions vest based on years of service as described in the Plan document and Plan amendment effective January 1, 2024. A participant is immediately vested upon death, retirement, or termination of employment due to total and permanent disability.

**Forfeitures**

Forfeitures are used to reduce employer contributions or to pay Plan administrative expenses. For the year ended December 31, 2024, forfeitures of \$74,896 were used to reduce employer contributions. There were no forfeitures used to pay Plan administrative expenses during 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$121,092 and \$12,901, respectively.

**Payment of Benefits**

Benefits are payable upon retirement, disability, death, or termination of service with the Company. Normal retirement age under the Plan is 65. Hardship withdrawals and in-service withdrawals for participants who have attained age 59½ are permitted. Participants may receive their distributions in a lump-sum or partial payment under certain circumstances. Qualified joint and 50% survivor annuity withdrawals from the EP Minerals Teamsters money purchase pension plan assets and nonelective contributions accounts merged into the Plan from the EP Retirement Savings Plan are permitted. Distributions of account balances less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid to participants in a cash distribution if the participant does not elect a distribution method. The Plan was amended effective January 1, 2024 to increase the automatic distribution threshold to \$7,000 and provide that any distribution greater than \$1,000 will be rolled over to an individual retirement account for the participant.

**Notes Receivable from Participants**

Plan participants may borrow Plan assets at a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. No more than one outstanding loan per participant is permitted. Loans are repaid in level installments through payroll deductions for periods ranging up to five years or up to 30 years for the purchase of a primary residence. The loans bear interest at reasonable rates as determined by the plan administrator at the time of the loan, and are secured by the participant's vested account to the extent of the principal amount of the loan plus accrued interest.

**Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and the Company matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The Company discretionary nonelective contributions are recorded in the plan year in which participant compensation is paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, trustee services, notes receivable from participants, withdrawals, and certain transaction fees are charged directly or allocated to the participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Money Market Fund:* Primarily invests in cash, U.S. Government securities, and/or repurchase agreements that are fully collateralized to maintain a stable \$1 share price. The net asset value (NAV) is a quoted price in an active market.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The Managed Income Portfolio - Class I (MIP) is a commingled pool managed by Fidelity. The MIP is valued using NAV, based on the market value of the underlying investments, as a practical expedient to determine fair value. The portfolio attempts to maintain a stable NAV of \$1 per unit. The portfolio's principal objective is to preserve the principal investment while earning interest income and primarily invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities, and money market funds. The portfolio allows for daily liquidity with no additional days' notice required for redemption for participant-directed transactions. Were the Plan to initiate a full redemption, the trustee of the portfolio reserves the right to temporarily delay withdrawal from the portfolio for up to 12 months in order to ensure that the securities liquidations will be carried out in an orderly manner. The Plan has no unfunded commitments and no contractual obligation to further invest in the portfolio.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used for valuing securities at December 31, 2024 or 2023.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - TAX STATUS**

The Plan has adopted the FMR LLC non-standardized pre-approved plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor Rules and Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are in shares of mutual funds, a money market fund, and a commingled pool managed by Fidelity or entities related to Fidelity. Fidelity is the Plan's trustee, as defined by the Plan. Therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
