Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Starwood Headquarters, LLC 401k Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 Financial Statements").

1. Description of Plan

The following description of the Starwood Headquarters, LLC 401k Profit Sharing Plan (the "Plan") provides only general information. The Plan allows for employer-specific provisions that each participating employer can select. Participants should refer to their respective plan agreements for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer defined contribution plan as defined under Section 413(c) of the Internal Revenue Code ("IRC"), administered by Starwood Headquarters, LLC (the "Company", or "Plan Sponsor"), covering eligible participants of the participating employers subscribing to the Plan, collectively (the "Employers"). The Plan was established effective January 1, 1995, and its Plan document was restated on January 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Upon reaching the age of 21 and completing 3 consecutive months of employment, employees are eligible to participate within the Plan. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees and Plan Administrator.

The Plan includes the following participating employers:

- Starwood Headquarters, LLC
- Starwood Capital Operations, LLC
- Starwood Asset Management, LLC
- Starwood Retail Partners, LLC
- Starwood Capital Group Global, LLC
- Rinaldi, Finkelstein and Franklin, LLC

Effective December 29, 2022, the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act of 2022 was signed into law. The Act is inclusive of approximately 90 provisions which offer many new benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distributions, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year. During 2024 and subsequently, the Plan adopted certain provisions of SECURE 2.0 and is in the process of formally amending the Plan document.

Contributions

Each year, upon meeting eligibility requirements, participants may contribute up to 100 percent of Plan compensation on a pre-tax or after-tax Roth basis, as defined in the Plan document, up to the maximum limits of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

Effective July 1, 2024, the Plan includes an automatic enrollment provision whereby all newly eligible employees (excluding employees of Rinaldi, Finkelstein, and Franklin LLC) are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Matching contributions, if any, are made at the discretion of the Employers. All participating employer contributions will occur on a quarterly entry date after an employee has completed one year of service with any of the Employers. Any employee who earned greater than \$250,000 in total compensation with the Employers in the prior year is excluded from participating in the matching contributions. For the Plan year ended December 31, 2024, 50% of each participant's deferral contributions were matched, up to 6% of the participant's eligible compensation, for a maximum match of 3% of compensation.

Discretionary non-elective contributions, if any, are made at the discretion of the Employers and are determined on an annual basis. To be eligible, participants must be employed on the last day of the Plan year and have attained one year of service. During the year ended December 2024, the Employers did not make any discretionary non-elective contributions.

The Plan also permits safe harbor non-elective contributions for non-highly compensated employees of participating employer Rinaldi, Finkelstein, and Franklin LLC. The safe harbor non-elective contributions are made at 3% of each eligible participant's compensation. During the year ended December 31, 2024, the safe harbor non-elective contributions totaled approximately \$8,500.

Participant Accounts

Each participant's account is credited with the participant's contributions, Rollovers, Employers' matching contributions, and other discretionary contributions (if applicable) and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, including Rollovers, safe harbor non-elective contributions and the actual earnings thereon. For participants terminated prior to January 1, 2020, their interest in the Employers' matching and discretionary non-elective contributions and earnings thereon vests at 20% after two years of service and 20% for each additional year until 100% vesting after six years of service. For participants who were employed on or after January 1, 2020, a participant is 33 percent vested after one year of credited service and continues to vest in increments of 33 percent until 100 percent vested after three years of credited service. Participants become 100% vested in the Employers' contributions and earnings thereon upon death, total and permanent disability, or attainment of early retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the second business day of the month the inception of the loan occurs, is set at the Prime rate plus 1%, as defined in the Plan document. Principal and interest are generally paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to retirement, death, disability, or other separation from service, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other

reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of rollover into an IRA. In addition, the Plan allows for hardship distributions if certain criteria are met. For the year ended December 31, 2024, there were no hardship distributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$71,608 and \$282,944, respectively. The Employers may use forfeitures to pay Plan expenses. In some cases, remaining forfeitures will be used to reduce Employers' contributions. During 2024, Plan administrative expenses and QNEC corrections (see Note 4) totaling \$315,093 were offset and utilized, respectively, from forfeited nonvested accounts, in accordance with Plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

5. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Newport Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. This information has not been audited by the Plan's independent auditors. Effective April 25, 2025, Newport Trust Company, LLC has assigned its rights and obligations to Ascensus Trust Company.

6. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Employers. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employers' contributions.

8. Tax Status

The Plan has adopted a pre-approved Plan document that has received an opinion letter from the IRS, dated June 30, 2020, stating that the pre-approved Plan document and trust, as then designed, were in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved Plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

10. Delinquent Participant Contributions

For the years ended December 31, 2024 and 2023, certain participating Employers did not remit certain participant contributions and loan repayments to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$2,830 in 2024 and were partially corrected in 2025. Untimely remittances of \$48,328 were identified in the 2023 Plan year and were partially corrected in October 2024. The participating Employers will be compensating participants for lost earnings and interest resulting from the delay in contributions for the remaining uncorrected amounts.
