INDEPENDENT AUDITOR'S REPORT

TO THE PARTICIPANTS AND PLAN ADMINISTRATOR OF BARCLAY DAMON LLP PROFIT SHARING AND 401(K) PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **BARCLAY DAMON LLP PROFIT SHARING AND 401(K) PLAN**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Barclay Damon LLP Profit Sharing and 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:



NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Barclay Damon LLP Profit Sharing and 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan commenced on January 1, 1997, and is a contributory defined contribution plan as defined under Section 401(k) of the Internal Revenue Code and has been established by Barclay Damon LLP (the “Sponsor”) for the benefit of its eligible employees in order to encourage their personal savings. The assets of the Plan are held, administered and managed in accordance with the terms and conditions of the Trust Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are immediately eligible to contribute to the Plan and receive Sponsor contributions. The minimum Sponsor contribution is calculated as 4% of a participant’s compensation earned during the plan year.

Participant Contributions

Participants in the 401(k) Plan may contribute no less than 1% and no more than 100% of their compensation, as defined by the Plan, up to the Internal Revenue Service (“IRS”) limitations. Participants over the age of 50 may contribute additional amounts as allowed by IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans. Participants may redirect their existing account balances and future contributions once during each business day.

Sponsor Contributions

Under the terms of the Plan, the Sponsor is required to make a minimum contribution of 4% of each participant’s compensation received during the Plan year. This non-elective contribution is intended to fulfill the requirements of the “safe harbor” regulations for qualified plans. Participants do not need to make contributions to the Plan to be eligible to receive the non-elective contribution. Additionally, the Sponsor may make discretionary profit sharing and matching contributions to the Plan. The Sponsor made total contributions of \$3,646,789 and \$3,180,523 for the years ended December 31, 2024 and 2023, respectively.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN – Continued

Allocation of Sponsor Contributions

Participants are allocated Sponsor contributions as of the last day of the Plan year. Participants who are terminated before the end of the Plan year due to retirement, disability or death also share in the Sponsor contributions.

Participant Accounts

Each participant's account is credited with the participant's and Sponsor's matching and profit-sharing contributions (if any) and an allocation of earnings.

Vesting

Employees are immediately vested in their voluntary contributions and Sponsor matching and profit-sharing contributions and earnings thereon upon entry into the Plan.

Payment of Benefits

Upon termination of service, a participant will receive the amount of his vested interest upon receipt of a distribution request from a participant entitled to a distribution. The amount which the participant or beneficiary is entitled to receive will be distributed in a single lump-sum distribution or installment payments, depending upon the participant's election.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes terms range from one to five years or up to 30 years for the purchase of a primary residence. The notes are collateralized by the balance in the participant's account and bear interest at rates of 4.25% - 9.5% (at December 31, 2024), which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

The accounting principles and practices which affect the more significant elements of the financial statements are:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for funds held in the common collective trust. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to the common collective trust because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for common collective trusts which are presented at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. The Plan presents in the statements of changes in net assets, the net appreciation or depreciation in the fair value of its investments which consists of the realized gains and losses and the unrealized appreciation and depreciation of those investments.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES – Continued

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The participants pay for certain custodial and administrative services of the Plan.

Risks and Uncertainties

The Plan provides for various investment options in any combination of a variety of mutual funds or a self-directed brokerage link investment option. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds and securities and the level of uncertainty related to changes in the value of mutual funds and securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Date of Management's Review

Plan management has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued. Plan management has determined that no such events have occurred.

NOTE 3 – OTHER INCOME

Other income consists of administrative revenue credits provided by T. Rowe Price with respect to Price Funds or Price Investments that exceed the established revenue threshold provided by the administrative contract. Other income was \$178,467 and \$160,635 for the years ended December 31, 2024 and 2023, respectively.

NOTE 4 – TAX STATUS

The Employer has adopted the T Rowe Price Retirement Plan Services Inc. Non-Standardized Pre-Approved Profit-Sharing Plan with CODA. The Plan obtained its latest determination letter on August 19, 2020, in which the IRS ruled that the plan is acceptable under Section 401(a) of the Internal Revenue Code (“IRC”) and, therefore, is not subject to federal income tax under present law. Although the plan has been amended and restated since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 5 – FAIR VALUE – Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Brokerage Link: Valued at quoted market prices in an active market on the last day of the Plan year.

Stable Value Common Collective Trust: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Common/Collective Trust Fund’s principal objective is to earn a current income stream that is relatively consistent over time, while preserving capital through a broadly diversified high-quality portfolio. The Common/Collective Trust Fund invests in a variety of investment contracts issued by insurance companies and other financial institutions and other investment products with similar characteristics. The fund strives to maintain a stable \$1 unit value. However, there is no guarantee that this objective can be achieved.

NOTE 7 – TERMINATION OF PLAN

Although it has not indicated any intention to do so, the Plan Sponsor may terminate the Plan at its own discretion upon notification to the trustee. The Plan may also terminate if the Plan Sponsor becomes judicially bankrupt, insolvent, upon dissolution, or if the entity merges, consolidates, reorganizes or sells its assets without the successor company electing to continue the Plan. In the event of Plan termination, participants will become 100% vested in their employer contributions. None of the participant's benefits will be forfeited upon termination.

NOTE 8 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

T. Rowe Price Trust Company and Fiducient Advisors are the considered parties in interest as defined by the Plan and, therefore fees paid to these organizations for Plan administration and investment advisory services qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan and Plan participants were approximately \$58,000 and \$50,000 for the years ended December 31, 2024 and 2023, respectively.
