Note 1. Description of Plan

The following description of The Cato Corporation (the “Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a stock bonus plan covering eligible employees of the Company who have completed one year of service, provided the employee has worked at least 1,000 hours and is age 21 or older. The Compensation Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Participants are permitted to diversify portions of their stock accounts subject to specific provisions of the Plan. Pass-through voting of employer securities is permitted under the Plan.

Contributions

For each plan year, the Company may contribute amounts determined by the Company’s Board of Directors at its discretion. Participants are eligible to receive the annual Company contribution if they have worked at least 1,000 hours during the plan year and are employed on the last day of the Plan year, except for cases of death, disability or retirement. The Company’s contributions may be paid to the Plan in cash or in shares of Company common stock, as determined by the Company’s Board of Directors. The Plan does not permit employee contributions.

Participant Accounts

Each participant’s account is credited with the allocations of the Company’s contribution, if applicable, plan earnings, and forfeitures of terminated participants’ non-vested accounts, and charged with allocations of plan losses. Allocations are based on participants’ eligible compensation, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

The vested portion of a participant’s account is a percentage of the total amount credited to the participant’s account determined on the basis of the participant’s number of years of credited service. A participant is 100% vested after five years of service.

Payment of Benefits

On termination of service, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions are made in cash or, if a participant elects, in the form of shares of Company common stock plus cash for any fractional shares.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Ascensus, LLC (the “Trustee”), prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of the Plan participants and beneficiaries.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,656 and \$48,353 respectively. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. During 2024, no forfeitures were allocated to administrative expenses.

Note 2. Summary Of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is accrued on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employees receive compensation from the Plan.

Subsequent Events

The Plan has evaluated the effect subsequent events would have on the financial statements through September 30, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Common Stock

Common stock in the Plan is publicly traded investments and is valued daily at the closing price reported on the active market on which the individual securities are traded.

Interest-Bearing Cash

Interest bearing cash in the Plan is valued at fair value based on quoted market prices.

Note 5. Exempt Party-in-Interest Transactions

Plan investments are shares of the Company's class A common stock and the Ascensus Insured Deposit Program, and therefore these transactions qualify as exempt party-in-interest transactions.

The Company provides certain accounting, administrative and investment management services to the Plan, for which no fees are charged. The Company also pays certain operating expenses of the Plan.

Note 6. Tax Status

The Internal Revenue Service (the "IRS") has determined and informed the Company by letter dated January 27, 2015, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8. Risk and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.



