## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Coda Project 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained certifications from a qualified institution as of December 31, 2024 (in liquidation) and 2023 (ongoing), and for the year ended December 31, 2024 (in liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Coda Project 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of Coda Project, Inc., the sponsor of Coda Project 401(k) Plan, approved a plan of liquidation on December 15, 2024, and management determined liquidation of Coda Project 401(k) Plan is imminent. As a result, the plan has changed its basis of accounting from the ongoing basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Coda Project 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing audits in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Coda Project 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules of delinquent participant contributions for the year ended December 31, 2024, and of assets (held at end of year) as of December 31, 2024 (In Liquidation), (collectively, "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF THE PLAN

The following description of the Coda Project 401(k) Plan, (the "Plan") provides only general information. Therefore, participants should refer to the plan documents and related adoption agreement for a more comprehensive description of the Plan's provisions.

General

The Plan was a defined contribution plan sponsored by Coda Project, Inc. (the "Company", "Plan Sponsor" or "Employer") established effective January 1, 2015, and was most recently restated on March 24, 2022. The Plan was designed to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("IRC"). The Plan was adopted to enable eligible employees to defer their compensation to save and invest those funds for retirement.

Plan termination and liquidation

On December 15, 2024, the governing body of the Company adopted a resolution to terminate the Plan effective January 9, 2025, and initiated a standard termination in accordance with ERISA. As a result of the termination, the Plan is in the process of liquidating its assets and distributing benefits to participants and beneficiaries. Plan assets will be allocated and distributed to participants and beneficiaries in accordance with ERISA, applicable regulations, and the plan documents. As the Plan is in liquidation, the financial statements have been prepared on the liquidation basis of accounting. Under this basis, assets are stated at their net realizable values and liabilities are stated at their estimated settlement amounts. The outcome of the liquidation process is not expected to result in any adjustments to participant benefits, as assets are sufficient to satisfy all Plan liabilities and obligations.

Plan administration

The Company was the administrator of the Plan and, as such, carried out the duties imposed by ERISA. The Company delegated certain responsibilities for the operation and administration of the Plan. Custodial services were provided by Matrix Trust Company (the "Trustee"), while recordkeeping services were performed by Human Interest (the "Recordkeeper"). The Trustee managed the Plan's investments and made investment transactions while the Recordkeeper managed participant accounts and participant related transactions.

Eligibility

Before the Plan's termination, all employees, except for union employees, leased employees, non-resident aliens, and interns, of the Company who have attained age 18 were immediately eligible to participate in the Plan upon hire.

Contributions

Before the Plan termination, participants were allowed to contribute through payroll deductions amounts up to 90% of their annual compensation on a pre-tax basis and amounts up to 50% of their annual compensation on an after-tax basis (as Roth contributions), as defined by the Plan, subject to annual dollar limits established by the IRC. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions up to the IRC limit. Participants were also allowed to make rollover contributions to the Plan from other qualified retirement plans, or certain individual retirement accounts.

Before the Plan termination, the Company made discretionary non-elective Employer contributions to the Plan. Participants were required to be employed by the Company on the last day of the Plan year in order to share in the allocation of non-elective contributions. No discretionary non-elective Employer contributions were made to the Plan for the year ended December 31, 2024.

Participant accounts

Each participant's account was credited with the participant's contributions, rollovers, and allocations of Employer non-elective contributions, if any, and allocation of Plan earnings, and charged with an allocation of investment losses and administrative expenses not paid directly by the Company. Participants could direct their account balances into any of the investment options offered by the Plan. Allocations were based on participant earnings or account balances, as defined in the plan documents. Other allocations were based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that could be provided from the participant's vested account balance.

Vesting

Participants are immediately 100% vested in their contributions and the Company's discretionary non-elective Employer contributions, plus actual earnings thereon.

Notes receivable from participants

Before the Plan termination, participants could borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable were secured by the balance in the participants' accounts and interest was charged at a rate to be fixed by the Plan administrator based on interest rates currently being charged on similar commercial loans by persons in the business of lending money. As of December 31, 2024 and 2023, there were no outstanding notes receivable from participants.

Payment of benefits

Distributions and withdrawals were payable upon retirement, termination, disability, death, upon attaining the age of 59½, or financial hardship, as defined by the Plan. Under certain circumstances of financial hardship, the participant was allowed to withdraw funds from the Plan. Balances less than or equal to \$5,000 upon termination were distributed in a lump-sum payment directly to the participant. If the account balance is over \$5,000 upon termination, the participant could elect payment in a lump sum payment or a direct rollover into another qualified benefit plan or individual retirement account, or postpone payment to a later date and remain in the Plan as described in the Plan document. Participants, while still employed by the Company, could request in-service distributions from their vested Plan accounts at any time after having attained age 59 1/2.

Administrative expenses

Administrative expenses covered routine expenses for services provided by accountants, third party administrators, and other advisors. Transaction fees for certain participant-initiated activity were charged to the specific account of the participant initiating any such transaction. Such expenses included but were not limited to costs to process distributions and loans. The Plan required that certain expenses related to the Plan be paid directly or reimbursed by the Company, but permitted certain expenses incurred to administer the Plan to be paid from Plan assets. The Plan was not required to repay expenses paid by the Company on behalf of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP"). As a result of the Plan termination disclosed in Note 1, the Plan has changed its basis of accounting from the ongoing basis used in presenting the financial statements as of December 31, 2023, to the liquidation basis used in presenting the financial statements as of and for the year ended December 31, 2024.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent liabilities. Actual results could differ from these estimates.

Risks and uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the value of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefit and changes therein.

Investment valuation and income recognition

The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on the sale of investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants were recorded based on the date the contributions were separated from a participant's pay by the Company, which is the pay date. Employer contributions, if any, were recorded in the year earned to coincide with the year in which the Company recorded the contributions in its general ledger. The Plan recorded receivables for contributions based upon contributions recognized in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants were recorded based on the date the contributions were received by the Trustee.

Payment of benefits

Benefit payments were recorded when paid.

Administrative expenses

Administrative expenses were recorded when incurred.

Subsequent events

Management of the Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available for issuance. The Plan was terminated effective January 9, 2025 (Note 1). There were no other subsequent events that occurred as of the date the financial statements were available for issuance.

3. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The plan administrator, having determined it was permissible in the circumstances, elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Trustee (Note 1), determined to be a qualified institution by the Plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and schedule of assets (held at end of year) ("supplemental schedule"). The Trustee certified that the following data included in the accompanying financial statements and supplemental schedule was complete and accurate:

- Non-interest bearing cash, and investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 (In Liquidation) and 2023 (Ongoing);
- Net appreciation in fair value of investments and dividend and interest income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 (In Liquidation) ("supplemental schedule"), and,
- Investments reflected on the supplemental schedule as of December 31, 2024 (In Liquidation).

Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards require that fair value be determined based on the price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market, in an orderly transaction between market participants. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- *Level 1* - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

- *Level 2* - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value on a recurring basis. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Mutual and money market funds - Valued at the daily closing price as reported on the open market. The Plan's investments in mutual and money market funds consisted of investments principally in funds containing equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Investments were valued using market quotations or prices obtained from independent pricing services. The mutual and money market funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan has adopted and operates under a non-standardized pre-approved profit sharing plan document sponsored by CCH Incorporated. The Internal Revenue Service issued an opinion letter dated June 30, 2020, stating that the form of the non-standardized pre-approved profit sharing plan document was designed in accordance with the applicable sections of the IRC and was appropriate for use by employers for the benefit of their employees. The plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan was qualified and tax-exempt. Therefore, no provision for income taxes were included in the Plan's financial statements.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similarly to the definition of a related party under financial accounting standards, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, and an employee organization whose members were covered by the Plan, a person who owned 50% or more of such an employer or employee association or relatives of such persons.

The Company pays certain fees and expenses on behalf of the Plan. These transactions qualify as party-in-interest transactions. The Plan is not required to repay expenses paid by the Company on its behalf. The Plan has included in its investment fund options certain funds managed by the Trustee or one of its affiliates. Transactions in these funds are considered party-in-interest transactions under ERISA. Such transactions are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.
