We have performed an audit of the accompanying financial statements of Shellback Holdings, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Shellback Holdings, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Shellback Holdings, Inc. and its affiliated entities, Shellback Semiconductor Technology, LLC and Rite Track Equipment Services, LLC (the “Company”), with the exception of excluded employees, including union employees, certain nonresident aliens, leased employees, and Co-op employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Eligibility

Employees, other than excluded employees, who have attained 18 years of age and completed three months of service are eligible to participate. Plan entry date is the first day of the month following eligibility (“anniversary date”).

Contributions

Participants may contribute a portion of compensation up to limits defined by the Internal Revenue Code (“IRC”). Each year, participants may contribute a portion of their compensation, as defined in the Plan, into pre-tax or after-tax Roth accounts. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan contains an automatic salary deferral feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants defer at a rate of 5% of compensation, with contributions invested in a designated fund, until modified by the participant.

The Company may make both safe harbor matching contributions and rigid discretionary matching contributions. The Company safe harbor matching contribution is equal to the sum of 100% of the amount of the participant’s elective deferrals that do not exceed 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals that exceed 3% of the participant’s compensation but do not exceed 5% of the participant’s compensation, for a maximum safe harbor matching contribution of 4%. Additional employer rigid discretionary matching contributions may be contributed as directed by management to participants who have attained age 18 and completed three months of service. The Company did not make any rigid discretionary matching contributions to the Plan during 2024.

Participants may change their investment election and deferral election at times throughout the year as defined in the plan document.

1. Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, any rollover contributions, and allocations of (a) the Company's contributions, (b) the Plan earnings (losses), and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and safe-harbor matching contributions plus actual earnings thereon.

Employees are credited with a year of service for each year (anniversary date) during which they have at least 1,000 hours of service. The vested interest in participant accounts upon termination from employment, other than by retirement, disability, or death, vest as discussed below.

Vesting in the Company's rigid discretionary matching contributions, plus actual earnings thereon, is as follows:

Notes Receivable from Participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of Prime + 1%, based on date of loan. Principal and interest is paid ratably through payroll deductions over a period of up to five years. The home loan term is ten years. A participant may have five loans outstanding at any time.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account or elect to receive partial withdrawals or installments if subject to minimum distribution requirements. Participants' nonforfeitable account balances less than \$5,000 should be distributed as soon as administratively feasible following severance of employment.

Payment of Benefits (Continued)

The Plan allows participants to make in-service withdrawals at age 59½ from accounts in which the participant is fully vested.

The Plan allows participants to make hardship distributions from pre-tax and Roth elective deferral accounts. The minimum amount of the hardship distribution is \$500, and the participant is required to be employed by the Company at the time of the distribution.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the years.

Benefit Payments

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

2. Summary of Accounting Policies (Continued)

Investment Fees

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of distributions and participant accounts are charged directly to the participant's account and are included in administrative fees. Certain investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 and/or Level 2 inputs as components of the overall fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investment Certification (Continued)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental Schedule of Assets (Held at End of Year).

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in any employer contributions.

6. Tax Status

The Company adopted a prototype non-standardized defined contribution plan which received a favorable determination letter from the Internal Revenue Service on June 30, 2020, which stated that the form of the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the letter. However, the Company believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and that the related trust continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there were no positions taken or expected to be taken or accrued interest or penalties that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transactions with Parties in Interest

Certain routine plan administrative expenses are incurred and/or paid by the plan sponsor. Notes receivable from participants qualify as exempt transactions with parties-in-interest. Certain plan investments are shares of mutual funds managed by John Hancock. John Hancock Life Insurance Company is the trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Other than the aforementioned, the Plan has no agreements or transactions with parties in interest.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued, and has determined that no material subsequent events exist that require recognition or disclosure.
