### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CNBSTL and UBU 401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

### ***General***

The following description of the CNBSTL and UBU 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by CNB St. Louis Bank (formerly Citizens National Bank of Greater St. Louis) (the "Sponsor") for the benefit of its employees (including part-time employees) who are age 21 or older. The United Bank of Union, an employer with common ownership, also participates in the Plan. Effective January 1, 2024, the Plan was amended and restated to operate as a multiple employer plan. Additionally, the service requirement for eligible employees to receive employer matching contributions was changed from no minimum service requirement to one year of service. The minimum age requirement changed from 21 years of age to 18 years of age. The participation entry dates changed from quarterly to monthly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Charles Schwab Trust Bank serves as Plan custodian (the "Custodian").

CNB St. Louis Bank and The United Bank of Union are collectively referred to as "the Employers" within the notes to the financial statements.

### ***Contributions***

In 2023, the Plan permit eligible employees through a salary deferral election to have the Employers make annual contributions of up to 75% of eligible compensation. Employee rollover and Roth contributions were also permitted. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Employers provided a 9% match for any participant deferring 3% or more who had at least one year of service.

Effective January 1, 2024, the Plan was amended to permit eligible employees through a salary deferral election to make annual contributions from 5% to 80% of eligible compensation. Employee rollover and Roth contributions are also permitted. Matching contributions and employer profit-sharing contributions are discretionary as determined by the Sponsor's Board of Directors. The Employers' made employer matching contributions to the Plan at an amount equal to 300% of eligible participants' contributions up to 5% for the year ended December 31, 2024, for a total of 15%.

There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Employers' contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Employers' contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The non-vested balance is forfeited upon termination of service. Forfeitures are used to reduce administrative expenses and Employers' contributions.

### ***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loan is based on local prevailing rates at loan inception as determined by the Plan Administrator.

### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to maintain their funds with the Plan if they are above the federally-stated distribution limit, to receive a lump-sum amount equal to the value of the vested interest in their account or to receive a direct rollover to a specified account. Upon termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

An in-service distribution may be made to a participant who has not separated from service and attained the age of 65, if their account is fully vested.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$37,540 and \$36,678, respectively. These accounts will be used to reduce future Employers' contributions and pay administrative expenses. Also, in 2024, Employers' contributions were reduced by \$0 from forfeited nonvested accounts.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Investments in mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan holds interests in common collective trust funds, which invest in investments that pursue multiple strategies to exceed the performance of certain industrial averages. The funds may invest in securities or a combination of other collective funds. The net values of the funds are determined daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as declared by each fund. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted market prices of investments with similar characteristics or independent pricing services and pricing models, the inputs of which are market-based or independently sourced marketed parameters, including but not limited to yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 3 investments held by the Plan.

**Note 4. Certification of Plan Custodian**

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 5. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

The Plan incurs expenses related to general administration and record keeping. The Plan paid \$74,791 and \$68,207 of record keeping and advisory fees during 2024 and 2023, respectively. Certain accounting and auditing fees relating to the Plan are paid by the Sponsor. Additionally, the Sponsor provides certain administrative services at no cost to the Plan.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust/custodial document sponsored by Retirement Plan Services, L.L.C. This prototype Plan Document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service on March 31, 2008, stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has been amended since the prototype received the determination letter. However, the Plan Administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
