Independent Auditors' Report

To the Participants and the Komatsu Pension and Investment Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Komatsu America Corp. Target Benefit/Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of the Plan

The following description of the Komatsu America Corp. Target Benefit/Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a target benefit defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective April 1, 2019, the Plan was closed to new hires. Prior to the eligibility freeze, all nonunion employees of Komatsu America Corp. (the Company) and certain of its affiliates who completed one year of service were eligible to participate in the Plan. In addition, under terms as outlined in the Plan document, individuals who were participants in the Plan as of April 1, 2019 became either grandfathered participants or nongrandfathered participants based on their age as of April 1, 2019, and years of benefit service as of March 31, 2019. Benefit accruals for the nongrandfathered participants were frozen effective March 31, 2019.

Administration

The Company, along with its subsidiary, Komatsu Mining Corp. (collectively, the Companies), established the Komatsu Plan Sponsor Committee to act on behalf of the Companies as plan sponsor to the employee benefit plans maintained by the Companies, including the Plan. In addition, the Companies established the Komatsu Pension and Investment Committee (the Committee) to serve as the plan administrator for their employee benefit plans. Fidelity Management Trust Company (the Trustee) is the trustee and Fidelity Investments, an affiliate of the Trustee, is the recordkeeper for the Plan.

Contributions

The Plan is noncontributory for participants. The Company makes an annual contribution for each grandfathered participant. The contribution amounts are calculated as the excess of a participant's projected retirement benefit over the preceding years projected retirement benefit times a contribution factor based on the participant's age, the result of which is added to the contribution calculated for the preceding year. Nongrandfathered participants are ineligible to receive a contribution.

Participants direct the investment of their Company contributions into various investment options offered by the Plan.

Participant Accounts

Separate benefit accounts are maintained for each participant. Each participant's account is credited with an allocation of the Company contributions and plan earnings or losses based on the investment funds selected and charged with an allocation of administrative expenses. Income is allocated to participants' accounts based on the participant's account balance, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants in the Plan are fully vested after three years of service, or upon becoming disabled, attaining normal retirement age, or terminating employment by reason of death.

Forfeitures

Forfeitures of participants' nonvested account balances are used to reduce Company contributions to the Plan or to pay plan expenses. Forfeitures totaling \$106,042 were used to reduce Company contributions and no forfeitures were used to pay plan expenses in 2024. There were approximately \$559 and \$34,405 of available forfeitures for future use at December 31, 2024 and 2023, respectively.

Payment of Benefits

A participant's projected retirement benefit is composed of two parts: past service benefit and future service benefit. The past service is equal to years of benefit service before December 1, 1991 (up to a maximum of 35 years), multiplied by the accrual rate less any amounts payable that will be received from the Plan or other plans as specified in the plan document. The future service benefit is the number of years a participant would earn if he or she remained with the Company from December 1, 1991 until age 65 (up to 35 years maximum) times the accrual rate. The accrual rate is equal to the sum of 0.75% of final average compensation, as defined, plus a percentage of between 0.65% and 0.75% of final average compensation. Final average compensation is the average compensation earned by a participant during the five consecutive years within the last ten completed years of service in which such average compensation was highest.

All participants in the Plan are entitled to receive their vested benefits under the Plan upon retirement, death, or termination of service. Payment of benefits is either in one lump sum or through the purchase of a nontransferable fixed or variable annuity contract, providing monthly payments throughout the life of the employee. Automatic distribution commences when the participant turns age 73 or when the participant terminates employment.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will immediately become fully vested in their account balances.

Recent Regulatory Pronouncements

The SECURE 2.0 Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management is evaluating the optional SECURE 2.0 provisions. The application of SECURE 2.0 did not have a material effect on the Plan's financial statements. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company pays substantially all administrative fees associated with the Plan. Certain participant transaction charges are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Payment of Benefits

Benefits are recorded when paid.

3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental schedule Form 5500, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from the information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund - Valued at the published market price, which is a constant net asset value (NAV) of \$1 per unit.

Registered investment companies - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from that trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts - Include common stock, certificate of deposits, and mutual funds and are valued at the quoted market price of the respective security held within the accounts. All securities within the accounts are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 26, 2014, stating that the Plan was designed in accordance with applicable Internal Revenue Code (IRC) requirements as of that date. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement dates.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides various investment securities that, in general, are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan held three and two investments, respectively, with significant concentration as a percentage of net assets available for benefits totaling \$36,019,740 and \$26,057,586, respectively.

8. Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.
