We have performed audits of the financial statements of Unit Corporation Employees' Thrift Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the Unit Corporation Employees' Thrift Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Unit Corporation and its subsidiaries (collectively, the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by the Company, whereby certain employees of the Company serve as the Benefits Committee. The Plan also utilizes Fidelity Management Trust Company (the "Trustee") as the trustee of the Plan and holds the Plan assets. Fidelity Workplace Services LLC processes and maintains the records of the participant data.

In connection with the Chapter 11 bankruptcy reorganization of Unit Corporation in 2020, each holder of Unit common stock outstanding ("Old Common Stock") before the Emergence Date that did not opt out of the release under the Plan is entitled to receive 0.03460447 warrants for every share of Old Common Stock owned. Each warrant is exercisable for one share of common stock, subject to adjustment as provided in the Warrant Agreement. Pursuant to the terms of the Warrant Agreement, the Company determined the initial exercise price of the warrants to be \$63.74. Subsequent to the Company's emergence from bankruptcy, the Plan did not permit new investments in Company common stock. As of December 31, 2024, no warrants have been exercised.

Contributions

Employees who have reached 18 years of age and have completed three months of service are eligible to participate in the Plan, as defined by the Plan agreement. Participants can be enrolled in the Plan on the first day of the month after satisfying eligibility requirements. All employee contributions are accumulated in the individual participant's accounts and contributions are subject to certain limitations.

Participants are allowed to contribute from 1% to 99% of their eligible compensation, as defined in the Plan agreement, not to exceed Internal Revenue Service ("IRS") limitations for contribution limits. Participants may also elect to make Roth 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company provides safe-harbor matching contributions equal to 100% of deferrals up to 4% of a participant's eligible compensation.

Participants may direct the allocation of their contributions and employer safe-harbor matching contributions to any of the Plan's investment funds.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's safe-harbor contribution and (b) Plan earnings or losses. Allocations are based on participant earnings (losses) or account balances, as defined in the Plan agreement.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe-harbor matching contribution plus actual earnings (losses) thereon.

Payment of Benefits

Distribution of a participant's vested account is available upon the participant's retirement, death, disability, termination of employment or attainment of age 59½. Distributions are available to satisfy a financial hardship meeting the requirements of the IRS regulations. Other in-service withdrawals are also available to participants subject to certain limitations as defined in the Plan agreement.

Forfeitures

While Plan participants are fully vested in their contributions, there are forfeitures related to prior years' QNEC contributions and uncashed checks written to participants.

Forfeitures are first used to pay Plan administrative expenses and then used to reduce employer contributions. As of December 31, 2024 and 2023, there were approximately \$3,600 and \$1,100 forfeitures included in the Plan assets, respectively. For the year ended December 31, 2024, there were \$33,223 of forfeitures utilized to pay Plan administrative expenses or reduce employer contributions.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's Benefits Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments and are deducted directly from the participant's investment returns. The Plan has a revenue-sharing agreement whereby certain investment managers return a portion of the investment fees to the recordkeeper to offset the Plan's administrative expenses as permitted per the Plan agreement. There were approximately \$18,000 and \$8,200 of unallocated funds in the revenue credit account as of December 31, 2024 and 2023, respectively.

NOTE 3 - TAX STATUS

The Plan utilizes a pre-approved defined contribution plan sponsored by Fidelity Management and Research Company ("Fidelity"). The Plan obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the document, as then designed, followed the applicable requirements of the Internal Revenue Code of 1986, as amended (the "Code"). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the framework are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at fair value based on published market prices as of the close of business on the last business day of the Plan year, which represents the net asset value ("NAV") of shares held by the Plan.

Warrants: Valued at fair value based on the over-the-counter closing price on the last business day of the Plan year.

Collective trust funds: Stated at fair value as determined by the issuer of the collective investment trusts based on the fair market value of the underlying investments, which is valued at the NAV of units of the collective investment trusts. The NAV is used as a practical expedient to estimate the fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan's assets include a fully benefit-responsive Guaranteed Interest Balance Contract with Principal Life Insurance Company ("Principal") and a fully benefit-responsive Guaranteed Insurance Contract with New York Life Insurance Company. The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include but are not limited to the Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under

Section 501(a) of the IRC; premature termination of the contract; Plan termination or merger; changes to the Plan's prohibition or competing investment options; and bankruptcy of the Plan Sponsor.

Contract value represents contributions made under the respective contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The contracts shall terminate upon the contract values being transferred to other plan investments or upon liquidation. There are no events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, assets of the Plan will be distributed to the participants.

NOTE 8 - RELATED PARTIES AND PARTIES-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain administrative fees related to the administration of the Plan are paid by the Plan. Certain fees incurred by the Plan are included in net appreciation in fair value of investments on the statement of changes in net assets as they are paid through revenue sharing, rather than a direct payment. The Plan also makes direct payments to service providers which are not covered by revenue sharing. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibited transactions rules under ERISA.

In 2023, the Department of Labor approved an exemption permitting Plan participants to acquire warrants issued by the Company in connection with its bankruptcy filing without violating any prohibited transaction rules.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
