We have performed audits of the financial statements of Cozen O'Connor Profit Sharing Plan B (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - PLAN DESCRIPTION

The following brief description of the Cozen O'Connor Profit Sharing Plan B (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, which was formed effective January 1, 2021, is a defined contribution profit sharing plan. All non-union domestic employees of Cozen O'Connor (the "Company" or "Employer") who have completed thirty (30) days of service and have a social security number ending in an odd digit are eligible to participate in the Plan except for employees who are classified as Associate Attorneys or Staff Attorneys of the Employer. Any Participant who is classified as a Shareholder, Senior Counsel, Managing Director, Chief Operating Officer, Chief Marketing Officer or Chief Operating Officer Ancillary Business Units/Chief Innovation Officer shall be eligible to participate in the non-elective contribution component of the Plan even if their social security number ends in an even number. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Employer Contributions

Participants who have completed one year of service (worked 1,000 hours) and are employed on the last day of the Plan year are eligible for non-elective Employer contributions. Employer contributions to the Plan are determined annually as follows:

Profit Sharing Contributions

The Employer may make a discretionary contribution to the Plan as determined by the Employer. Discretionary Employer profit sharing contributions are allocated to participants according to employee group classification as established by the Employer and set forth in the Plan document. Amounts contributed to each group are allocated to each group participant proportionately based upon compensation subject to annual compensation limitations (\$23,000 for 2024) under the Internal Revenue Code (the "Code"). The Employer profit sharing contribution was \$10,980,955 for the year ended December 31, 2024.

Investment Options

Participants may choose to invest their account balances among any of the Plan's investment options or through a self-directed brokerage account offered by the Plan. Investments in the self-directed brokerage account will be limited to marketable securities traded on active securities exchanges. Participants may redirect their future employer contributions or transfer their existing account balances among the investment options on a daily basis.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with allocations of the Employer's annual contributions and investment earnings, and is charged with withdrawals, administrative expenses and an allocation of investment losses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Employer profit sharing contribution portion of their accounts is based on years of continuous service. Participants vest 20% after two years of service and an additional 20% per year thereafter. Participants are 100% vested after six years of service. Additionally, participants are credited with specific service at previous law firms that precedes employment with the Employer.

Benefit Payments

Upon termination of service, death, disability, retirement or separation, participants or their beneficiaries may elect to receive, a lump sum or if certain criteria are met, annuity payments, an amount equal to the value of the participant's vested interest in his or her account. If a participant's account balance is less than \$5,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into an individual retirement account. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account will be made automatically in a single lump-sum cash distribution.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Participants are also permitted to make hardship withdrawals from their deferral contribution in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be taken at any time.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures may be made available to reinstate previously forfeited account balances of former participants renewing employment with the Company, subject to certain conditions, or may be used to pay any administrative expenses of the Plan. The remaining forfeitures, if any, shall be used to reduce Employer contributions or for allocation to certain eligible participants. There were \$121,189 and \$53,209 of forfeited non-vested accounts as of December 31, 2024 and 2023, respectively. For the plan year ended December 31, 2024, \$121,189 of forfeitures were used to reduce employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). Plan management determines the Plan's valuation policies utilizing information provided by the trustee.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation or depreciation includes the gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses, such as audit, investment advisory and consulting fees, may be paid by the Plan or the Employer. The Plan incurred administrative expenses of \$3,408 for the year ended December 31, 2024.

ERISA Account

The Plan has an ERISA account that captures excess income and fee credits collected by the trustee. The funds held in the account may be used to pay administrative expenses of the Plan or allocated to participants. The ERISA account balance was \$12 at December 31, 2024 and \$9 at December 31, 2023, respectively, and is included as assets of the Plan. During the year ended December 31, 2024, amounts totaling \$27,355 were earned and allocated to eligible participants.

NOTE C - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable pricing inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies and Self-Directed Brokerage Accounts: Valued at net asset value ("NAV") of shares held by the Plan at year end based upon quoted market prices on nationally recognized exchanges (Level 1). Self-directed brokerage accounts hold investments in common and preferred stock, as well as mutual funds.

Collective Trust: Valued using the NAV as a practical expedient to fair value, provided by the administrator of the fund. The NAV is based on the value of the assets owned by the fund, less the liabilities at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Plan has applied for a determination letter from the Internal Revenue Service ("IRS") but has not yet received a letter. The Plan administrator believes that the Plan, in form and operations, complies with the requirements of the Code, as currently in effect.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

The Plan includes investments in registered investment company funds and a collective trust fund managed by an affiliate of T. Rowe Price Trust Company, the trustee of the Plan. The Plan also allows notes receivable from participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.
