#### **Note 1 – Plan Description**

The following description of the Unmanned Systems Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Unmanned Systems, Inc. dba Albers Aerospace and the following participating employers: Garrett Container Systems, Inc. and Heritage Aviation Ltd. (collectively, the “Company” or “Employer”). The Plan commenced effective January 1, 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

#### ***Plan Custodian and Trustees***

Matrix Trust Company (“Matrix” or the “Custodian”) and Ameritas Life Insurance Corp. formally dba as BlueStar Retirement Services Inc. (“BlueStar” or the “Recordkeeper”) serve as the Custodian and Recordkeeper of the Plan. The Custodian maintains custody of all investments held by the Plan. Among other duties, the Custodian receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. BlueStar maintains the Plan’s participant account balances and provides recordkeeping services to the Plan. Two officers of the Company serve as Trustees of the Plan.

#### ***Eligibility and Plan Entrance Date***

Prior to March 15, 2023, except for leased employees, union employees covered by a collective bargaining agreement, and nonresident aliens who receive no United States source income, all employees become eligible to participate in the Plan upon reaching the age of 21.

Effective March 15, 2023, union employees are permitted to participate in the Plan, and the age requirement was changed to 18 years of age. Eligible employees are permitted to enter the Plan on the first day of each month after satisfying the eligibility requirements.

#### ***Contributions***

Participants may elect to contribute, on a before-tax and Roth basis, up to 100% of their eligible compensation up to the maximum amount allowed for deferral annually by the IRC, which was \$23,000 for 2024. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions of up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Plan provides for Safe Harbor Employer matching contributions. During 2024, the Company made Safe Harbor Employer matching contributions to participants in an amount equal to 100% of the first 4% of the participant's eligible compensation contributed to the Plan. Contributions are subject to certain statutory limitations.

#### Note 1 – Plan Description (continued)

##### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Safe Harbor Employer matching contributions, allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Participant-Directed Investments*

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, and participants may direct the allocation of their account balances to one or more of these investment options. The options vary in types of investments, rates of return, and investment risk.

##### *Vesting*

Participants are vested immediately in their contributions and Safe Harbor Employer matching contributions plus actual earnings thereon.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are secured by the balance in the participant's account, and the loan's interest rate is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

##### *Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the vested interest in their account. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If a participant makes no election, the amount is automatically distributed in cash. If the participant's vested account balance is equal to or less than \$5,000, the Plan permits involuntary lump sum cash distributions, which are made as soon as administratively possible following termination.

A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age of 59½.

#### Note 2 – Summary of Significant Accounting Policies

##### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

##### *Use of Estimates*

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Note 2 – Summary of Significant Accounting Policies (continued)**

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased, sold, and held during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Certain expenses incurred by or attributable to a specific participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

#### **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 3 – Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Common Collective Trusts** – Valued using the NAV of units held by the Plan at year-end as provided by the fund administrator. Units of each fund are valued each day on which the New York Stock Exchange (“NYSE”) is open for trading in accordance with the valuation procedures established by fund administrators. The NAV per unit is calculated as of the close of trading on the NYSE and computed by dividing the total fair value of the assets of a fund, less its liabilities, by the total number of units outstanding at the time of such computation. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

#### Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. All investment fund earnings or losses posted to each participant’s account are net of investment management fees charged by each investment fund under the Plan.

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

#### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### Note 7 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by BlueStar. The Internal Revenue Service (“IRS”) has determined and informed BlueStar by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt and no provision for income taxes has been included in the Plan’s financial statements.

#### Note 7 – Tax Status (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

#### Note 9 – Prohibited Transactions

During 2024 and 2023, the Company failed to remit to the Plan's Custodian certain participant contributions and loan repayments totaling \$8,355 within the period prescribed by the DOL's Rules and Regulations. Delays in remitting contributions to the Custodian were due to unintentional administrative errors. The Company is in the process of correcting the remaining contributions to the affected participants' accounts to compensate those participants for potential lost earnings due to the delays.
