### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

**Note 1 – Description of the Plan**

Nexsentio Inc 401(k) Profit Sharing Plan & Trust (the “Plan”) is a defined contribution plan covering substantially all eligible employees of Nexsentio, Inc., (the “Plan Sponsor”). The Plan became effective January 1, 2020, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All Plan assets are held by Mid Atlantic Trust Company (“MATC”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Administration - The Plan Sponsor has contracted with MATC to act as the trustee to the Plan, and with Paychex to process and maintain the records of participant data.

Eligibility - Employees of the Plan Sponsor who have reached age 21 and are not members of a collective bargaining unit, leased employees, or non-resident aliens, are eligible to participate in the Plan upon the completion of one year of service, defined by the plan document as 1,000 hours of service. Employees are eligible to enter the Plan immediately following their satisfaction of the eligibility requirements. Participants must complete a minimum of 500 hours of service, as defined by the plan document, during a plan year and remain employed by the Plan Sponsor on the last day of the plan year, to be eligible for employer discretionary profit-sharing contributions.

Contributions - Participants are allowed to make elective pre-tax or after-tax Roth contributions to the plan of up to 100% of their annual eligible Plan compensation, as defined by the plan document, subject to limitation under the Internal Revenue Code (IRC). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

The Plan Sponsor may elect to allocate an employer discretionary profit-sharing contribution to the Plan based on annual profits determined and authorized by the Plan and the Plan Sponsor up to the maximum amounts permitted by the IRC. Allocation of the profit-sharing contributions will be based on total salary. No employer discretionary profit-sharing contributions were approved or made through December 31, 2024.

Participant accounts - Participants direct the investment of their accounts among various investment options offered by the plan. Participants may change their investment options daily.

Each participant account is credited with (a) the participant’s contributions, (b) an allocation of employer contributions, and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Vesting in the Plan Sponsor’s discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of credited service, as defined in the plan document. The vesting schedule for the profit-sharing contributions includes a 2-year cliff at 20% and becomes fully vested after 6 years. A participant is 100% vested upon death, disability, or retirement.

Notes receivable from participants - Participants may borrow from their accounts a maximum of (a) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or (b) 50% of the present value of their vested account balance, whichever is less. Notes receivable from participants are secured by the vested balance in the participant’s account balance and bear interest. Participants are limited to one note receivable outstanding at a time. Principal and interest are paid ratably through payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be longer.

Payment of benefits - Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total vested benefits in a lump-sum amount. The Plan allows for the automatic lump-sum distribution of participant vested account balances which do not exceed \$5,000. Distributions are subject to the applicable provisions of the plan document.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, and changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – The investments are reported at fair value. The Plan’s trustee, MATC, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable), are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events – The Plan has evaluated subsequent events through October 14, 2024, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Note 3 – Fair Value Measurements (continued)**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. The funds held by the plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Tax Status**

The Plan has adopted a prototype plan that has received an opinion letter dated August 31, 2020 from the Internal Revenue Service. The Plan Administrator believes that the Plan, as amended, is operated in accordance with, and qualifies under, the applicable requirements of the IRC and related state statutes, and therefore is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is at least reasonably possible given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**Note 6 – Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MATC, the trustee of the plan, has certified to the completeness and accuracy of:

- Investments at fair value reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and dividend and interest income, reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments at fair value reflected on the schedule of assets (held at end of year).

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Nexsentio Inc 401(k) Profit Sharing Plan & Trust (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

**Note 1 – Description of the Plan**

Nexsentio Inc 401(k) Profit Sharing Plan & Trust (the “Plan”) is a defined contribution plan covering substantially all eligible employees of Nexsentio, Inc., (the “Plan Sponsor”). The Plan became effective January 1, 2020, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All Plan assets are held by Mid Atlantic Trust Company (“MATC”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Administration - The Plan Sponsor has contracted with MATC to act as the trustee to the Plan, and with Paychex to process and maintain the records of participant data.

Eligibility - Employees of the Plan Sponsor who have reached age 21 and are not members of a collective bargaining unit, leased employees, or non-resident aliens, are eligible to participate in the Plan upon the completion of one year of service, defined by the plan document as 1,000 hours of service. Employees are eligible to enter the Plan immediately following their satisfaction of the eligibility requirements. Participants must complete a minimum of 500 hours of service, as defined by the plan document, during a plan year and remain employed by the Plan Sponsor on the last day of the plan year, to be eligible for employer discretionary profit-sharing contributions.

Contributions - Participants are allowed to make elective pre-tax or after-tax Roth contributions to the plan of up to 100% of their annual eligible Plan compensation, as defined by the plan document, subject to limitation under the Internal Revenue Code (IRC). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

The Plan Sponsor may elect to allocate an employer discretionary profit-sharing contribution to the Plan based on annual profits determined and authorized by the Plan and the Plan Sponsor up to the maximum amounts permitted by the IRC. Allocation of the profit-sharing contributions will be based on total salary. No employer discretionary profit-sharing contributions were approved or made through December 31, 2024.

Participant accounts - Participants direct the investment of their accounts among various investment options offered by the plan. Participants may change their investment options daily.

Each participant account is credited with (a) the participant’s contributions, (b) an allocation of employer contributions, and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Vesting in the Plan Sponsor’s discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of credited service, as defined in the plan document. The vesting schedule for the profit-sharing contributions includes a 2-year cliff at 20% and becomes fully vested after 6 years. A participant is 100% vested upon death, disability, or retirement.

Notes receivable from participants - Participants may borrow from their accounts a maximum of (a) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or (b) 50% of the present value of their vested account balance, whichever is less. Notes receivable from participants are secured by the vested balance in the participant’s account balance and bear interest. Participants are limited to one note receivable outstanding at a time. Principal and interest are paid ratably through payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be longer.

Payment of benefits - Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total vested benefits in a lump-sum amount. The Plan allows for the automatic lump-sum distribution of participant vested account balances which do not exceed \$5,000. Distributions are subject to the applicable provisions of the plan document.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, and changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – The investments are reported at fair value. The Plan’s trustee, MATC, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable), are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events – The Plan has evaluated subsequent events through October 14, 2024, which is the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Note 3 – Fair Value Measurements (continued)**

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. The funds held by the plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Tax Status**

The Plan has adopted a prototype plan that has received an opinion letter dated August 31, 2020 from the Internal Revenue Service. The Plan Administrator believes that the Plan, as amended, is operated in accordance with, and qualifies under, the applicable requirements of the IRC and related state statutes, and therefore is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements.

**Note 5 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is at least reasonably possible given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**Note 6 – Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MATC, the trustee of the plan, has certified to the completeness and accuracy of:

- Investments at fair value reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and dividend and interest income, reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments at fair value reflected on the schedule of assets (held at end of year).

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
