We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of Restated Profit Sharing Plan and Trust of Boston Sand & Gravel Company (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of Boston Sand & Gravel Company and all of its eligible subsidiaries (collectively the “Company”), with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Effective January 1, 2021, the Plan was restated to comply with all applicable laws and regulations.

Eligibility

All employees of the Company, other than those employed as watchmen or parts runners, those covered by a collective bargaining agreement, those that are participants in the Railroad Retirement Plan, or those that are residents of Puerto Rico, are eligible to participate in the Plan upon completing two months of service.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of eligible pretax annual compensation, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). The Plan also allows Roth 401(k) contributions. These deferrals are subject to federal income taxes, and the maximum allowable contribution is \$23,000 combined between both the Roth and pre-tax deferral. Further, participants who are 50 years of age or older may contribute an additional “catch up” contribution (\$7,500 in 2024). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market account as investment options for participants.

The Plan added an automatic enrollment provision for eligible participants as more fully described in the amendment. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company will automatically, on behalf of those participants, defer 3% of the participants’ total eligible compensation (as defined). The deferrals will be allocated to the money market fund. Participants may cancel, modify, or otherwise change any of the automatic elections.

Nonelective profit sharing and matching contributions are made to the Plan at the discretion of the Company. Participants are required to complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to be eligible for the Company discretionary profit sharing contributions. Profit sharing contributions were \$266,709 for the year ended December 31, 2024.

Participants’ Accounts

Each participant’s account is credited with their respective contribution and its allocation of (a) employer contributions and (b) Plan earnings or losses.

Vesting

Participants are immediately vested in their voluntary contributions and actual earnings thereon. Company discretionary nonelective contributions made and earnings thereon vest over a period of six years, beginning with the participant's second year of service. Company discretionary nonelective contributions and earnings thereon prior to this date, vest over a period of seven years, beginning with the participants' second year of service. Company discretionary contributions and earnings thereon vest over a period of five years, beginning with the participants' second year of service.

In the event of death, disability, or attainment of age 65, participants' accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, attainment of age 59 ½, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum or elect to receive annual installments in accordance with Internal Revenue Service ("IRS") regulations and Plan provisions. Further, withdrawals from the Plan before leaving the company are available for special "hardship" reasons (as defined) or after attaining the age of 62. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and maximum of \$50,000. Participant loans are subject to the approval of the plan administrator and bear interest at a reasonable rate for similar types of loans. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to 15 years. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions. Interest payments are equal to the applicable Prime rate plus 1%.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, are applied to reduce future employer contributions or pay the Plan's administrative expenses. During 2024 and 2023, an amount of \$18,472 and \$33,411 was allocated to participant accounts as employer contributions, respectively. The balance in the unallocated forfeiture account was \$67,542 and \$18,472 as of December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use Of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are recorded at contract value (see Note 9). The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses

Administrative expenses associated with the Plan are paid for by the Plan or the Company.

Refundable Contributions Due to Participants

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants on July 31, 2025.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Information Certified by The Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company LLC (John Hancock), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by John Hancock Retirement Plan Services LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Party-in-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of a money market fund and mutual funds managed by John Hancock. John Hancock is the custodian, as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, as defined by ERISA.

The Plan paid \$15,917 of recordkeeping fees to John Hancock Trust Company LLC during the year ended December 31, 2024. Individually nonmaterial expenses paid to parties in interest aggregated to \$32,755 during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of

investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 9. Fully Benefit-Responsive Investment Contract

The Plan invested a portion of its assets in a certain annuity contract with Lincoln Financial Group. The Lincoln Stable Value Account is a fixed annuity contract which meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The Lincoln Stable Value Account provides (during the accumulation phase) for guaranteed principal, a guaranteed minimum rate of interest and the potential for additional interest, as more fully described in the contractual agreement. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. When the contract value accumulation (plan asset) is converted to an annuity (plan withdrawal), based on certain actuarial assumptions, the present value of the stream of payments is equal to the accumulation.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.
