NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Fidelity National Information Services, Inc. 401(k) Profit Sharing Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment transactions are accounted for on the trade date (the date the order to buy or sell is executed). The cost of investments sold is computed on an average cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and could materially affect the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Related-Party Transactions

Several employees of Fidelity National Information Services, Inc. (the "Company") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Fidelity Management Trust Company is the Plan's trustee and record-keeper.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant and are included in administrative expenses. Other administrative fees include investment advisory fees, qualified domestic relation order fees, beneficiary determination fees, managed account fees, legal fees, recordkeeping fees, and audit fees. Certain investment related expenses are included in net appreciation of fair value of investments. Expenses paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Fidelity National Information Services, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all employees of the Company who are 18 years of age and have completed 90 days of service. Temporary, part-time, or seasonal employees are eligible to participate in the Plan if they are 18 years of age or older and have completed 500 hours of service during the Plan year. Union, non-resident aliens without U.S. income and leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Employees are automatically enrolled at 3% in the Plan if they do not decline enrollment within 30 days of becoming eligible. Each year, participants may contribute up to 40% of eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC) (\$23,000 for 2024). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions (\$7,500 for 2024). Participants are automatically enrolled at 3%, unless they opt out. Participants may also contribute amounts representing pre-tax distributions from other qualified plans. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. Effective January 1, 2024, participant deferrals are automatically increased 1% annually, limited to 6%, unless they opt out.

The Plan provides a matching contribution equal to 50% of the participant's deferrals up to 6% of eligible compensation (3% maximum). The Plan also allows for the Company to make discretionary employer contributions at the option of the Company's Board of Directors. There were no discretionary contributions during 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants vest 34% after at least one year of credited service, 67% after at least two years of credited service, and 100% after at least 3 years of credited service. Forfeited balances of terminated participants' non-vested accounts are used to restore accounts of former Plan participants, pay administrative expenses of the plan, and then reduce future Company matching contributions. The balance of unallocated forfeitures was \$1,098,775 and \$689,886 at December 31, 2024 and 2023, respectively. During 2024, \$53,525 was used to pay Plan expenses and \$1,450,000 was used to reduce employer contributions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in as a complete or partial lump-sum payment. If a participant's account balance is less than \$1,000 upon retirement or termination, a distribution of the participant's account balance will be made automatically.

In-service distributions are permissible from the Plan for participants that have attained the age of 59½ or for qualified birth or adoption of a child. Also, rollover account balances are eligible for distribution at any time.

In conditions of "financial hardship", as defined, a participant may apply to the Plan Administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan.

Notes Receivable from Participants

Participant loans are available on amounts in the participant's account. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of one-half of a participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan Administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home. No more than one loan may be outstanding at a time for a participant. Principal and interest are paid ratably through payroll deductions.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market: Valued at the daily closing price as reported by the underlying fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common-Collective Trust: These assets are valued at daily net asset value (NAV) provided by Vanguard. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Units of the collective trust may be redeemed on a daily basis. There were no unfunded commitments to purchase investments as of December 31, 2024 and 2023. These investments are direct filing entities.

Self-Directed Brokerage Account: In addition to mutual funds and money market funds, the self-directed brokerage account consists of common stocks, which are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although the Plan has been amended, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 PLAN TRANSFER

In connection with the purchase and sale agreement between Fidelity National Information Services, Inc. and GTCR, LLC and affiliates providing for the spin-off of Fidelity National Information Services, Inc.'s Merchant Solutions business, WorldPay participants were spun-off into a separate plan. The transfer occurred on July 1, 2024 and all participant balances of affected participants were transferred from the Plan. All affected participants became 100% vested. NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Fidelity National Information Services, Inc. 401(k) Profit Sharing Plan (the "Plan") have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment transactions are accounted for on the trade date (the date the order to buy or sell is executed). The cost of investments sold is computed on an average cost basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and could materially affect the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Related-Party Transactions

Several employees of Fidelity National Information Services, Inc. (the "Company") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Fidelity Management Trust Company is the Plan's trustee and record-keeper.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant and are included in administrative expenses. Other administrative fees include investment advisory fees, qualified domestic relation order fees, beneficiary determination fees, managed account fees, legal fees, recordkeeping fees, and audit fees. Certain investment related expenses are included in net appreciation of fair value of investments. Expenses paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of the Fidelity National Information Services, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering all employees of the Company who are 18 years of age and have completed 90 days of service. Temporary, part-time, or seasonal employees are eligible to participate in the Plan if they are 18 years of age or older and have completed 500 hours of service during the Plan year. Union, non-resident aliens without U.S. income and leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Employees are automatically enrolled at 3% in the Plan if they do not decline enrollment within 30 days of becoming eligible. Each year, participants may contribute up to 40% of eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC) (\$23,000 for 2024). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions (\$7,500 for 2024). Participants are automatically enrolled at 3%, unless they opt out. Participants may also contribute amounts representing pre-tax distributions from other qualified plans. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. Effective January 1, 2024, participant deferrals are automatically increased 1% annually, limited to 6%, unless they opt out.

The Plan provides a matching contribution equal to 50% of the participant's deferrals up to 6% of eligible compensation (3% maximum). The Plan also allows for the Company to make discretionary employer contributions at the option of the Company's Board of Directors. There were no discretionary contributions during 2024.

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants vest 34% after at least one year of credited service, 67% after at least two years of credited service, and 100% after at least 3 years of credited service. Forfeited balances of terminated participants' non-vested accounts are used to restore accounts of former Plan participants, pay administrative expenses of the plan, and then reduce future Company matching contributions. The balance of unallocated forfeitures was \$1,098,775 and \$689,886 at December 31, 2024 and 2023, respectively. During 2024, \$53,525 was used to pay Plan expenses and \$1,450,000 was used to reduce employer contributions.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in as a complete or partial lump-sum payment. If a participant's account balance is less than \$1,000 upon retirement or termination, a distribution of the participant's account balance will be made automatically.

In-service distributions are permissible from the Plan for participants that have attained the age of 59½ or for qualified birth or adoption of a child. Also, rollover account balances are eligible for distribution at any time.

In conditions of "financial hardship", as defined, a participant may apply to the Plan Administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan.

Notes Receivable from Participants

Participant loans are available on amounts in the participant's account. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of one-half of a participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any loan. All loans shall bear a reasonable rate of interest as determined by the Plan Administrator. All loans must be repaid within five years except in the case of a loan for the purpose of acquiring a home. No more than one loan may be outstanding at a time for a participant. Principal and interest are paid ratably through payroll deductions.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds and money market: Valued at the daily closing price as reported by the underlying fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common-Collective Trust: These assets are valued at daily net asset value (NAV) provided by Vanguard. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Units of the collective trust may be redeemed on a daily basis. There were no unfunded commitments to purchase investments as of December 31, 2024 and 2023. These investments are direct filing entities.

Self-Directed Brokerage Account: In addition to mutual funds and money market funds, the self-directed brokerage account consists of common stocks, which are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Internal Revenue Service (IRS) has informed the Company by a determination letter dated April 19, 2018, that the Plan adopted by the Company as then-designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

The following information provided by Fidelity Management Trust Company was certified to be complete and accurate with respect to the following:

- (a) The assets held as of December 31, 2024 and 2023, as well as the transactions involving these assets for the years then ended.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 6 PLAN TRANSFER

In connection with the purchase and sale agreement between Fidelity National Information Services, Inc. and GTCR, LLC and affiliates providing for the spin-off of Fidelity National Information Services, Inc.'s Merchant Solutions business, WorldPay participants were spun-off into a separate plan. The transfer occurred on July 1, 2024 and all participant balances of affected participants were transferred from the Plan. All affected participants became 100% vested. A summary of the Worldpay transferred assets follows:

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
