Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Brockton Visiting Nurse Association Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. Description of Plan

The following description of the Brockton Visiting Nurse Association Retirement Plan (the Plan) provides general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

Brockton Visiting Nurse Association (the Association) has offered to their employees a defined contribution tax sheltered annuity plan qualifying under Section 403(b) of the Internal Revenue Code (IRC). The Association established the Plan to provide employees with a systematic means of savings and investing for the future. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Empower Trust Company, LLC (Empower) is the custodian of the Plan. Empower Annuity Insurance Company of America, Brighthouse Life Insurance Company (Brighthouse) and Lincoln National Life Insurance Company (Lincoln) (collectively, the trustees) are the trustees of the Plan.

Participation

All employees of the Association, as defined in accordance with the universal availability standards, are considered to be active participants and are eligible to enroll in the Plan for pre-tax salary reduction contributions upon hire, with the exception of the following excluded employees:

- Employees who are eligible to participate in a 401(k) plan sponsored by the Association
- Employees who normally work less than 20 hours per week
- Employees who are students performing services in the employment of a school, college or university

For purposes of contributions other than elective deferral contributions, active participants as defined above are eligible for employer match and non-elective contributions on the first day of the month coinciding with or following completion of one year of service and when the participant has attained age 21.

Contributions

Permissible employees may contribute up to 100% of their compensation as defined by the Plan by means of payroll deductions as of the date they become eligible to participate in the Plan (upon hire). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also elect to make special Section 403(b) catch-up contributions. Participants may also make direct rollover contributions to the Plan from other eligible retirement plans as defined by the Plan.

The Association matches 25% of each eligible participant's elective deferral contribution to the Plan, up to 1% of total compensation.

The Association may also make a discretionary non-elective contribution based on years of service to eligible participants during the year as follows:

Contributions are subject to certain IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Association's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Vesting in the Association's contributions is based on years of continuous service. A participant's vested interest in their account derived from employer contributions and investment earnings shall be based on a six year vesting schedule.

A participant becomes immediately 100% vested in accounts derived from employer contributions and investment earnings upon death, disability or attainment of normal retirement age (age 65).

Forfeitures

Participants who terminate their employment prior to becoming 100% vested forfeit their non-vested account balance. These benefits, plus accumulated investment earnings, are left in the Plan to reduce employer contributions for the succeeding plan year. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33,546 and \$42,254, respectively. During the year ended December 31, 2024, the Association reduced employer contributions by \$30,700 from forfeited nonvested accounts.

Payment of Benefits

Upon termination of employment due to severance, disability or death, a participant or beneficiary may receive an amount equal to the value of the participant's vested interest in his or her account. In-service withdrawals are also permitted for financial hardship, attainment of age 59½ or attainment of normal retirement age (65). If a participant incurs a hardship, as defined by the Plan, the participant may receive the entire amount credited to the participant's account from elective deferral contributions and rollovers. After attaining age 59½, but before age 65, a participant may make in-service withdrawals if the participant's account is fully vested.

Distributions of account balances may be in any form permitted by the Plan (lump sum, installment, or annuity). A participant who terminates employment with a vested account balance of \$1,000 or less and does not elect to receive a distribution will receive an involuntary cash-out distribution in the form of a lump-sum payment. A participant who terminates employment with a vested account balance between \$1,000 and \$5,000, and does not elect to receive a distribution, will have their vested account balance automatically rolled over to an individual retirement account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of certain assets, liabilities and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 10 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Participants may borrow up to \$50,000, subject to certain limitations and vested account balance, as set forth in the Plan document.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Substantially all administrative expenses are paid by the Association; however, certain expenses, including recordkeeping and contract administration services, are paid by the participants.

Subsequent Events

Management has considered transactions or events occurring through October 13, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Certified by Custodian and Trustees

All investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants, and interest and dividend amounts were obtained by management and agreed to or derived from the information certified by the custodian and trustees, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year).

4. Guaranteed Interest Account

The MassMutual General Account is a guaranteed interest account (GIA) provided through a group annuity contract (the Contract). Under the terms of the Contract, a crediting rate is established for amounts invested in the GIA and participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. MassMutual considers this investment option to be fully benefit-responsive notwithstanding the Contract provisions that limit the ability of the Plan to transact at contract value when market value event occurs.

Because the GIA is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIA.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to a participant termination of employment due to: (a) removal of a group of participants from plan coverage as a result of temporary absence; (b) change in position or other occurrence qualifying as a temporary break in service under the Plan; (c) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (d) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (a) removal from the Plan of one or more groups or classifications of participants; (b) partial or complete plan termination; or (c) plan disqualification. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the plan to transact at contract value with the participants.

The average yield earned by the Plan and average interest rate credited to participant accounts was 2.43% during the year ended December 31, 2024.

5. Life Insurance Contracts

As of December 31, 2024, the Plan had three fully benefit-responsive life insurance contracts: two with Brighthouse and one with Transamerica Employee Benefits. The contributions are maintained in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The group annuity contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the life insurance contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the life insurance contracts.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rates are based on a formula agreed upon with the issuers. Such interest rates are reviewed on an annual basis for resetting. The guaranteed minimum interest rates under the contracts range from 0% - 3%.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any event that would limit the Plan's ability to transact at contract value with participants is probable of occurring.

The contracts do not permit termination of the agreement by the trustees prior to the scheduled maturity date.

6. Parties-in-Interest

Certain of the Plan's investments are managed by the trustees and, therefore, their transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustees for recordkeeping and contract administration services totaled \$36,427 for the year ended December 31, 2024.

7. Plan Termination

Although it has not expressed any intent to do so, the Association has the right to terminate the Plan subject to the provisions of ERISA.

8. Tax Status

The Plan has adopted the Empower Retirement Volume Submitter 403(b) Plan, which received a favorable advisory letter dated April 7, 2021, from the Internal Revenue Service stating that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter, however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the quoted market value of shares held by the Plan at year-end which are traded in an active market.

11. Exclusion of Certain Accounts

The Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. U.S. GAAP requires that these accounts and the income and distributions be included in the accompanying financial statements. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable.
