The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of GCC Technologies 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of GCC Technologies, LLC (Company) Retirement Plan & Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have at least an hour of service, except for leased employees. Service Contract Act employees are not eligible for matching and profit sharing contributions. The profit sharing option covers employees who have completed 500 hours of service in a six month period, who have completed 1,000 hours of service during the plan year, and who are employed by the Company on the last day of the plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, Plan participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing tax-free rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund investment options for participants. The Company contributes 100% of the first 3% and 50% up to 4% of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company. As of January 1, 2018, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan along with eligible employees who had an elective deferral contribution at January 1, 2018, that was less than the automatic contribution rate. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. Contributions are subject to certain limitations as defined in the Plan agreement, and as limited by statute.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with the participant's distributions, withdrawals and an allocation of administrative expenses, at the direction of the plan administrator. Allocations are based on participant compensation or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, qualified nonelective contributions, and qualified matching contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined by the plan administrator. As of December 31, 2024, interest rates ranged from 4.25% - 9.5%. Principal and interest is paid ratably through bi-weekly payroll deductions. Outstanding loans as of December 31, 2024 and 2023 amounted to \$241,193 and \$208,529, respectively. Refer to Note 13 for additional information regarding a restatement of the 2023 outstanding loan balance.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$28,869 and \$225,359 respectively. Forfeitures are to be used to pay expenses or reduce future employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The 2024 excess contributions were distributed to the applicable participants prior to December 31, 2025. The Plan did not have excess contributions for the year ended December 31, 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the guaranteed investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Under certain requirements of professional accounting and financial reporting standards, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. As required by professional accounting standards, the Statement of Net Assets Available for Benefits presents the guaranteed investment contract at contract value.

The value of a unit in a pooled separate account is the fair market value of investments in the account as of the valuation date, plus cash balances and accruals less accounts payable, expenses and taxes that are allocable to the account, divided by the number of outstanding participation units in the account. Securities held in the pooled separate accounts are valued based on quoted market prices. If there is no readily available market value for a particular security, the investment manager will determine the fair market value of such investment in accordance with accepted practices and applicable laws and regulations. As of any date, the value of the Plan’s share of a separate account will equal the number of participation units held by the Plan multiplied by the participation unit value.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Company. Other administrative and transaction fees are paid by the Plan and are reported in the statement of changes in net assets available for benefits as administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. There has been no material event noted during the period that would either impact the results in the report or the Company's results going forward.

NOTE 3 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

Empower Retirement (Empower) acquired Massachusetts Mutual Life Insurance Company's (MassMutual) retirement plan business. All contracts previously issued by MassMutual remained as such and were not reissued by Empower. The Plan maintains, as an investment option for participants, a benefit responsive investment contract with MassMutual. Empower maintains the contributions in a general account. No other changes were made to the structure of the contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract is contractually obligated to repay the principal at a specified interest rate that is guaranteed by the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

NOTE 3 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

There are no allowances against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis and can be changed at any time by Empower with written notice.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents including those that adversely affect Empower's sole determination (2) changes to the Plan's prohibition and competing investment options (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract value of the investment contract at December 31, 2024 and 2023, was \$66,080 and \$347,099, respectively.

NOTE 4 - FAIR VALUE MEASUREMENTS

Investments in the Plan's variable investment account (pooled separate account) and part of the Group Annuity Contract are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable quoted prices in inactive markets for identical or similar assets or liabilities. Level 3 inputs are unobservable and have the lowest priority. The Plan's investments held in the separate account and administered by Empower are valued entirely using Level 2 inputs.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The valuation methodology used for the assets measured at fair value and held in the pooled separate account was the accumulated units of the variable investment that are credited to the participant’s account (also known as the participant’s variable investment account “Account Value”).

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The principal owners of GCC Technologies, LLC (the plan sponsor) are also the trustees of GCC Technologies, LLC Retirement Plan & Trust. GCC Technologies, LLC provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions are exempt party in interest transactions. Plan administrative expenses of \$2,895 for the year ended December 31, 2024 are comprised of investment advisory, recordkeeping and information management fees paid to the plan consultant and plan record keeper.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 1, 2010, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America required the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions taken by the Plan that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Required nondiscrimination testing related to Code Section 401(k) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions will be disposed of in accordance with regulations.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – ERISA SECTION 103(A)(3)(C) AUDIT DISCLOSURE

The investment asset values, transactions, and income, and the schedules of assets held for investment purposes and reportable transactions were certified by Empower Annuity Insurance Company of America, the third party plan custodian as of December 31, 2024 and 2023 to be complete and accurate.

NOTE 10 - ERISA FIDELITY BOND COVERAGE

The amount of the Plan’s ERISA Fidelity Bond coverage as of December 31, 2024 and 2023 was sufficient in relation to the Plan’s assets. The IRS/DOL requires the bond to be at least equal to the lesser of 10% of plan assets or \$500,000. The Plan’s policy was \$500,000 as of December 31, 2024, and therefore, provides compliance.

NOTE 12 – SECURE ACT AND SECURE ACT 2.0

The Plan has implemented requirements of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), which law changes the Plan to, among others, allows in-service withdrawals for childbirth and adoption expenses, allow retirees to delay taking RMD until age 72, and increase the maximum amount of the automatic contribution from 10% to 15%. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

The Plan has implemented requirements of the Setting Every Community Up for Retirement Enhancement Act 2.0 of 2022 (SECURE Act 2.0), which law changes the Plan to, among others, allow retirees to delay taking RMD until age 73. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

NOTE 13 – PRIOR PERIOD ADJUSTMENT – CORRECTION OF AN ERROR

During the year ended December 31, 2024, the Plan determined that it had understated notes receivable from participants for the year ended December 31, 2023. This was the result of an error in the presentation of deemed distribution of notes receivable in a default status. While these defaulted notes are presented as distributions for the 5500, they should continue to be reported as notes receivable for financial reporting purposes until paid. The Plan restated its December 31, 2023 financial statements to properly state the notes receivable and net asset balances as of December 31, 2023, resulting in an increase of \$29,835 in notes receivable from participants and net assets. Deemed distributed loans in the current year have been included in notes receivable and included in Note 11 as a reconciling item between the 5500 and the financial statements. This change has no other impact to the financial statements or the Plan's operations during the years ended December 31, 2024, or December 31, 2023.
