NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Lueder Larkin & Hunter LLC 401(k) Profit Sharing Plan & Trust** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - On January 1, 2005, Lueder, Larkin & Hunter, LLC (the "Company") adopted a Section 401(k) profit sharing plan. The Plan allows all eligible employees of the Company, who have 1 year of service of a minimum of 1,000 service hours and have attained age 21 to participate, excluding union employees and nonresident aliens. Upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the month coinciding with or next following date requirements met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes Center Professional Title LLC, One Legacy Title LLC, Title Connections LLC, and Tradition Title LLC as participating employers in the Plan. During 2024, Connect Title Services LLC and Crossroads Title LLC became participating employers in the Plan.

Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth deferrals.

Participants become eligible for safe harbor matching contributions at the beginning of the calendar quarter subsequent to completion of one year of service. For the years 2024 and 2023, the Plan contributed 100% of the first 4% of elective deferrals that a participant contributed to the Plan. The Company may make non-elective discretionary contributions. The Company made no non-elective discretionary contributions for the years 2024 and 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

Participant Accounts - Voya Institutional Trust Company is Trustee of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment option the participant contribution, employer match, and discretionary contribution are to be invested.

Vesting - Participants are immediately vested in their voluntary contributions, safe harbor matching contributions, rollovers and corresponding earnings. The following schedule will be used to determine vesting in the discretionary non-elective contributions and its corresponding earnings:

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Notes Receivable From Participants - Participants may borrow from the Plan in any amount between \$500 and \$50,000, but not more than 50% of their vested balance. Loans bear interest at an agreed-upon percentage based on prevailing market rates, subject to applicable usury limits. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions. Participants may have only one loan outstanding at any given time.

Benefits Paid - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or partial withdrawals, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. The participant account balance threshold for automatic distributions was increased to \$7,000 effective January 1, 2025. In addition, participants may receive distributions of the employee deferral and rollover amounts for qualified financial hardships.

Forfeitures - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. Forfeitures in the amount of \$813 and \$0 were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$0 and \$777.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options at any time via phone or the Internet. Deferral percentages can be changed via the enrollment form or the Internet.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses is deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan entered into an Expense Account for Service Expenditures ("EASE Account") Agreement that allows the Plan to accumulate any excess revenue into this EASE Account and to use the funds to defray the reasonable expenses of administering the Plan. The Company may pay certain administrative expenses of the Plan that are not paid by the EASE Account. The EASE Account is included in Plan assets and is invested in the Voya Fixed Account. The excess revenue is accumulated into the account at the end of each month. All payment requests must be submitted prior to the close of business on March 31 following the end of the year in which the excess revenue was credited to the EASE Account. The unused balance after submission of the expenses will be allocated to participants on a forfeiture-account basis. Income in the amount of \$1,078 and \$2,693 was allocated to participants in 2024 and 2023. The balance in the EASE Account was \$1,369 and \$1,078 at December 31, 2024 and 2023.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for specific transactions, such as loans and distribution withdrawals, are paid by the individual participant.

Reclassifications - Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 financial statement presentation.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company (the Trustee of the Plan).

NOTES TO FINANCIAL STATEMENTS

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued based on the valuation formula contained in the contract of the underlying fund; provides a daily mil-rate for income accretion.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Voya Fixed Account is a fully benefit-responsive investment contract that provides a stated rate of return. The objective of the fund is to preserve principal and provide interest income, while maintaining liquidity. Investment contracts have elements of risk due to lack of a secondary market and resale restrictions. The crediting interest rate is determined semiannually, based on factors such as investment experience, projected cash flows, and maturity of investments.

The crediting interest rates are based on an agreed-upon formula with Voya Institutional Trust Company. The interest rates are reviewed on a quarterly basis for resetting by Voya Institutional Trust Company. The contract is included in the statements of net assets available for benefits as a fully benefit-responsive investment contract at its contract value.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Voya Institutional Trust Company. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

NOTES TO FINANCIAL STATEMENTS

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with Voya Institutional Trust Company with record keeping performed by Voya Institutional Plan Services, LLC. Voya Institutional Trust Company, the Trustee of the Plan, is related to Voya Institutional Plan Services, LLC. Thus, Voya Institutional Trust Company and Voya Institutional Plan Services, LLC qualify as parties-in-interest. Fees paid by the Plan for administrative services for the years 2024 and 2023 totaled \$1,000 and \$950.

Gallagher Benefit Services, Inc. provided advisory services to the Plan and qualifies as a party-in-interest. Fees paid to these parties were indirect and totaled \$30,877 and \$26,553 for the years 2024 and 2023.

The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

NOTE 8 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

NOTE 11 - NON-EXEMPT TRANSACTIONS

During 2024, the Plan sponsor failed to timely remit participant contributions in the amount of \$7. As a result of this failure, a non-exempt transaction was reported. The Plan sponsor is liable for lost earnings and excise tax, which will be paid during 2025. The Plan sponsor was timely on the remittance of all participant contributions during 2023.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Lueder Larkin & Hunter LLC 401(k) Profit Sharing Plan & Trust** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - On January 1, 2005, Lueder, Larkin & Hunter, LLC (the "Company") adopted a Section 401(k) profit sharing plan. The Plan allows all eligible employees of the Company, who have 1 year of service of a minimum of 1,000 service hours and have attained age 21 to participate, excluding union employees and nonresident aliens. Upon satisfaction of the eligibility requirements, employees may enter the Plan on the first day of the month coinciding with or next following date requirements met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes Center Professional Title LLC, One Legacy Title LLC, Title Connections LLC, and Tradition Title LLC as participating employers in the Plan. During 2024, Connect Title Services LLC and Crossroads Title LLC became participating employers in the Plan.

Contributions - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth deferrals.

Participants become eligible for safe harbor matching contributions at the beginning of the calendar quarter subsequent to completion of one year of service. For the years 2024 and 2023, the Plan contributed 100% of the first 4% of elective deferrals that a participant contributed to the Plan. The Company may make non-elective discretionary contributions. The Company made no non-elective discretionary contributions for the years 2024 and 2023. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service.

Participant Accounts - Voya Institutional Trust Company is Trustee of Plan investments. Each participant's account is credited with the participant's contributions, Company contributions, net earnings or losses, forfeitures, distributions, and withdrawals. Company contributions are allocated based on participants' compensation as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment option the participant contribution, employer match, and discretionary contribution are to be invested.

Vesting - Participants are immediately vested in their voluntary contributions, safe harbor matching contributions, rollovers and corresponding earnings. The following schedule will be used to determine vesting in the discretionary non-elective contributions and its corresponding earnings:

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

Notes Receivable From Participants - Participants may borrow from the Plan in any amount between \$500 and \$50,000, but not more than 50% of their vested balance. Loans bear interest at an agreed-upon percentage based on prevailing market rates, subject to applicable usury limits. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions. Participants may have only one loan outstanding at any given time.

Benefits Paid - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or partial withdrawals, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$5,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. The participant account balance threshold for automatic distributions was increased to \$7,000 effective January 1, 2025. In addition, participants may receive distributions of the employee deferral and rollover amounts for qualified financial hardships.

Forfeitures - Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. Forfeitures in the amount of \$813 and \$0 were used during 2024 and 2023. Unallocated forfeitures at December 31, 2024 and 2023 were \$0 and \$777.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in investment options in increments of one percent. Participants may change their investment options at any time via phone or the Internet. Deferral percentages can be changed via the enrollment form or the Internet.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Financial Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTES TO FINANCIAL STATEMENTS

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses is deemed necessary as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Plan entered into an Expense Account for Service Expenditures ("EASE Account") Agreement that allows the Plan to accumulate any excess revenue into this EASE Account and to use the funds to defray the reasonable expenses of administering the Plan. The Company may pay certain administrative expenses of the Plan that are not paid by the EASE Account. The EASE Account is included in Plan assets and is invested in the Voya Fixed Account. The excess revenue is accumulated into the account at the end of each month. All payment requests must be submitted prior to the close of business on March 31 following the end of the year in which the excess revenue was credited to the EASE Account. The unused balance after submission of the expenses will be allocated to participants on a forfeiture-account basis. Income in the amount of \$1,078 and \$2,693 was allocated to participants in 2024 and 2023. The balance in the EASE Account was \$1,369 and \$1,078 at December 31, 2024 and 2023.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for specific transactions, such as loans and distribution withdrawals, are paid by the individual participant.

Reclassifications - Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 financial statement presentation.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company (the Trustee of the Plan).

NOTES TO FINANCIAL STATEMENTS

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued based on the valuation formula contained in the contract of the underlying fund; provides a daily mil-rate for income accretion.

Pooled separate accounts: Valued at the net asset value (NAV) of units held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Voya Fixed Account is a fully benefit-responsive investment contract that provides a stated rate of return. The objective of the fund is to preserve principal and provide interest income, while maintaining liquidity. Investment contracts have elements of risk due to lack of a secondary market and resale restrictions. The crediting interest rate is determined semiannually, based on factors such as investment experience, projected cash flows, and maturity of investments.

The crediting interest rates are based on an agreed-upon formula with Voya Institutional Trust Company. The interest rates are reviewed on a quarterly basis for resetting by Voya Institutional Trust Company. The contract is included in the statements of net assets available for benefits as a fully benefit-responsive investment contract at its contract value.

Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Voya Institutional Trust Company. The Plan Administrator believes the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is not probable.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan assets are invested with Voya Institutional Trust Company with record keeping performed by Voya Institutional Plan Services, LLC. Voya Institutional Trust Company, the Trustee of the Plan, is related to Voya Institutional Plan Services, LLC. Thus, Voya Institutional Trust Company and Voya Institutional Plan Services, LLC qualify as parties-in-interest. Fees paid by the Plan for administrative services for the years 2024 and 2023 totaled \$1,000 and \$950.

Gallagher Benefit Services, Inc. provided advisory services to the Plan and qualifies as a party-in-interest. Fees paid to these parties were indirect and totaled \$30,877 and \$26,553 for the years 2024 and 2023.

The Plan Sponsor provides certain accounting, recordkeeping, and administrative services to the Plan, for which it receives no compensation.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

NOTE 8 - TAX STATUS

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

NOTE 11 - NON-EXEMPT TRANSACTIONS

During 2024, the Plan sponsor failed to timely remit participant contributions in the amount of \$7. As a result of this failure, a non-exempt transaction was reported. The Plan sponsor is liable for lost earnings and excise tax, which will be paid during 2025. The Plan sponsor was timely on the remittance of all participant contributions during 2023.
