We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's responsibilities for the audit of the financial statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

The supplemental schedule of assets of (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the

certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - PLAN DESCRIPTION

The following brief description of the Cozen O'Connor Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Prior to January 1, 2021, the Plan name was Cozen O'Connor Profit Sharing Plan.

General

The Plan is a defined contribution profit sharing plan with a 401(k) feature. All non-union domestic employees of Cozen O'Connor (the "Company" or "Employer") who have completed thirty (30) days of service and attained age 21 are eligible to participate in the Plan except for employees who are classified as Associate Attorneys or Staff Attorneys of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligible employees are automatically enrolled in the Plan at 5% of compensation, unless the employee opts out or elects a different deferral percentage.

The Plan provides for automatic annual escalation on April 1 of each year up to a maximum of 15% of compensation. This automatic increase provision will not apply to participants who had elected a deferral rate of a flat dollar amount and those who opt out of the automatic escalation program.

Contributions

Participant Salary Deferrals

Participants may elect to contribute up to 75% of their qualified pre-tax compensation subject to the Internal Revenue Code (the "Code") annual contribution limitations (\$23,000 for 2024). Participants attaining age 50 before the end of the Plan year may elect to defer additional amounts (called "catch-up contributions") to the Plan, up to a maximum of \$7,500 for 2024. Participants may also roll over amounts distributed from other qualified plans.

Employer Contributions

Participants who have completed one year of service (worked 1,000 hours) and are employed on the last day of the Plan year are eligible for discretionary Employer contributions. Employer contributions to the Plan are determined annually as follows:

Matching Contributions

The Employer may contribute discretionary Employer matching contributions for participants who were not classified as an attorney at any time during the Plan year and whose compensation is less than or equal to \$213,000 for 2024. The discretionary matching contribution for each participant is based upon a uniform percentage of the amount of participant salary deferral made to the Plan, up to an annual maximum of \$500. The Employer matching contribution for 2024 was \$251,898.

Profit Sharing Contributions

The Employer may make a nonelective contribution to the Plan as determined by the Employer. Effective January 1, 2021, any Participant is excluded from participating in the Nonelective Contribution feature of the Plan if both (i) their Social Security Number ends in an odd number, and (ii) they are not classified by the Employer as a Shareholder, Senior Counsel, Managing Director, Chief Operating Officer, Chief Marketing Officer or Chief Operating Officer Ancillary Business Units/Chief Innovation Officer. Any Participant who is classified as a Shareholder, Senior Counsel, Managing Director, Chief Operating Officer, Chief Marketing Officer or Chief Operating Officer Ancillary Business Units/Chief Innovation Officer shall

be eligible to participate in the Nonelective Contribution component of the Plan even if their Social Security Number ends in an odd number.

Employer profit sharing contributions are allocated to participants according to employee group classification as established by the Employer and set forth in the Plan document. Amounts contributed to each group are allocated to each group participant proportionately based upon compensation subject to annual compensation limitations (\$345,000 for 2024) under the Code. The Employer profit sharing contribution was \$ 10,723,933 for the year ended December 31, 2024.

Investment Options

Participants may choose to invest their contributions among any of the Plan's investment options or through a self-directed brokerage account offered by the Plan. All investments in the self-directed brokerage account are marketable securities traded on active securities exchanges. Participants may redirect their future investment contributions or transfer their existing account balances among the investment options on a daily basis.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's salary deferral contributions and allocations of the Employer's annual contributions and investment earnings, and is charged with withdrawals, administrative expenses and an allocation of investment gains (losses), if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, Employer matching contributions and actual earnings thereon. Vesting in the Employer profit sharing contribution portion of their accounts is based on years of continuous service. Participants vest 20% after two years of service and an additional 20% per year thereafter. Participants are 100% vested after six years of service. Additionally, participants are credited with specific service at previous law firms that precedes employment with the Employer.

Benefit Payments

Upon termination of service, death, disability, retirement or separation, participants or their beneficiaries may elect to receive, in either a lump sum or in annuity payments, an amount equal to the value of the participant's vested interest in his or her account. If a participant's account balance is less than \$5,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into an individual retirement account. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account will be made automatically in a single lump-sum cash distribution.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Participants are also permitted to make hardship withdrawals from their deferral contribution in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be taken at any time.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures may be made available to reinstate previously forfeited account balances of former participants renewing employment with the Company, subject to certain conditions, or may be used to pay any administrative expenses of the Plan. The remaining forfeitures, if any, shall be used to reduce

Employer contributions or for allocation to certain eligible participants. For the plan year ended December 31, 2024, forfeited non-vested accounts of \$171,667 were used to fund Employer contributions. As of December 31, 2024 and 2023, the forfeiture account amounted to \$171,667 and \$398,207, respectively.

Notes Receivable from Participants

Notes receivable from participants allow, under defined conditions and approval by the Plan administrator, participants to borrow the lesser of 50% of the participant's vested account balance or \$50,000, with a minimum loan amount of \$1,000. The repayment period may not exceed five years, unless for the purchase of a primary residence, which extends the repayment period to 15 years. Participants may only have one outstanding loan at a time. The loans are collateralized by the participant's account balance and bear interest at a reasonable rate, determined by the Plan administrator to be the prime rate published in the Wall Street Journal on the first business day of the month in which the loan is made, plus 1%. Interest rates ranged from 4.25% to 9.5% at December 31, 2024 and from 4.25% to 9.50% at December 31, 2023. Principal and interest are paid ratably through payroll deductions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation or depreciation includes the gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain noninvestment administrative expenses of the Plan are paid by the Plan, such as audit, investment advisory and consulting fees. The Plan incurred administrative expenses of \$300,821 for the year ended December 31, 2024.

ERISA Account

The Plan has an ERISA account that captures excess income and fee credits collected by the trustee. The funds held in the account may be used to pay administrative expenses of the Plan or allocated to participants. The ERISA account balance was \$37,315 and \$326 at December 31, 2024 and 2023, respectively, and is included as assets of the Plan. During the year ended December 31, 2024, amounts totaling \$1,411,998 were allocated to eligible participants.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 - 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable pricing inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies and Self-Directed Brokerage Accounts: Valued at net asset value ("NAV") of shares held by the Plan at year end based upon quoted market prices on nationally recognized exchanges (Level 1). Self-directed brokerage accounts hold investments in common and preferred stock, as well as mutual funds.

Collective Trust: Valued using the NAV as a practical expedient to fair value, provided by the administrator of the fund. The NAV is based on the value of the assets owned by the fund, less the liabilities at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

NOTE E - TAX STATUS

The Plan obtained its latest determination letter from the Internal Revenue Service ("IRS") by letter dated October 20, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan, in form and operations, complies with the requirements of the Code, as currently in effect.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - TRANSFERS FROM ASSOCIATES 401(K) PLAN

Transfers from the Cozen O'Connor Associates 401(k) Plan occur when an Associate Attorney of the Employer is promoted from an Associate to Member Attorney status. As a result, the employee becomes eligible to participate in the Plan and, accordingly, transfers his or her entire balances from the Cozen O'Connor Associates 401(k) Plan to the Plan. Upon change in position to Staff or Associate Attorney, a participant is no longer eligible to participate in this Plan. However, he or she is eligible to participate in the Cozen O'Connor Associates 401(k) Plan and, accordingly, his or her entire balance is transferred to that plan.

NOTE H - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

NOTE I - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan includes investments in registered investment company funds, self-directed brokerage accounts and a common collective trust managed by an affiliate of T. Rowe Price Trust Company, a trustee of the Plan. The Plan also allows notes receivable from participants. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Effective January 1, 2021, the Company formed Cozen O'Connor Profit Sharing Plan B ("Profit Sharing Plan B"). During 2024, the Company prefunded profit sharing contributions to the Plan. At December 31, 2024, the Plan was holding prefunded profit-sharing contributions on behalf of Profit-Sharing Plan B. In August 2025, the Employer transferred the amount due to Profit Sharing Plan B.
