**1. DESCRIPTION OF THE PLAN**

The following description of the Allegheny Contracting, LLC 401(k) Profit Sharing Plan (“The Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan adopted on January 1, 2018, covering all employees of Allegheny Contracting, LLC (“The Company”), upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year employees may make either pretax or after-tax Roth contributions, as defined in the Plan, up to the maximum permitted by law. The Company makes a safe-harbor matching contribution up to four percent (4%) of the employee’s pretax annual compensation. The Company may also contribute additional profit sharing amounts which are totally discretionary.

The Plan also provides the participants who are age 50 or older by the end of the calendar year and who are making deferral contributions to make catch-up contributions as permitted by the IRS; catch-up contributions will also be matched by the Company at the same rate as regular pretax contributions.

Additionally, the Plan provides for rollover contributions from eligible rollover distributions that participants receive from prior employer's eligible retirement plan.

Participant Accounts

Upon enrollment in the Plan, each participant may direct their contributions into several investment options provided by the Plan.

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested both in their contributions and in the Company’s matching contribution portion of their accounts, plus actual earnings thereon. Vesting in the Company’s discretionary profit sharing contribution portion of their accounts is based upon years of continuous service. A participant is 100% vested after three years of credited service.

Forfeitures

If an employee terminates employment, the nonvested portion of contributions are treated as forfeitures and are retained by the Plan and will first be used to pay expenses and then any remaining amounts will be used to reduce future Company Contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$ 8, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest rates at 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

On separation of service due to voluntary or involuntary termination, death, disability or retirement, a participant is entitled to receive a lump sum amount equal to the vested portion of the participant's account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that effect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting and are prepared in conformity with U.S. generally accepted accounting principles ("GAAP") as promulgated by the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan's Recordkeeping and Investment Advisory expenses have been paid by charging each participant's account with an allocation of these expenses paid by The Plan.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**4. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by American Funds and Employee Fiduciary, the custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**5. SEPARATED PARTICIPANTS**

At December 31, 2024, participants separated from service for which distributions have not been remitted have an approximate vested balance of approximately \$513,000.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**7. ADMINISTRATIVE EXPENSES**

Fees paid by the Plan for the administrative services amounted to \$10,281 and \$775 for the years ended December 31, 2024 and 2023, respectively. Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Certain administrative expenses are paid directly to the third party administrator by the Plan.

**8. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by letter that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified as tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**10. SUBSEQUENT EVENT**

In August 2024, the Plan sponsor had been purchased by Delphi Infrastructure Group. The Plan sponsor began the transiting process in May of 2025 and the adoption agreement for the Mercer Wise Pooled Employer Plan was adopted August 1, 2025. Delphi Infrastructure Group has elected to consolidate their companies' plans into one. Plan assets were transferred from Employee Fiduciary to Mercer Wise PEP effective August 27, 2025.
