Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Komatsu America Corp. 401(k) Deferred Savings Plan for Union Hourly Employees, Peoria, Illinois (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Komatsu America Corp. 401(k) Deferred Savings Plan for Union Hourly Employees, Peoria, Illinois (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan covers eligible union hourly employees of the Peoria plant of Komatsu America Corp. (the Company).

Administration

The Company, along with its subsidiary, Komatsu Mining Corp. (collectively, the Companies), established the Komatsu Plan Sponsor Committee to act on behalf of the Companies as plan sponsor to the employee benefit plans maintained by the Companies, including the Plan. In addition, the Companies established the Komatsu Pension and Investment Committee (the Committee) to serve as the plan administrator for their employee benefit plans. Fidelity Management Trust Company (the Trustee) serves as the trustee of the Plan, while Fidelity Investments, an affiliate of the Trustee, serves as the recordkeeper of the Plan.

Contributions

Participants may elect to defer a portion of their earnings by contributing a percentage or a flat dollar amount of their eligible compensation to the Plan. Contributions may be designated as pre-tax or as Roth deferral. A participant may change his or her contribution as of the beginning of each payroll period. For any plan year, the maximum contribution shall be 50% of a participant's compensation, subject to certain limitations under the Internal Revenue Code (IRC). Participants over the age of 50 by the end of the calendar year are permitted to defer an additional amount in excess to the otherwise applicable limit in pre-tax contributions. In certain situations, participants may make rollover contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. There are no employer contributions made to the Plan.

Participant Accounts

Separate benefit accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, rollovers and an allocation of investment earnings or losses based on the investment funds selected and charged with an allocation of administrative expenses and any specific participant transactions such as loans, distributions, and the related transaction expenses. Allocations are made to participants' accounts based on the proportion that each participant's balance bears to the total of all participant account balances within each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their contributions and earnings thereon.

Payment of Benefits

Upon retirement, death, disability, or termination of service, a participant may elect to receive a lump-sum distribution of the full value of his or her account balance. In addition, hardship distributions are permitted if certain criteria are met, as defined by plan document. Automatic distribution commences when the participant turns age 73 or when the participant terminates employment.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Notes Receivable from Participants

A participant may borrow an amount equal to the lesser of \$50,000 or 50% of their vested account balance from the Plan. The minimum loan amount is \$1,000. Loans are secured by the balance of the participant's account and are repaid through payroll deductions over periods ranging up to 60 months, or up to 120 months for loans used for the purchase of a primary residence. The loans bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator and are fixed over the life of the note. Loans are granted in accordance with the terms set forth in the plan document.

Recent Regulatory Pronouncements

The SECURE 2.0 Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management is evaluating the optional SECURE 2.0 provisions. The application of SECURE 2.0 did not have a material effect on the Plan's financial statements. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company pays substantially all administrative fees associated with the Plan. Certain participant transaction charges are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as benefit payments based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplementary schedule Form 5500, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from the information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund - Valued at the published market price, which is a constant net asset value (NAV) of \$1 per unit.

Registered investment companies - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Valued at the NAV of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from that trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Self-directed brokerage accounts - Include common stock and mutual funds and are valued at the quoted market price of the respective security held within the accounts. All securities within the accounts are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Parties in Interest

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Tax Status of the Plan

The Plan has adopted a Fidelity Pre-Approved Defined Contribution Plan (Fidelity Plan). The Fidelity Plan received its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Fidelity Plan, as then designed, was in compliance with the applicable requirements of the IRC; therefore, the Plan is in compliance.

The Fidelity Plan has been amended since receiving its latest opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the financial statement dates.

U.S. GAAP requires management of the Plan to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan provides for various investment securities that, in general, are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan held three investments with significant concentration as a percentage of net assets available for benefits totaling \$7,241,984 and \$7,262,013, respectively.

8. Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.
