INDEPENDENT AUDITOR'S REPORT

Employers Deferred Compensation Plan for Covered Employees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Liquor and Wine Sales Representatives, Warehouse, Clerical, Distillery, Rectifying, Tire, Plastic and Allied Workers Union, Local No. 3 Employers Deferred Compensation Plan for Covered Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.





Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.


Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the



participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.



Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Liquor and Wine Sales Representatives, Warehouse, Clerical, Distillery, Rectifying, Tire, Plastic and Allied Workers Union, Local No. 3 Employers Deferred Compensation Plan for Covered Employees (the Plan) maintains its financial records and files its annual reports with the Department of Labor (DOL) on the modified cash basis of accounting. Except for assets arising from cash transactions, for the recognition of appreciation in fair value of investments, and the accrual of certain operating expenses, revenue is recognized when received rather than when earned and expenses are recognized when paid rather than when incurred.

The Plan's investment in the Voya Fixed Account and Voya Fixed Account A are a collective investment fund that holds investment contracts that are fully benefit-responsive and are reported at contract value.

Investment Valuation - Investments are reported at fair value (except for the investment in Voya Fixed Account which is a fully benefit-responsive investment contract, reported at contract value). The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price).

Investment Income Recognition - Dividends, interest, realized and unrealized gains and losses and investment expenses paid are included in net appreciation in fair value of investments in the statements of changes in net assets available for benefits (modified cash basis). Interest and dividend income on participant loans and investments are recorded when received.

Participant Loans - Participant loans are valued at the unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits - Benefits are recorded when paid to the participant or beneficiary. All benefit payments are disbursed by Voya Retirement Insurance and Annuity Company.



NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates - The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from those estimates.

NOTE 2. PLAN DESCRIPTION

General - The Plan was established effective January 1, 1999. Employer contributions were effective when collective bargaining agreements were signed for the Local 3 Clerical Pension, Local 3 Warehouse Pension and Local 3 Sales Pension funds, which was retroactive to 1998. Participants were allowed to make deferrals into this Plan effective April 1, 1999. This Plan was established to provide savings and retirement benefits for eligible employees. The Plan, financed by required contributions of the employer, voluntary contributions of the participants and by the net investment earnings of the Plan, covers all employees who have at least one year of service. The Plan is a multiemployer defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Participants may elect to contribute an amount between 1% and 15% of their compensation. Employers contribute 3% of eligible participant compensation.

Participant Accounts - Each participant account is credited with the participant's contributions, employer's contribution, rollovers from eligible deferred compensation plans and plan earnings. Any distributions, fees or expenses are charged against the participant's account. The balance remaining is the amount a participant is entitled to at the time of distribution.

The Plan allows participants to borrow against their vested interest in accordance with Internal Revenue Service (IRS) guidelines with interest being charged at the prevailing market rate. Loans are secured by the balance in the account.

Participants are fully vested in their accounts as of the first day on which they participate in the Plan.

Participants may amend their investment direction at any time in accordance with the investment contract provisions.

Contributions to the Plan are invested as directed by the participant in various investment funds. Participants must evaluate their own investment goals and objectives and choose the investment funds best suited to achieve those goals and objectives. Poor investment performance by the investment funds selected by the participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Payment of Benefits - Upon termination, retirement, disability, death, or unforeseen emergency, a participant or the designated beneficiary will receive a one-time, lump-sum payment equal to the value of the participant's account balance or the amount of benefit requested.



NOTE 2. PLAN DESCRIPTION (CONTINUED)

Participant Loans - Loans made are limited to the lesser of:

1. \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans from the Plan to the participant during the one year period ending on the day before the date on which such loan is made, over the outstanding balance of loans from the Plan to the participant on the date on which such loan was made, or
2. One-half (1/2) of the participant's vested interest in the Plan.

During the year ended December 31, 2020, the Plan did allow for participants to utilize the aid from the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act). This act provided for Coronavirus-related distributions, increases in loan limits, loan payment suspensions, and changes to the required minimum distribution administration.

Effective January 1, 2023, this Plan shall be administered in a manner to satisfy the Section 401(k)(12) safe harbor requirements.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

NOTE 3. PRIORITIES UPON TERMINATION

Although they have not expressed any intent to do so, the Board of Trustees have the right to terminate the Plan subject to the provisions of ERISA. Benefits would be distributed to the participants and their beneficiaries as if the Plan had not been terminated.

NOTE 4. TAX STATUS

The IRS has issued a determination letter dated August 4, 2015 indicating that the Plan, as designed, is a qualified plan under Internal Revenue Code Sections 410(b) and 401(a)(4) and therefore not subject to tax.

The Plan accounts for income taxes in accordance with the Accounting Standards Codification (ASC) Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of uncertain tax positions taken or expected to be taken in a tax return.

The Plan performed an evaluation of uncertain tax positions for the years ended December 31, 2024 and 2023, and determined that there were no matters that would require recognition in the financial statements or that might have an effect on its tax-exempt status. As of December 31, 2024, the statute of limitations for tax years 2021 through 2023 remains open with the IRS.



NOTE 5. INVESTMENTS

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by Voya Life Insurance and Annuity Company, the Trustee, as of December 31, 2024 and 2023, and for the years then ended.

The Plan's Trustee has certified its statement of accounts as of December 31, 2024 and 2023, and for the years then ended. The statement of accounts includes beginning and ending balances of investments held, contributions received, and detail of all transactions during the period, including investment income.

NOTE 6. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.



NOTE 6. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement levels within the fair value hierarchy are based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at fair value as determined by the price of the underlying assets.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Voya Life Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the statements of net assets available for benefits (modified cash basis) at contract value as reported to the Plan by Voya.

As described in Note 1, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract value of the investment contract at December 31, 2024 and 2023 was \$72,087,845 and \$71,766,135, respectively. The average yield and crediting interest rate was 3% for 2024 and 2023. The crediting interest rate is based upon a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Voya. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without the consent of the issuer.



NOTE 8. NET ASSETS AVAILABLE FOR BENEFITS

Each employer of the Plan remits an administrative fee of \$5.00 per month per participant to the Plan. Voya holds these amounts in reserve in a non-allocated account to cover administrative expenses. The composition of the allocated and non-allocated net assets available for benefits is as follows:

NOTE 9. RELATED ORGANIZATIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has four related entities including a local union, two health and welfare funds, and three pension plans. All entities are tax-exempt organizations. The financial activities of these organizations are not included in the accompanying financial statements.

The Plan has common trustees and shares office facilities and staff with the Liquor and Wine Sales Representatives, Warehousemen, Clerical, Distillery, Rectifying, Tire, Plastic and Allied Workers Union Local 3 Independent and the following Local 3 Fringe Benefit Funds:

- Local 3 Tire and Plastic Division Pension Fund;
- Liquor and Allied Workers' Union Local No. 3 Health and Welfare Fund - Sales Division;
- Liquor and Allied Workers' Union Local 3 Pension Fund - Sales Representatives Division (Sales Pension Fund); and
- Liquor and Allied Workers' Union Local No. 3 Pension Fund (Warehouse Pension Fund).

Certain administrative expenses were paid for by one or more of the above-related parties in 2014. In late 2014, the Plan started to reimburse the Liquor and Allied Workers' Union Local No. 3 Pension Fund - Sales Representatives Division (Sales Pension Fund) for administrative services provided to the Plan. The amount reimbursed was \$234,967 and \$249,916 for the years ended December 31, 2024 and 2023, respectively. The Plan collectively owes \$20,660 and \$18,967 at December 31, 2024 and 2023, respectively.

These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.



NOTE 9. RELATED ORGANIZATIONS AND PARTY-IN-INTEREST TRANSACTIONS (CONTINUED)

Participant loans and certain Plan investments are shares of registered investment companies managed by Voya. Voya is the Trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$169,932 and \$182,072 for the years ended December 31, 2024 and 2023, respectively. These fees are included in administrative fees.

NOTE 10. ADMINISTRATIVE FEE INCOME

Two employers reimburse the Plan for administrative fees based on the number of participants. For the years ended December 31, 2024 and 2023, the Plan was reimbursed \$187,883 and \$203,233, respectively.

NOTE 11. SIGNIFICANT UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

NOTE 12. SUBSEQUENT EVENTS REVIEW

Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
