To the Participants and Plan Administrator
Beekman 1802, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Beekman 1802, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Beekman 1802, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General Information

The Plan is a defined contribution plan covering substantially all employees of Beekman 1802, Inc. (the “Company”) who have attained six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security act of 1974 (ERISA), as amended.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (IRC). Participants may make voluntary pretax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has a safe harbor matching contribution of 100% of the first 3% of eligible compensation that a participant contributes to the Plan, plus 50% of the next 2% of eligible compensation that a participant contributes to the Plan. The Company may also make a discretionary non-elective contribution, as defined by the Plan. Participants must be employed on the last working day of a Plan year and work at least 1,000 hours during that Plan year to be eligible for an allocation of the discretionary non-elective contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s safe harbor matching contributions, as well as allocations of the Company’s discretionary non-elective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. Participants are 100% vested in the discretionary non-elective contributions after three years of service. In addition, a participant’s account balance will become fully vested upon death, disability or retirement while employed by the Company, regardless of years of service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, not to exceed 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%, which is commensurate with local prevailing rates as determined monthly. The rate of interest remains constant throughout the term of the loan. Principal and interest is paid ratably through payroll deductions.

Effective November 7, 2023, the Plan was amended to eliminate future participant loans.

Payment of Benefits

The Plan allows benefits to be distributed as lump sum payments, partial payments or distributions in-kind. Benefits are distributed under the Plan based on normal retirement date, disability, death or termination of employment of the participant. In-service withdrawals are available to participants who have obtained age 59½ or who have met certain hardship requirements, as outlined by the Internal Revenue Service (IRS). Participants who terminate employment shall be eligible for a distribution as soon as administratively feasible following the participants termination date. Termination distributions of account balances greater than \$5,000 may be deferred to a later date.

Forfeitures

There were \$43 and \$262 of unapplied forfeited non-vested balances at December 31, 2024 and 2023, respectively. When there are forfeitures available, they may be used to reduce administrative expenses, restore forfeited account balances or to reduce employer contributions. There were forfeitures of \$467 used during the year ended December 31, 2024 to reduce employer contributions.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Payment of Benefits

Benefits are recognized when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees for the administration of notes receivable from participants and benefits paid to participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Reclassifications

Certain items were reclassified in the 2023 financial statements to conform to the 2024 presentation.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to include an automatic enrollment provision, whereby, all newly eligible participants will be automatically enrolled in the Plan, unless they affirmatively elect not to participate. Participants will be auto-enrolled at 3% of eligible compensation.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price.
- **Pooled Separate Account:** Represent an investment in participation units held in pooled separate accounts through sub accounts of an insurance company. The pooled separate account is primarily invested in mutual funds listed on the national securities exchanges and are valued daily at the unit value of shares held by the Plan in the separate investment account based on the underlying mutual funds and their quoted net asset value (NAV), which is an observable input. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company, denotes readily determinable fair value.
- **Collective Investment Trusts (CIT):** Valued at the NAV of units of the collective trust. Due to the various unique investments that may be allowed in a collective trust, and the various redemption restrictions that may be imposed, the CIT funds are valued at NAV, as provided by the trustee, as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the fund less its liabilities. As of December 31, 2024, there were no redemption restrictions.

NOTE 4 — INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certification are as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and includes investment information related to fair value of investments, notes receivable from participants, net appreciation in fair value of investments and interest income on notes receivable from participants that are included in the Plan's financial statements and supplemental schedule.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal Trust Company, the trustee, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

Notes receivable from participants qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules of ERISA.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested.

NOTE 7 — TAX STATUS

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the volume submitter profit sharing plan adopted by the Plan and related trust, as then designed, are in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
