Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP,

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### Other Matter – Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

The following description of GBMH Retirement Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution pension plan covering substantially all employees of Grant-Blackford Mental Health, Inc. (Plan sponsor). Employees age 18 or older are eligible to participate after completing 3 months of service as defined by the Plan. Entry date to the Plan is the first day of the calendar month after the requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

The Plan allows employee elective deferrals, including Roth contributions, catch up contributions and rollover contributions. Auto enrollment and deferral for participants joining after January 1, 2023 is at 1% increasing an additional 1% annually on the first day of each plan year. Auto enrollments are pre-tax. The Plan sponsor matches 100% of the first 2% of employee elective deferrals including Roth and catch up contributions. Additionally, a non-elective discretionary contribution of 3% of eligible compensation was made by the Plan sponsor in 2024.

#### Participant's Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the allocation of the Plan sponsor's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocation of Plan sponsor's contributions is based on participant wages as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Compensation

Participant compensation is as W-2 wages including IRC Section 125 compensation.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of the fair market value of their vested account balance built up from employer contributions and eligible rollover contributions. The loans are secured by the balance in the participant's account and bear interest at a rate reasonable at the time of application. Principal and interest are paid in equal installments, not less frequently than quarterly. As of December 31, 2024 and 2023, outstanding loans approximated \$11,000 and \$20,000, respectively. The loans bear interest at rates ranging 4.25% - 6.50% and mature at various dates through 2027.

### Vesting and Forfeitures

The Plan provides that the participant's account in salary reduction contributions are fully vested immediately at the participant's effective date of participation. The Plan also provides that the participant's account in the employer matching contribution and the non-elective contribution vests at 20% per year and is fully vested at the end of five years of vesting service or earlier upon attainment of retirement age, upon retirement due to disability, upon death or upon termination of the Plan.

After termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce the Plan sponsor's contributions. As of December 31, 2024 and 2023, available forfeitures totaling approximately \$3,900 and \$2,000, respectively, were available to reduce the Plan sponsor's contributions. During 2024, no forfeitures were used.

### Payment of Benefits

On termination of service due to death, disability or retirement, a vested participant may receive a lump-sum distribution, an installment or an annuity equal to the value of their account.

### Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in unrealized appreciation of investments are reflected in the statements of changes in net assets available for benefits in the year in which such changes occur.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varied investment objectives. Participants should refer to the custodian for a more complete description of the investment objectives.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan sponsor and generally include audit and legal fees. The expenses paid by the Plan sponsor are excluded from these financial statements. Administrative expenses incurred by the Plan generally include certain administrative fees charged directly to the participants' accounts. Investment related expenses are included in net change in fair value of investments.

#### Income Taxes

The Plan has adopted a pre-approved plan document sponsored by Leon E. Wertz & Associates, Inc., the parent company of Innovative Pension Consulting – A Division of Momenta, Inc., which has received an opinion letter from the Internal Revenue Service (IRS) dated December 10, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan has filed its tax returns for years through December 31, 2023. These tax returns are generally open to examination by the relevant taxing authorities for a period of three years from the later of the date the return was filed or its due date (including approved extensions).

#### Subsequent Events

The Plan evaluated events or transactions occurring subsequent to statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued which was October 10, 2025.

#### 3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets as of December 31, 2024, and investment related activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

#### 4. FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

##### Investments Measured Using the Net Asset Value (NAV) per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

#### 5. PLAN TERMINATION

The Plan sponsor reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no change will decrease the vested benefits already earned by the participants, except as may be required by the IRS for its continuing approval of the Plan.

#### 6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan sponsor and certain others. As of December 31, 2024, the Plan's investments are held by John Hancock, the custodian of the Plan. Edward D. Jones & Co., LP and Wilshire Associates, Inc. are the registered investment advisors for the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to approximately \$24,000 and \$20,000 for 2024 and 2023, respectively.

Blue & Co., LLC is the independent auditor for the Plan and receives payment for those services. The third party administrator (TPA) of the Plan is Momenta-IPCA, who receives payment for TPA services. The Plan sponsor pays certain expenses of the Plan, including accounting fees and certain TPA fees. These expenses qualify as party-in-interest transactions. Certain members of management of the Plan sponsor are named trustees of the Plan. Also, notes receivable from participants qualify as party-in-interest transactions.

#### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term that such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
