Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of OYO Hotel and Casino 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the OYO Hotel and Casino 401(k) Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

1. Description Of The Plan

The following description of the OYO Hotel and Casino 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 1994. The Plan is a defined contribution plan covering substantially all employees of Paragon Tropicana, Inc. dba OYO Hotel and Casino Las Vegas (the Employer or Plan Sponsor), as defined below. The Employer is the sponsor of the Plan. The Plan was most recently restated and amended August 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian And Administrator Of The Plan

Standard Retirement Services, Inc. (Standard Retirement or Recordkeeper) serves as recordkeeper for the Plan. Standard Insurance Company (the Standard or Custodian) holds all assets of the Plan in accordance with the provisions of the custodial agreement and service provider contract with the Plan Sponsor. The Standard is the third-party administrator of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees, excluding residents of Puerto Rico and non-resident aliens who have a minimum of three months of service and are at least 21 years of age are eligible to participate in the Plan. An eligible participant can enter the Plan the first day of January or July coinciding with or following the date they become eligible.

Contributions

Each year, participants may contribute up to the full amount of their annual pre-tax compensation up to the maximum amount allowed by law. Effective August 1, 2023, the Plan also allows Roth contributions. Participants who have attained the age of 50 before the close of the Plan year may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Salary deferral agreements shall be made, terminated or changed according to procedures and limitations set up by the Plan administrator and the Plan Document.

OYO HOTEL AND CASINO 401(k) PLAN

Notes To Financial Statements (*Continued*)

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer, at its discretion, may make matching and/or profit-sharing contributions to the Plan. All participants employed at the end of the year are eligible for the discretionary matching and/or profit-sharing contributions. Participants not employed at the end of the year are eligible if the participant has completed more than 500 hours of service or have retired (early or normal retirement age of 55 or 65, respectively), were disabled or died during the plan year. During 2024, there were no discretionary employer matching or profit-sharing contributions. Contributions are subject to certain limitations of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account includes the participant's elective deferral, the Company's contribution, rollovers deposited from qualified participant accounts, and an allocation of Plan earnings or losses and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, the value of the account balances or specific participant transactions, as defined in the Plan Document. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and allocated Plan earnings thereon. Vesting for the Employer's matching and profit-sharing contributions is based on periods of service as follows:

Payment Of Benefits

On termination of service, participants with vested benefits of \$5,000 or less will receive a single lump-sum cash payment of benefits or roll over their vested interest into another qualified plan or individual retirement account (IRA), and those participants with vested benefits exceeding \$5,000 have the option of receiving a single lump-sum, roll over their vested interest into another qualified plan or IRA or deferral of this distribution until normal retirement age. Partial cash payments or installments are permitted for participants or beneficiaries who must receive required minimum distributions. On termination of employment prior to retirement, other than a result of death or disability, participants forfeit their non-vested balances. Prior to termination, participants may receive a hardship from their pre-tax deferral account or in-service distribution for participants who have obtained age 59½ from their vested account, under certain circumstances.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. Notes are secured by the balance in the participant's account and bear interest at the prime rate or at local prevailing rates as determined by the Plan Administrator, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Each participant may not have more than one loan outstanding at any time.

Administrative Expenses

The Employer pays a portion of administrative expenses incurred by the Plan. Other administrative expenses are paid by the Plan.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received in an asset sale or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment contracts held by a defined contribution plan that are fully benefit-responsive investment contracts are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Invesco Stable Value Fund is a fully benefit-responsive investment contract and is reported at contract value in the Statement Of Net Assets Available For Benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions Receivable And Credit Loss Policy

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule of assets held at end of year that was prepared by or derived from information certified by the Standard, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Standard that the information provided to the Plan Administrator related to the following information is complete and accurate to the best of their knowledge and belief.

4. Fair Value Measurements

The Plan follows current accounting standards, which establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts (PSA)

Valued at the net asset value (NAV) as a practical expedient of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. PSA are comprised, primarily, of shares of mutual funds that are traded on an active market. PSA may be redeemed by participants daily at NAV. For the years ended December 31, 2024 and 2023, the Plan had no unfunded purchase commitments or redemption restrictions. Investments that are measured at NAV as a practical expedient have not been categorized in the fair value hierarchy.

There have been no changes in the valuation methodology used at December 31, 2024 or 2023.

6. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Standard Retirement Services. Standard Retirement Services received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan, in its entirety, at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

8. Party In Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Standard or their subsidiaries and affiliates. Participant loan, distribution, and recordkeeping processing fees are paid to the Standard by participants. The Plan paid for third-party administrator fees and investment advisory fees which qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

9. Risk And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. It is at least reasonably possible, given the level of risk associated with investment securities that changes in the values of investment securities in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

10. Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive investment contract with Standard Insurance Company (Standard) through the Stable Value Fund A. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is fully benefit-responsive, therefore contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract.

Stable Value Fund A investment choice seeks to provide a safe investment by establishing a rate, or rates, for monies invested in the general account. This rate, or rates, may change periodically. The general account assets are invested in the general assets of Standard and are predominately fixed income investments (bonds, mortgages, private placements) of high quality. All benefit payments prior to contract liquidation are made at book value (principal invested plus interest earned).
