For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.



Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

We were not engaged to audit, review, or apply any procedures to the 2023 financial statements, and accordingly, we do not express an opinion or any other form of assurance on the 2023 financial statements as a whole.

1. Description of the Plan

The following description of the Spectralink Corporation 401(k) Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established effective February 1, 2013. The Plan was adopted by Spectralink Corporation (the “Company”) for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits payable under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation. Participants and others should refer to the Plan document for a more complete description of the Plan’s provisions.

Eligibility

Eligible employees, which exclude collectively bargained employees and non-resident aliens, as defined by the Plan document, are automatically enrolled in the Plan on the first day of the month following the attainment of age 21 and 60 days of service, as defined in the Plan document. The auto enrollment is set to withhold 6% of eligible compensation.

Contributions

Participants may elect to contribute up to 100% of their annual compensation to the Plan through regular payroll deductions (“Basic”). Annual participant contributions are limited by the Internal Revenue Service (“IRS”) to \$23,000 and \$22,500 for calendar year 2024 and 2023, respectively. In addition, eligible employees age 50 or over may contribute “catch-up” contributions of \$7,500 in both 2024 and 2023. Participants may elect to make rollover contributions (“Rollover”) to the Plan from a previous employer’s qualified retirement plan or from a “conduit” investment retirement account.

The Company has the option to make discretionary matching contributions to the Plan on behalf of the participants. For 2024 and 2023, the Company made a discretionary matching contribution of 50% of the first 4% of the participant contributions.

Participant Accounts

Each participant account is credited with the participant’s contributions, the Company’s matching contributions, and the participant’s plan earnings and losses. Each participant has the choice of investing his/her basic, rollover, and employer contribution account balance into any combination of 27 registered investment companies and 1 investment contract with an insurance company in 2024 and 2023. Participants may change investment fund elections and transfer their existing balances between any of the funds on a daily basis. Investment income or losses for each investment fund are allocated to each participant’s account balance in proportion to the value of his/her interest relative to the total interest of all participants in such fund at the time the income or loss is earned.

Vesting

Participants are immediately fully vested in their contributions and any employer contributions, including any earnings related to those contributions.

1. Description of the Plan (continued)

Payment of Benefits

Upon a participant's retirement or disability, the value of his/her vested account may be paid as a lump sum. A participant's vested account balance in excess of \$5,000 will be paid only upon the written consent of the participant. An account balance between \$1,000 and \$5,000 will be distributed as a direct rollover to the Plan's designated individual retirement plan, and an account balance of \$1,000 or less will be distributed directly to the participant. In the event of the death of a participant, his/her beneficiary may elect to receive payment in the form of a lump sum, required minimum distributions, defer receipt for up to 5 years or, if the participant's beneficiary is his or her spouse, defer payment until the last day of the year in which the participant would have attained age 65.

Withdrawals

Upon submission of a written request to the plan administrator, and attainment of age 59½, a participant may withdraw from his/her account all or any portion of their vested account balance. The Plan also provides for hardship withdrawals upon a participant's written request to the plan administrator for the withdrawal of all or any portion of his/her vested account, provided all other forms of financial assistance have been explored and exhausted, including participant loans, and certain criteria are met.

Notes Receivable from Participants

The Plan allows participants to obtain loans against their accounts, subject to certain restrictions and limitations. The maximum amount a participant may borrow is limited to the lesser of \$50,000 or 50% of his/her vested account balance. The minimum amount that can be borrowed as a loan is \$1,000. Loans bear interest equivalent to the prime lending rate plus 1% and must be paid at least on a quarterly basis, and repaid generally within five years, except for the purchase of a primary residence. The interest rate charged on participant loans ranged from 4.25% to 9.5% at December 31, 2024.

Administrative Expenses

Most administrative expenses of the Plan, including custodian and recordkeeping fees, are paid by the Plan. Loan processing and transfer redemption fees are paid by the applicable participants' accounts. For the year ended December 31, 2024, administration expenses totaled \$29,310.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan has prepared its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at quoted market value on the last business day of the plan year. Net appreciation or depreciation in fair value of investments as reflected in the statement of changes in net assets available for benefits consists of unrealized appreciation or depreciation of investments held during the year and the realized gain or losses on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded when earned, and dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

3. Investment Contracts with an Insurance Company

In 2020, the Plan entered into a fully-benefit-responsive investment contract with an insurance company. The insurance company maintains the contributions in a general account that is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract is fully-benefit-responsive, and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are set on a quarterly basis. The crediting interest rates were 3.10% and 2.95% at December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Section 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 from those used in the prior year.

Investments in registered investment companies: Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Information Prepared and Certified by Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information has been certified by Ascensus Trust Company as being complete and accurate, and the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule:

- Investments held as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- The schedule of assets (held at end of year) as of December 31, 2024, as shown on the supplemental schedule

6. Federal Income Tax Status

Effective October 2020, the Company adopted a pre-approved defined contribution prototype plan and trust, which received a favorable opinion letter from the IRS on June 30, 2020. The Plan has been amended since receiving the determination letter. While the Company is not required to file for a separate IRS opinion letter for the Plan, the Plan management believes that the Plan is currently designed and being operated in compliance with the applicable sections of the Internal Revenue Code.

6. Federal Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
