A. Description of Plan

The following description of the J. H. Fletcher & Co. (the "Company") Employees' Profit Sharing Plan (the "Profit Sharing Plan" or the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Merger – On October 29, 2019, the Company approved the merger of the J. H. Fletcher & Co. Employees' 401(k) Plan (the "401(k) Plan") into the Profit Sharing Plan, effective November 1, 2019. As a result, all investments were transferred from the 401(k) Plan into the Profit Sharing Plan. Transferred net assets of \$10,575,850 were recognized in the accounts of the Profit Sharing Plan at the balances previously carried in the accounts of the 401(k) Plan.

General – The Plan is a defined contribution plan covering substantially all employees of the Company. Established in 1955, the Plan provides benefits upon retirement, disability, death, or termination for other reasons. Effective October 1, 2019, all full-time employees of the Company who have completed three consecutive months of service and are age eighteen or older, may elect to defer from their compensation up to the maximum percentage allowed under the limits of Code Sections 401(k), 402(g), 404, and 415. Employees that are covered by a collective bargaining agreement or are providing services to the Company through a referral from a temporary employment service and compensated by the temporary employer are not eligible to participate even if they satisfy the eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Company may contribute a share of profit each year at the discretion of the directors. The amount contributed for a Plan year, if any, shall be between five percent (5%) and fifteen percent (15%) of the gross compensation paid during the plan year. For the years ended December 31, 2024 and 2023, the directors elected to contribute 15%. Effective October 1, 2019, participants may contribute a portion of their salary into the Plan on a pretax basis. Participants may also contribute amounts representing rollover distributions from other qualified plans.

Participant Accounts – Each participant's profit sharing account is credited with an allocation of the Company's contribution and Plan earnings. Allocations are based on the ratio of each participant's compensation to the total compensation for all participants. Funds that have been allocated and applied to purchase insurance contracts are excluded from Plan assets. Each participant's deferral account is credited with the participant's contribution and an allocation of Plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Vesting in the Company's contributions and earnings is based on years of service. A participant is 100% vested after six years of credited service. Participants are immediately vested in their contributions plus actual earnings thereon.

Notes Receivable from Participants – Participants may borrow from their profit sharing accounts at the discretion of the Plan Advisory Committee. Loans are limited to the lesser of \$50,000 or one-half of the participant's vested balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates which represent prime at the date of the loan plus approximately 0.25% to 0.50%.

Payment of Benefits – On termination of service due to retirement, the normal form of benefit payment is the value of a participant's account in a lump-sum amount. However, for profit sharing accounts only, participants may elect periodic payments of equal amounts for a specified number of years not to exceed the participant's life expectancy or the life expectancies of the participant and his or her beneficiary or by the purchase of an annuity contract. For termination of service for other reasons, participants with salary deferral accounts may receive the value of the vested interest in his or her account as a lump-sum distribution during the Plan year that termination has occurred; or, for profit sharing accounts of more than \$10,000, in four annual installments beginning as soon as administratively possible.

Forfeited Accounts – For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$201,694 and \$177,251, respectively. Forfeited non-vested accounts shall be used to reduce the Company's contributions or to pay administrative expenses. The amount of forfeitures used to reduce contributions or pay administrative expenses was \$0 in both 2024 and 2023.

B. Summary of Significant Accounting Policies

Date of Management's Review – Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting – The financial statements have been prepared using the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation – Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Income Recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Administrative Expenses – Substantially all expenses of the Plan are absorbed by the Plan.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Reclassifications – Certain reclassifications have been made to prior year's financial statements to place them on a basis comparable with the current year.

D. Fair Value Measurements

The Plan has adopted the provisions of Fair Value Measurements, Topic 820 of the Financial Accounting Standards Board—Accounting Standards Codification. This topic requires disclosures about fair value measurements in financial statements based on hierarchical levels directly related to the amount of subjectivity associated with the inputs used to determine the fair value of financial instruments. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels.

The inputs or methodologies used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

Level 1 – Quoted prices in active markets for assets identical to the securities to be valued. If a Level 1 input is available, it must be used.

Level 2 – Inputs other than quoted prices that are observable for securities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.

Corporate obligations and U.S. Government securities – valued based on pricing provided by an independent pricing vendor, broker/dealer, or model-based technique for which the inputs for the valuation are based upon readily observable pricing information.

Pooled separate accounts – valued using the net asset value of units, as determined by the insurance company. Net asset value is a readily determinable fair value and is the basis for current transactions.

F. Parties-in-Interest

Certain Plan assets are in investment funds managed by John Hancock Life Insurance Company. John Hancock is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. At December 31, 2024 and 2023, funds of \$58,111,780 and \$12,163,570, respectively, were held in such investments.

The Plan also engages in transactions with parties-in-interest during the normal course of operations. Amounts expensed for services provided by parties-in-interest are found under advisory fees and other professional fees in the statement of changes in net assets available for benefits.

G. Group Annuity Contract with John Hancock Life Insurance Company

In 2019, the Plan entered into guaranteed investment contract ("GIC") that is a group annuity contract, backed by the assets of the general account of John Hancock Life Insurance Company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the financial statements at fair value as reported to the Plan by John Hancock Life Insurance Company.

In general, fully benefit responsive contracts require participant-initiated transaction to occur at contract value with no conditions, limitations, or restrictions. In the John Hancock Life Insurance Company group annuity contract, inter-account transfers from guaranteed interest accounts may be subject to a market value adjustment and inter-account transfers from certain subaccounts may be subject to a redemption fee. Since the group annuity contract restricts certain transfers and withdrawals, the Plan does not consider it to be fully benefit responsive.

H. Tax Status

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

I. Plan Termination

While it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

K. Subsequent Event

Effective January 1, 2025, the Company amended the trust known as the J. H. Fletcher & Co. Employees' Profit Sharing Plan and will provide an Employer Safe Harbor Contribution of 3% of employee eligible compensation that is 100% vested. This contribution may not be distributed except under the terms of the Plan that apply to salary deferrals generally after death, disability, retirement, or termination of employment.
