## NOTES TO FINANCIAL STATEMENTS

### NOTE 1—DESCRIPTION OF PLAN

The following description of Pittsburgh Logistics Systems, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – Effective October 1, 2007, Pittsburgh Logistics, Inc., PLS International, Inc., and eflatbed.com, Inc. transferred their assets to a newly created plan, Pittsburgh Logistics Systems, Inc. 401(k) Plan. The Plan covers the employees of Pittsburgh Logistics, Inc., PLS International, Inc., and eflatbed.com, Inc., all of whom are related through common ownership (hereinafter referred to collectively as the “Company”). The Plan is a defined contribution plan covering all full-time employees of the Company who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator manages the operations and administration of the Plan.

**Contributions** – Participants may elect to contribute up to the maximum percentage of eligible compensation as defined by the Plan agreement, subject to IRS dollar limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers); after-tax rollover contributions are permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically-enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Additional employer contributions, up to a maximum of \$1,500, are allowable to be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations as defined in the Plan agreement and as limited by statute. For the year ended, \$290,404 in discretionary contributions were made.

**Participant Accounts** – Each participant’s account is credited with the participant’s elective deferrals and his or her pro rata share of the Company contributions, as well as the related earnings or losses thereon. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment election for future contributions or the percentages invested in each of these options, or transfer funds among these options on any business day. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their voluntary contributions and actual earnings thereon. Company matching and discretionary contributions vest over a five-year vesting schedule based on years of service, as follows:

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. A participant may only have one outstanding loan at a time. The period of payment for participant loans can be a maximum of five years, or longer if for the purchase of a primary residence. Such loans are secured by the balance in the participants' accounts, and each loan bears interest at a rate commensurate with local financial institutions for similar loans at the time the loan is made, as determined by the Plan administrator. Principal and interest are paid at least quarterly, generally through payroll deductions or ACH agreements. As of December 31, 2024, participant loans carried interest rates at 3.25% through 8.50%, with various maturities through 2029.

**Payment of Benefits** – Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or annual installments over 5, 10, or 15-year periods. Hardship distributions may also be granted in accordance with the provisions of the Plan agreement. The plan will automatically distribute balances of terminated participants that are less than \$5,000.

**Forfeited Accounts** – Any portion of a participant's account, which is not vested, is forfeited upon the participant's termination of service. Such forfeitures are used to reduce employer contributions. Forfeitures available for use by the Plan were \$71,596 and \$54,449 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, \$69,930 in forfeitures were used to reduce the Company's contributions and administrative expenses.

**Plan Expenses and Costs** – Certain administrative expenses are paid for by the Company and are excluded from these financial statements, while others are paid for by the Plan. Recordkeeping costs are now being deducted from plan assets.

## NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value, including the stable value fund (a common/collective trust fund), which holds indirect investments in fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as the current year change in unrealized appreciation and depreciation of investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Income Taxes**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA plan document via FMR LLC, which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the related trust is tax-exempt. In accordance with IRS Procedure 2017-41, the Plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is a qualified plan as described in Section 401(a) of the IRC and is therefore exempt from federal and state income taxes. Income generated by activities that would be considered unrelated to the Plan's purpose would be subject to tax which, if incurred, would be recognized as a current expense. No such tax has been recognized as of December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 3—INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The trustee of the Plan has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024 in accordance with DOL Regulation 2520.103-5. Such information includes the composition, cost and current value of all investments held and net notes receivable from participants balances as of December 31, 2024 and 2023, as reported in the statements of net assets available for benefits, and the interest, dividends, and net appreciation (depreciation) in fair value of investments and interest income from notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### NOTE 4—FAIR VALUE MEASUREMENTS (UNAUDITED)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- Quoted Prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Shares of registered investment companies (mutual funds) are reported at fair value based on the quoted market price of the fund which represents the net asset value of the investments held by the fund at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the plan are considered to be actively traded.

*Stable Value Common/Collective Trust Fund:* This fund is valued at net asset value (NAV) of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The fair values of participation units in the stable value fund are based upon the NAV of such fund. It is the Common/Collective Trust's policy to use its best efforts to maintain a stable net asset value of \$1 per unit. At December 31, 2024 and 2023, the trust reported a NAV of \$1. The fund's objective is the safety and preservation of principal and accumulated interest. For liquidity purposes, the fund may have all or a portion of its assets invested in high-quality money market instruments, investment companies, and collective investment trusts that meet the investment objectives. The stable value fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. There were no unfunded commitments at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5—AMENDMENT AND TERMINATION**

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion by written action of the Plan sponsor, to amend the plan, terminate the plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying or otherwise adversely affecting any benefit to a participant that is a “protected benefit” within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company’s contributions.

The Plan was last amended on October 31, 2022 for the Plan’s year-end change from September 30<sup>th</sup> to December 31<sup>st</sup>.

### **NOTE 6—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Certain funds of the Plan are invested in mutual funds managed by Fidelity Investment Company, who is the trustee as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than a direct payment.

Notes receivable from Plan participants qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

During the year ended December 31, 2024, administrative fees of \$103,073 were paid by the Plan to the trustee. The Plan sponsor also pays certain fees and expenses of the Plan.

### **NOTE 8—SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor’s report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
