## Independent Auditor's Report

Plan Administrator and Board of Trustees  
Pella Regional Health Center 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pella Regional Health Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

#### Note 1. Description of Plan

The following description of the Pella Regional Health Center 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan covering all employees of Pella Regional Health Center (Health Center) who are age 18 or older. Employees may enter the Plan for the purpose of making salary deferral contributions immediately upon satisfying the Plan's eligibility requirements. The Board of Trustees of the Health Center is responsible for oversight of the Plan. The Governance and Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 90% of pre-tax annual compensation as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation unless they affirmatively elect otherwise. Also, participants who have deferral rates less than 10% will have their deferral rates increased annually by 1% until their rate reaches 10% unless they affirmatively elect otherwise.

The Health Center provides a matching contribution equal to 50% of participant deferral contributions up to a maximum of 4% of eligible compensation for all participants hired or rehired on or after March 1, 2021. The Health Center also provides a fixed contribution for employees hired or rehired on or after March 1, 2021, based on years of service. The fixed contribution is equal to 1% of a participant's eligible wages after two years of service and then increases 1% per year of service up to 4% after five years of service. The Health Center also provides a fixed contribution for participants hired prior to March 1, 2021, equal to 6% of eligible compensation. Participants must work 1,000 hours and be employed on the last day of the Plan year in order to receive the fixed employer contribution, unless they terminate due to death, disability or retirement. The employer nonelective contribution made for the year ended December 31, 2024, was \$2,228,110.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Health Center's matching and fixed contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Participants direct the investment of their contributions and any Health Center contributions into various investments offered by the Plan. Participants may change their investment options at any time.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Health Center matching and fixed contributions plus actual earnings thereon are based on a three-year cliff schedule whereby participants are 100% vested after three years of service. Separate vesting schedules apply to balances merged in from the Pella Regional Health Center Money Purchase Plan, as defined in the Plan document.

#### Note 1. Description of Plan (Continued)

**Forfeitures:** Forfeitures can be used to offset Plan expenses or fund future employer contributions. Forfeitures included in net assets available for benefits as of December 31, 2024 and 2023, were \$7,990 and \$2,836, respectively. Forfeitures of \$152,750 were used to partially fund employer contributions during the year ended December 31, 2024.

**Notes receivable from participants:** Participant can borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates based on the USA Today's published prime rate. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan are used to acquire the participant's residence, in which case the loan would be 10 years. A participant can have no more than two outstanding loans at any one time. Notes receivable outstanding as of December 31, 2024, mature through December 2029 and bear interest at rates ranging from 3.25% to 8.50%. Notes receivable outstanding as of December 31, 2023 bore interest at rates ranging from 3.25% to 8.50%.

**Payment of benefits:** Upon retirement, death, approved disability or termination of employment, participants or their beneficiaries with balances exceeding \$5,000 may elect to receive a lump sum payment or installments as defined in the Plan. Participants with vested account balances less than \$5,000 are required to receive a lump sum distribution. Participants may also take in-service withdrawals, as defined in the Plan document.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expense charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment income for such investments.

**Contributions:** Contributions from Plan participants and the Health Center are recorded in the year in which the participant contributions are withheld.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Note 2. Significant Accounting Policies (Continued)

**Benefit payments:** Benefit payments are recorded when paid.

**Administrative expenses:** Certain administrative functions are performed by employees of the Health Center. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company (the Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$7,186,702 of net appreciation in fair value of investments, \$4,091,548 of interest and dividends and \$36,021 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

#### Note 4. Plan Termination

Although it has not expressed any intent to do so, the Health Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their accounts.

#### Note 5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan (pre-approved plan) sponsored by FMR LLC. FMR LLC has received an opinion letter dated from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### **Note 5. Tax Status (Continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, Plan trustee, and a pooled separate account under a group annuity contract issued by New York Life Insurance Company. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Plan issues loans to participants, which are secured by the balances in the participant's accounts, which also constitute party-in-interest transactions.

#### **Note 7. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 8. Fair Value Measurements (Continued)

The following are descriptions of the valuation methodologies used for assets measured at fair value used as of December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Self-directed brokerage accounts:** Accounts primarily consisting of money market funds, mutual funds and common stocks that are valued based on quoted prices in the active markets on which they are traded and are classified within Level 1 of the valuation hierarchy.

**Pooled separate accounts:** The pooled separate account invests primarily in a diversified portfolio of fixed income securities. The net asset value (NAV) is used as a practical expedient to determine fair value of this account. This practical expedient would not be used if it was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pella Regional Health Center 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

**Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. #### Note 1. Description of Plan

The following description of the Pella Regional Health Center 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan covering all employees of Pella Regional Health Center (Health Center) who are age 18 or older. Employees may enter the Plan for the purpose of making salary deferral contributions immediately upon satisfying the Plan's eligibility requirements. The Board of Trustees of the Health Center is responsible for oversight of the Plan. The Governance and Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute up to 90% of pre-tax annual compensation as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation unless they affirmatively elect otherwise. Also, participants who have deferral rates less than 10% will have their deferral rates increased annually by 1% until their rate reaches 10% unless they affirmatively elect otherwise.

The Health Center provides a matching contribution equal to 50% of participant deferral contributions up to a maximum of 4% of eligible compensation for all participants hired or rehired on or after March 1, 2021. The Health Center also provides a fixed contribution for employees hired or rehired on or after March 1, 2021, based on years of service. The fixed contribution is equal to 1% of a participant's eligible wages after two years of service and then increases 1% per year of service up to 4% after five years of service. The Health Center also provides a fixed contribution for participants hired prior to March 1, 2021, equal to 6% of eligible compensation. Participants must work 1,000 hours and be employed on the last day of the Plan year in order to receive the fixed employer contribution, unless they terminate due to death, disability or retirement. The employer nonelective contribution made for the year ended December 31, 2024, was \$2,228,110.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Health Center's matching and fixed contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Participants direct the investment of their contributions and any Health Center contributions into various investments offered by the Plan. Participants may change their investment options at any time.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Health Center matching and fixed contributions plus actual earnings thereon are based on a three-year cliff schedule whereby participants are 100% vested after three years of service. Separate vesting schedules apply to balances merged in from the Pella Regional Health Center Money Purchase Plan, as defined in the Plan document.

#### Note 1. Description of Plan (Continued)

**Forfeitures:** Forfeitures can be used to offset Plan expenses or fund future employer contributions. Forfeitures included in net assets available for benefits as of December 31, 2024 and 2023, were \$7,990 and \$2,836, respectively. Forfeitures of \$152,750 were used to partially fund employer contributions during the year ended December 31, 2024.

**Notes receivable from participants:** Participant can borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates based on the USA Today's published prime rate. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan are used to acquire the participant's residence, in which case the loan would be 10 years. A participant can have no more than two outstanding loans at any one time. Notes receivable outstanding as of December 31, 2024, mature through December 2029 and bear interest at rates ranging from 3.25% to 8.50%. Notes receivable outstanding as of December 31, 2023 bore interest at rates ranging from 3.25% to 8.50%.

**Payment of benefits:** Upon retirement, death, approved disability or termination of employment, participants or their beneficiaries with balances exceeding \$5,000 may elect to receive a lump sum payment or installments as defined in the Plan. Participants with vested account balances less than \$5,000 are required to receive a lump sum distribution. Participants may also take in-service withdrawals, as defined in the Plan document.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expense charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment income for such investments.

**Contributions:** Contributions from Plan participants and the Health Center are recorded in the year in which the participant contributions are withheld.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Note 2. Significant Accounting Policies (Continued)

**Benefit payments:** Benefit payments are recorded when paid.

**Administrative expenses:** Certain administrative functions are performed by employees of the Health Center. No such employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified or Provided by Fidelity Management Trust Company (the Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution:

Fidelity Management Trust Company also certified to the completeness and accuracy of \$7,186,702 of net appreciation in fair value of investments, \$4,091,548 of interest and dividends and \$36,021 of interest income on notes receivable from participants related to the aforementioned assets for the year ended December 31, 2024.

#### Note 4. Plan Termination

Although it has not expressed any intent to do so, the Health Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their accounts.

#### Note 5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan (pre-approved plan) sponsored by FMR LLC. FMR LLC has received an opinion letter dated from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

#### **Note 5. Tax Status (Continued)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, Plan trustee, and a pooled separate account under a group annuity contract issued by New York Life Insurance Company. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Plan issues loans to participants, which are secured by the balances in the participant's accounts, which also constitute party-in-interest transactions.

#### **Note 7. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 8. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following are descriptions of the valuation methodologies used for assets measured at fair value used as of December 31, 2024 and 2023.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Self-directed brokerage accounts:** Accounts primarily consisting of money market funds, mutual funds and common stocks that are valued based on quoted prices in the active markets on which they are traded and are classified within Level 1 of the valuation hierarchy.

**Pooled separate accounts:** The pooled separate account invests primarily in a diversified portfolio of fixed income securities. The net asset value (NAV) is used as a practical expedient to determine fair value of this account. This practical expedient would not be used if it was determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
