- 
1. **Description of the plan** The following description of the PM Consulting Group dba Vistant 401(k) Plan (formerly PM Consulting Group 401(k) Plan) (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of PM Consulting Group, LLC dba Vistant (formerly PM Consulting Group LLC (the "Company") who are at least 21 years old and who have completed one month of service, except for nonresident aliens, employees covered by a collective bargaining agreement, leased employees and residents of Puerto Rico. Effective January 1, 2024, a pre-approved defined contribution plan sponsored by CCH Incorporated DBA ftwilliam.com was adopted as a restatement of the Plan ("Restatement"). Effective with this Restatement, the Plan Sponsor's name changed from PM Consulting Group LLC to PM Consulting Group LLC dba Vistant and the Plan name changed to PM Consulting Group dba Vistant 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Effective with the Restatement, the Plan was modified to permit Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company contributes a safe harbor matching contribution of 100 percent of the first three percent of compensation and 50 percent of the next two percent of compensation that a participant contributes to the Plan. The Plan allows for discretionary matching contributions. There were no such contributions for the Plan year ended December 31, 2024. Profit sharing amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. There were no such contributions for the Plan year ended December 31, 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on a grouping allocation method whereby each participant constitutes a separate grouping classification. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer for the purchase of a primary residence. Effective with the Restatement, loan terms for a purchase primary residence can be up to 25 years. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one percent. Principal and interest are paid through payroll deductions.

**Payment of benefits:** Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum, partial payments, or installment payments.

**Vesting:** Participants are vested immediately in their contributions, the Company safe harbor matching and discretionary matching contributions, plus actual earnings thereon. Vesting in the Company profit sharing contributions is based on years of continuous service. A participant is 20 percent vested after one year of service is completed, and vests an additional 20 percent per year until full vesting after five years.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees are charged directly to the participant's account and are included in administrative expenses. Plan expenses related to investments were charged and allocated to individual participant accounts based on investment balances.

### 2. Significant accounting policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions:** Participant contributions, the related Company safe harbor matching contributions and discretionary matching contributions, if any, are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit sharing contributions, if any, are recognized in the period the related eligible compensation is paid to the participant.

**Payment of benefits:** Benefits are recorded when paid.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent events:** The Plan has evaluated subsequent events for disclosure in these financial statements through October 13, 2025, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the insurance company of the Plan.
- 4. Fair value measurements** Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the insurance company based on the fair value of the underlying assets in the account, less the liabilities.

All investments of the Plan are measured using net asset value as a practical expedient to estimate fair value and therefore, are not subject to the fair value hierarchy. The investments of the Plan are classified into different risk categories. The investment objective of the conservative accounts is to preserve principal and provide for liquidity while maintaining a competitive rate of interest. Income accounts seek to maximize total return consisting of current income and capital appreciation. Growth and income accounts seek long term growth of capital and income. Growth funds and aggressive growth accounts seek long term growth and capital appreciation. Target date accounts seek high total return through the portfolio's target retirement date.

Investments in all pooled separate accounts can be redeemed immediately at the current net asset value to meet participant-initiated withdrawals. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") may delay any participant-initiated withdrawal from the John Hancock Stable Value Fund for up to thirty days if immediate withdrawal would have an adverse impact on the fund. Up to twelve months advance written notice may be required prior to sponsor redemption of the John Hancock Stable Value Fund, determined by John Hancock. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

- 5. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 6. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 7. Party-in-interest transactions**

Certain Plan investments are managed by affiliates of John Hancock. John Hancock is the insurance company and recordkeeper as defined by the Plan. The Plan pays certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as exempt party-in-interest transactions.
- 8. Tax status**

Prior to January 1, 2024 the Plan was a pre-approved plan of Ascensus LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Effective January 1, 2024, the Plan is a pre-approved plan of CCH Incorporated DBA ftwilliam.com which received an opinion letter on June 30, 2020, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
