We have performed audits of the accompanying financial statements of TGS Holdings, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). **Note 1—Description of the Plan**

The following description of the TGS Holdings, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering eligible employees of TGS Holdings, LLC (the “Company” or “Plan Sponsor”). Eligibility for participation is one year of employment for all employees, excluding union employees, nonresident aliens, and leased employees, who have reached 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Note 1—Description of the Plan (continued)**

*Administration* – The Plan Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – A participant can elect to defer annually up to the amount allowed under the current Internal Revenue Code (“IRC”). Additionally, participants can make after-tax Roth contributions to the Plan, and participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company has elected to provide an enhanced safe harbor matching contribution which is equal to 100% of a participant’s contribution up to 4% of the participant’s eligible compensation, as defined. Additionally, the Company may make a discretionary matching and/or profit sharing contribution. Allocations of any additional profit sharing amounts are based on participants’ eligible compensation. Allocation of any discretionary matching contributions are at a deferral percentage at the Company’s discretion. There were no discretionary matching or profit sharing contributions in 2024.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, and allocations of the Company’s contribution(s) and Plan earnings, and charged with an allocation of Plan losses and administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific transaction costs, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Company’s safe harbor matching and discretionary matching contributions portion of their accounts plus actual earnings thereon. The discretionary profit sharing contribution vests 100% after three years of service.

*Investment Options* – Upon enrollment in the Plan, a participant may direct all contributions in any of the investment options offered by the Plan.

*Payment of Benefits* – Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount or in installment payments. If a terminated participant’s vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment, or rolled into an Individual Retirement Account, depending on the balance. In-service distributions are available to participants once they have attained an age of 59½ years. Hardship distributions are also permitted from participant pre-tax elective deferral account balances.

*Forfeited Accounts* – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$84 and \$3,290, respectively. Per the Plan agreement, these amounts may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$3,231 of forfeited nonvested accounts were used to reduce employer contributions.

**Note 2—Summary of significant accounting policies**

*Basis of Presentation* – The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value, except for the fully benefit-responsive investment, which is reported at contract value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

*Payment of Benefits* – Benefits paid to participants are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Company and are, therefore, excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (“Voya”), the “qualified institution” of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedules.

- Investments at fair value, and investments at contract value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, and dividends and interest as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**Note 4—Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, are described as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Investment contracts with insurance company**

The Plan has entered into a fully benefit-responsive investment contract with Voya totaling \$232,509 and \$225,978 at December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest and a specified interest rate that is guaranteed to the Plan. The minimum crediting rate is guaranteed but a higher minimum guaranteed annual interest rate may be communicated by Voya on a yearly basis.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent of the issuer's claims-paying ability. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as Plan amendments or premature termination of the Plan might limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value if agreed to by the Contract Holder.

**Note 6—Party-in-interest transactions**

Certain Plan investments include mutual funds and unallocated insurance contracts managed by Voya and its affiliate, Voya Investments, LLC. Voya is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

**Note 7—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

**Note 8—Tax status**

The Plan adopted a pre-approved plan sponsored by Acuff & Associates, Inc. which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on November 30, 2020, which stated that the pre-approved plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the pre-approved plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt as of December 31, 2024. The Plan Sponsor believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10—Delinquent participant contributions**

During the years ended December 31, 2024 and 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances are identified on the supplemental Schedule of Delinquent Participant Contributions – Form 5500, Schedule H, Part IV, Line 4a. Additionally, the Company will be compensating participants for lost earnings resulting from the delay in remittances.

**Note 11—Subsequent events**

The Plan has evaluated subsequent events through October 10, 2025, the date these financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to:

- Change eligibility requirements to age 18 and three months of service.
- Change the entry date to the date eligibility requirements are met.
- Add an automatic deferral arrangement for all participants with no existing affirmative election.
- Change the safe harbor employer matching formula to 100% of participant contributions that do not exceed 1% of compensation plus 50% of participant contributions between 1% and 6% of compensation.
- Allow participants to borrow from their vested account balances.
- Remove partial withdrawals as a form of distribution, except for required minimum distributions.
- Permit hardship withdrawals to be made from all account types.
- Add a two-year cliff vesting requirement for safe harbor employer matching contributions.

There were no other subsequent events requiring disclosure.
