Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Xanterra Parks & Resorts, Inc. Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Xanterra Parks & Resorts, Inc. Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following brief description of the Xanterra Parks & Resorts, Inc. Employee Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering qualified employees of Xanterra Parks & Resorts, Inc. and affiliated adopting employers (collectively, "the Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following employers were adopting employers under the Plan: Xanterra Parks & Resorts, Inc.; Xanterra South Rim, L.L.C.; American Railway Explorer, Inc.; Xanterra Tusayan, LLC; Xanterra Adventure Companies, LLC; Holiday Vacations, LLC, and Windstar Cruises Marshall Islands, LLC.

As amended by the Plan, effective December 12, 2024, participating employers in the Plan were restructured as follows: employees of Holiday Vacations, LLC, and Windstar Cruises Marshall Islands, LLC shall be employed by Xplore Xanterra, LLC; effective December 19, 2024, employees of Xanterra Adventure Companies, LLC shall be employed by Xplore Xanterra, LLC; and effective December 19, 2024, employees of Xanterra South Rim, L.L.C. shall be employed by Xanterra Parks & Resorts, Inc. Furthermore, American Railway Explorer, Inc. was removed as a participating employer. As a result of the amendment, at December 31, 2024, the following employers were participating employers in the Plan: Xanterra Parks & Resorts, Inc.; Xplore Xanterra, LLC; and Xanterra Tusayan, LLC.

The Plan's Trustee and Administrative Committee has delegated the selection and monitoring of the Plan's investment offerings to the Investment Manager.

Eligibility

All salaried and hourly employees of the Company, who have completed at least one year of service, as defined, are eligible to participate in the Plan. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Effective November 1, 2010, an employee must have reached age 21 to be eligible; this age requirement is not applicable to those employees that were participants prior to the effective date. Employees who are part of a collective bargaining agreement are not eligible, unless specifically stated in the collective bargaining agreement. Effective January 1, 2016, employees who are working in the United States on J-1 visas are not eligible. Effective January 1, 2024, employees who complete at least 500 hours of service, 3 years in a row, will be eligible to participate in the Plan. The hours will be determined on a lookback basis beginning January 1, 2021. Effective April 1, 2022, full-time employees are eligible to make employee elective deferrals after attaining 21 years of age and on the first day of the month following 30 days of employment. Highly compensated employees are required to complete one year of service, measured from date of hire, to make elective deferrals. Employees must attain 21 years of age and complete one year of service to be eligible to receive employer matching contributions.

Entry Date

Employees may enter the Plan on the date that coincides with or follows the date they satisfy the Plan's eligibility requirements. Full-time employees may enter the Plan on the first day of the month following 30 days of employment.

Contributions

Each year, participants may contribute between 2% and 50% of their eligible compensation, as defined in the Plan Document. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes 100% of the first 3% of a participant's eligible compensation contributed to the Plan each payroll period. In addition, the Company matches 50% of the next 2% of a participant's eligible compensation contributed to the Plan each payroll period. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Effective January 1, 2022, Plan participants are eligible for a "true-up" employer matching contribution. The true-up employer matching contribution is calculated and paid after the end of the year. The amount of the true-up contribution will equal the difference between the annual matching contribution allowable under the formula for the year (maximum of 4% of participants' eligible compensation) and the employer matching contribution received by the participant each pay-period, if any. In the first year a participant is eligible for the employer matching contribution, only the participant's compensation earned on and after the participant's date of eligibility for the employer matching contribution will be taken into consideration for the true-up contribution calculation. For the years ended December 31, 2024 and 2023, the true-up matching contribution totaled \$143,993 and \$113,832, respectively. Additional amounts may be contributed at the discretion of the Company's board of directors. No such additional discretionary contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as an allocation of the Company's discretionary contributions, if any, and Plan earnings. Participant accounts are charged a fixed amount for administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment into the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are vested immediately in their contributions, Company matching contributions, and the earnings thereon. Certain other portions of participant accounts, as defined in the Plan Document, are vested based on years of continuous service. A participant is 100% vested in these items after five years of continuous service.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested account balances.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan interest rate, determined annually, is set at 1% above the current prime rate. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant's residence, in which case the loan terms can range up to ten years. A participant may have no more than one outstanding loan at a given time.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments as defined in the Plan Document upon termination of service due to death, disability, or retirement. Participants who terminate employment with the Company automatically receive a distribution of their account balance in the event their vested account balance is less than \$1,000. Account balances between \$1,000 and \$5,000 will be automatically rolled over into an Individual Retirement Account designated by the Plan Administrator if the participant does not request a distribution or rollover within 60 days of termination. Any distribution made before the participant reaches age 65 requires the participant's consent if their vested interest is more than \$5,000. In the event of termination of employment (other than for death, disability, or retirement after age 65), participants are entitled to receive all of their elective deferral account balance and their vested percentage of their matching contribution and nonelective employer contribution account balances. In-service withdrawals prior to termination of service are allowed for any reason after attaining age 59 ½.

For hardship withdrawals, participants may withdraw a minimum of \$500 up to a maximum amount not to exceed their rollover or before-tax contribution account balance to satisfy one of the immediate and heavy financial needs as described in the Plan Document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in all of their employer contributions.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities.

Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, and other third parties. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, were \$0 at December 31, 2024 and 2023.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan Document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds - Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Self-directed brokerage accounts –

Common stock - Valued at the closing price reported on the active market on which the individual securities are traded.

Money market mutual funds - Valued at the quoted NAV of shares held by the Plan at year end.

Mutual funds - Valued at fair value based on the quoted NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by Bryan Cave Leighton Paisner LLP, which received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The trustee provides certain administrative services to the Plan pursuant to an agreement between the Plan and trustee. The trustee receives income from mutual fund service providers for services provided to the funds. This income is used to offset certain amounts owed to the trustee for its administrative services to the Plan.

If the income received by the trustee from such mutual fund service providers exceeds the amount owed under service agreement, the trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts are allocated to the accounts of the participants. During the year ended December 31, 2024, income in the amount of \$1,612 was used to offset administrative services.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Delinquent Participant Contributions

During the year ended December 31, 2022, the Company failed to remit \$3,109 to the Plan's trustee certain employee contributions within the period prescribed by DOL regulations, of which were fully remitted and corrected for during the year ended December 31, 2024. Delays in remitting contributions to the trustee were due to administrative errors, and the Company has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.
