## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anne Carlsen Center 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Anne Carlsen Center 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 PLAN DESCRIPTION**

The following description of the Anne Carlsen Center 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Anne Carlsen Center established the Plan effective July 1, 2003. The Plan has been amended throughout the years to comply with tax legislation and was last amended and restated effective January 1, 2024. The Plan is a safe harbor defined contribution plan covering employees of Anne Carlsen Center (the Organization). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the sponsor, Anne Carlsen Center. Alerus Financial, N.A. serves as the trustee of the Plan and holds the Plan assets, and Alerus Retirement and Benefits maintains the records of participant data.

**Eligibility**

Employees of the Organization are generally eligible to make contributions to the Plan after reaching 20 years of age and completing 1 hour of service within the first 90 days of employment. Employees can enroll in the Plan on the first day of each calendar month. Once an employee is deferring into the Plan, they are eligible to receive safe harbor matching contributions.

Once eligible for the Plan, employees are also eligible to receive nonelective contributions if they are employed on the last day of the year.

The Plan recognizes prior service for employees hired as a direct result of an acquisition by the Organization.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year but may not exceed 92% of participant compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

Each payroll period, safe harbor matching contributions are made to all participants making salary deferral contributions. The safe harbor matching contribution is 100% of the participant's elective deferrals up to 4% of the participant's eligible compensation.

The Plan allows for additional discretionary matching and nonelective contribution options, subject to Plan provisions. There were no discretionary matching or nonelective contributions made for the years ended December 31, 2024 and 2023.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Organization's contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and the Organization's contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Alerus Retirement and Benefits.

**Payment of Benefits**

Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution or installment payments. If a participant terminates employment and the participant's account balance does not exceed \$7,000, the Plan administrator will authorize the benefit payment without the participant's consent. If a participant terminates employment and the participant's account balance is between \$1,000 and \$7,000, the distribution will be automatically rolled over to an Individual Retirement Account. The Plan allows for in-service distributions if a participant is age 59 1/2 or disabled and for hardship distributions, subject to Plan provisions.

Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

**Vesting**

Participants are immediately 100% vested in their salary deferral, rollover, and safe harbor matching contributions plus actual earnings thereon. The Plan has a graded vesting schedule for discretionary matching and nonelective contributions. A participant is 100% vested in discretionary matching and non-elective contributions after six years of credited service.

**Forfeitures**

Forfeited nonvested accounts may be used to pay administrative expenses or to reduce future employer contributions. There were no forfeited nonvested accounts at December 31, 2024 and 2023. There were no forfeitures used to pay administrative expenses or to reduce employer contributions for the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Principal and interest are paid ratably through payroll deductions. Note terms are up to 5 years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Alerus Financial, N.A. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held and transferred during the year, and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of the loans. Certain administrative expenses are paid from Plan assets and are reflected in these financial statements. Other administrative expenses that are paid by the Organization are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced and a benefit payment will be recorded at the time the participant incurs a distributable event.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a pre-approved plan sponsored by Alerus Financial, N.A. The pre-approved plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the Plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Organization and Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Alerus Financial, N.A. is the trustee of the Plan and, therefore, is a party-in-interest. Alerus Financial, N.A. provides certain administrative services to the Plan pursuant to the service agreement between the Organization and Alerus Financial, N.A.

For the years ended December 31, 2024 and 2023, the Plan paid fees to Alerus Financial, N.A. in the amount of \$86,897 and \$84,862, respectively.

**NOTE 7 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Organization reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Organization terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 24, 2025, which is the date these financial statements were available to be issued.
