The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Cozen O'Connor Associates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering full-time U.S. Associate and Staff Attorneys of Cozen O'Connor (the "Company" or "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Associate and Staff Attorneys may elect to contribute up to 75% of their pre-tax annual compensation to the Plan, subject to the Internal Revenue Code (the "Code") annual contribution limitations (\$23,000 for 2024). Deferrals may be pre-tax or Roth Elective Deferrals (post-tax). Participants attaining age 50 before the end of the Plan year may elect to defer additional amounts (called "catch-up contributions") to the Plan, up to a maximum of \$7,500 for 2024. The Company may make discretionary matching contributions. There were no discretionary matching contributions for the year ended December 31, 2024.

Eligibility and Vesting

Full-time U.S. Associate and Staff Attorneys are eligible to participate as of the date they are employed for 30 days. Eligible employees are automatically enrolled in the Plan at 5% of compensation, unless the employee opts out or elects a different deferral percentage.

The Plan provides for automatic annual escalation on April 1 of each year up to a maximum of 15% of compensation. This automatic increase provision does not apply to participants who had elected a deferral rate of a flat dollar amount and those who opt out of the automatic escalation program.

Participants are immediately vested in their contributions plus actual earnings thereon and, if applicable, are 20% vested in Company discretionary matching contributions after two years of credited service and 20% per year thereafter. Participants are 100% vested in Company discretionary matching contributions after six years of credited service. Any forfeited non-vested amounts will be used to reduce future employer contributions. The Company has never made discretionary contributions to the Plan; therefore, there are no forfeited non-vested accounts.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, when applicable, and an allocation of investment earnings and is charged with withdrawals and an allocation of investment losses. Allocations are based on the participant's earnings or account balance, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment period may not exceed five years, except for the purchase of a primary residence, which extends the repayment period to 15 years. Participants may only have one loan outstanding at any given time. The loans are collateralized by the participant's account balance and bear interest at a reasonable rate, determined by the Plan administrator to be the prime rate published in the Wall Street Journal on the first business day of the month in which the

loan is made, plus 1%. Interest rates ranged from 4.25% to 9.50% at both December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

Investment Policy

All investments are participant-directed. Participants may choose to invest their contributions among any of the Plan's investment options. Participants may change their investment options at any time.

Payment of Benefits

Upon termination of service, death, disability, retirement or separation, participants or their beneficiaries may elect to receive, in either a lump sum or in annuity payments, an amount equal to the value of the participant's vested interest in his or her account. If a participant's account balance is less than \$5,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into another individual retirement account. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account will be made automatically in a single lump-sum cash distribution.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59½. Participants are also permitted to make hardship withdrawals from their deferral contribution in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be taken at any time.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation or depreciation includes the gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Administrative expenses for investment management and Plan administration are charged directly to the various investment funds, and earnings are reported net of these expenses. Participants are charged an administrative fee to process distributions and loans from the Plan. Certain expenses are paid by the Plan from the Plan's ERISA Account. All other administrative expenses of the Plan are paid by the Company.

ERISA Account

The Plan is a party to an administrative revenue sharing agreement under which the Plan receives excess income collected by the recordkeeper. The income may be used to pay certain plan expenses. The Plan's administrative account balance was \$3,133 and \$2,996 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$32,233 in fee credits were allocated to eligible participant accounts.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable pricing inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies and Self-Directed Brokerage Accounts: Valued at the net asset value ("NAV") of shares held by the Plan at year end based upon quoted market prices on nationally recognized exchanges (Level 1). Self-directed brokerage accounts hold investments in common and preferred stock, as well as mutual funds.

Collective Trust: Valued using the NAV as a practical expedient to fair value, provided by the administrator of the fund. The NAV is based on the value of the assets owned by the fund, less the liabilities at year end. While the underlying assets are actively traded on an active exchange, the fund is not.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - TAX STATUS

The Plan obtained its latest determination letter from the Internal Revenue Service (“IRS”) dated May 2, 2017, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan, in form and operations, complies with the requirements of the Code, as currently in effect.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

NOTE H - RELATED PARTY TRANSACTIONS

The Plan includes investments in registered investment company funds and a collective trust fund managed by an affiliate of T. Rowe Price Trust Company, the trustee of the Plan. The Plan also allows notes receivable from participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE I - TRANSFERS TO AND FROM PROFIT SHARING PLAN

Upon promotion to Member Attorney status, a participant is no longer eligible to participate in the Cozen O'Connor Associates 401(k) Plan. However, he or she is eligible to participate in the Cozen O'Connor Profit Sharing Plan and, accordingly, transfer his or her entire Cozen O'Connor Associates 401(k) Plan balance to that plan. Upon change in position to U.S Associate or Staff Attorney, a participant is no longer eligible to participate in the Cozen O'Connor Profit Sharing Plan. However, he or she is eligible to participate in the Cozen O'Connor Associates 401(k) Plan and, accordingly, transfer his or her entire Cozen O'Connor Profit Sharing Plan balance to this Plan.

NOTE J - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. The Plan is not aware of additional subsequent events which would require recognition or disclosure in the financial statements.
