## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Penske Media Corporation 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution savings plan sponsored by Penske Media Corporation and its subsidiaries (the “Company” or “Plan Sponsor”), established effective January 1, 2002. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: Employees of the Company must be at least 18 years of age and must complete one month of service to be eligible to participate in the Plan. The Plan includes an automatic enrollment feature under which eligible employees are automatically enrolled at a deferral rate of 4% of eligible compensation once eligibility requirements are met, unless they affirmatively elect a different rate or opt out. Employees must complete six months of service to be eligible to receive the employer matching contribution. Excluded employees, described as members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining, non-resident aliens, and part-time, temporary, and seasonal employees are not eligible to participate. Eligible employees can enroll in the Plan the first day of the month following the date eligibility requirements are met.

Participant Contributions: Participants may elect to contribute through payroll deductions a portion of their annual compensation, as defined in the Plan, up to a maximum amount allowed by the IRC. Maximum allowed deferral amount was \$23,000 for 2024. Participants over the age of 50 may also contribute an additional \$7,500 catch up contribution to the Plan for 2024. Participants are also allowed to rollover contributions from other qualified retirement plans. Participants direct the investment of all their contributions into various investment options offered by the Plan.

Employer Contributions: The Company provides discretionary matching contributions as a percentage of an eligible participant’s salary deferral. For the year ended December 31, 2024, the Company’s match contribution was at 50% up to 4% of a participant’s compensation. In addition, the Company has the option to make discretionary profit sharing contributions in an amount to be determined by the Board of Directors for each plan year. There are no such profit sharing contributions in 2024. The Company may also decide to make additional discretionary Qualified Matching Contributions (QMACs) or Qualified Nonelective Employer Contributions (QNECs) for non-highly compensated employees as determined under the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, and Plan earnings less losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings less losses on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus earnings thereon. Vesting for employer discretionary matching contributions is based on length of service, in which participants vest 25% per year of service and are 100% vested after completing four years of service. Employer discretionary QMACs and QNECs plus actual earnings thereon are 100% vested when contributed.

Notes Receivable from Participants: Under the terms of the Plan, participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. Loan terms are generally five years or less, but may exceed five years if the purpose of the loan is to purchase a principal residence. A participant may have two loans outstanding at any given time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability or death. Balances equal to or less than \$7,000 will be rolled over to an individual retirement plan designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, a specified series of installments equal to the value of their vested account balance or postpone payment to a later date and remain in the Plan as described in the plan documents.

Forfeitures: Forfeitures are used to offset employer matching contributions or administrative expenses of the Plan. During 2024, there were no forfeitures used to reduce employer matching contributions or pay plan expenses.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation reported by the Plan.

Transfers from Other Plan: Effective January 24, 2024, Luminate 401(k) Plan ("Luminate Plan") was merged into the Plan. The transfer of \$4,918,873 in net assets of the Luminate Plan into the Plan was completed on January 24, 2024.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VAULE MEASUREMENTS** (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. John Hancock Separate Account B is comprised of numerous sub-accounts which invest in shares of a mutual fund, except for stable value fund, which are segregated from other assets of insurance company. The name of the underlying mutual fund is identified in the name of the separate account when the underlying mutual fund is managed by an entity other than an affiliate of insurance company.

The sub-accounts that invest in mutual funds sponsored by an affiliate of insurance company generally reference the investment strategy of the underlying mutual fund in their names. The stable value fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. Participants direct their investments to certain of the underlying sub-accounts of John Hancock Separate Account available to them under the Plan. Each sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. Therefore, no table is presented for the \$123,422,710 and \$93,854,119 in pooled separate accounts held at December 31, 2024 and 2023, respectively.

**NOTE 5 – INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The units of pooled separate accounts are managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to John Hancock Life Insurance Company (U.S.A.) qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Penske Media Corporation 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution savings plan sponsored by Penske Media Corporation and its subsidiaries (the “Company” or “Plan Sponsor”), established effective January 1, 2002. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination or financial hardship. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: Employees of the Company must be at least 18 years of age and must complete one month of service to be eligible to participate in the Plan. The Plan includes an automatic enrollment feature under which eligible employees are automatically enrolled at a deferral rate of 4% of eligible compensation once eligibility requirements are met, unless they affirmatively elect a different rate or opt out. Employees must complete six months of service to be eligible to receive the employer matching contribution. Excluded employees, described as members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining, non-resident aliens, and part-time, temporary, and seasonal employees are not eligible to participate. Eligible employees can enroll in the Plan the first day of the month following the date eligibility requirements are met.

Participant Contributions: Participants may elect to contribute through payroll deductions a portion of their annual compensation, as defined in the Plan, up to a maximum amount allowed by the IRC. Maximum allowed deferral amount was \$23,000 for 2024. Participants over the age of 50 may also contribute an additional \$7,500 catch up contribution to the Plan for 2024. Participants are also allowed to rollover contributions from other qualified retirement plans. Participants direct the investment of all their contributions into various investment options offered by the Plan.

Employer Contributions: The Company provides discretionary matching contributions as a percentage of an eligible participant’s salary deferral. For the year ended December 31, 2024, the Company’s match contribution was at 50% up to 4% of a participant’s compensation. In addition, the Company has the option to make discretionary profit sharing contributions in an amount to be determined by the Board of Directors for each plan year. There are no such profit sharing contributions in 2024. The Company may also decide to make additional discretionary Qualified Matching Contributions (QMACs) or Qualified Nonelective Employer Contributions (QNECs) for non-highly compensated employees as determined under the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, and Plan earnings less losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings less losses on account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus earnings thereon. Vesting for employer discretionary matching contributions is based on length of service, in which participants vest 25% per year of service and are 100% vested after completing four years of service. Employer discretionary QMACs and QNECs plus actual earnings thereon are 100% vested when contributed.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Notes Receivable from Participants: Under the terms of the Plan, participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate. Loan terms are generally five years or less, but may exceed five years if the purpose of the loan is to purchase a principal residence. A participant may have two loans outstanding at any given time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability or death. Balances equal to or less than \$7,000 will be rolled over to an individual retirement plan designated by the administrator if the participant has not requested a lump-sum cash payment or a direct rollover into another qualified benefit plan. If the account balance is over \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, a direct rollover into another qualified plan, a specified series of installments equal to the value of their vested account balance or postpone payment to a later date and remain in the Plan as described in the plan documents.

Forfeitures: Forfeitures are used to offset employer matching contributions or administrative expenses of the Plan. During 2024, there were no forfeitures used to reduce employer matching contributions or pay plan expenses.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation reported by the Plan.

Transfers from Other Plan: Effective January 24, 2024, Luminate 401(k) Plan ("Luminate Plan") was merged into the Plan. The transfer of \$4,918,873 in net assets of the Luminate Plan into the Plan was completed on January 24, 2024.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Risks and Uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

**NOTE 4 – FAIR VAULE MEASUREMENTS** (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. John Hancock Separate Account B is comprised of numerous sub-accounts which invest in shares of a mutual fund, except for stable value fund, which are segregated from other assets of insurance company. The name of the underlying mutual fund is identified in the name of the separate account when the underlying mutual fund is managed by an entity other than an affiliate of insurance company.

The sub-accounts that invest in mutual funds sponsored by an affiliate of insurance company generally reference the investment strategy of the underlying mutual fund in their names. The stable value fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. Participants direct their investments to certain of the underlying sub-accounts of John Hancock Separate Account available to them under the Plan. Each sub-account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. Therefore, no table is presented for the \$123,422,710 and \$93,854,119 in pooled separate accounts held at December 31, 2024 and 2023, respectively.

**NOTE 5 – INCOME TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The units of pooled separate accounts are managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to John Hancock Life Insurance Company (U.S.A.) qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.
