Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A – DESCRIPTION OF PLAN

The following brief description of the **George Moehrle Masonry, Inc. Retirement Plan** (the “Plan”) provides only general information. Participants and other interested parties should refer to the Summary Plan Description and Plan Document for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution 401(k) plan covering all eligible employees of the Company who have completed one year of service (1,000 hours of service by the end of the employee’s first twelve consecutive months of employment) and are age eighteen years or older, or those employees who performed work on a contract subject to prevailing wage law. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Employee 401(k) Deferrals & Discretionary Employer Matching Contributions – Each year, participants may contribute a percentage (or flat amount) of their pretax annual compensation, as defined in the Plan. In order to become eligible to participate in the salary deferrals, an employee must have completed one year of service and be eighteen years or older. The Company may also make a discretionary matching contribution up to a certain percentage of a participant’s eligible compensation. In order to share in the matching contribution, a participant must be actively employed on the last day of the plan year and must have completed 1,000 hours of service with the Company during the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”). Contributions are subject to certain limitations.

Employer Prevailing Wage Contributions – Each year, employees who perform services for the Company under a public contract subject to the Davis-Bacon Act, the Service Contract Act or any other federal, state or municipal Prevailing Wage Law automatically become eligible to receive prevailing wage contributions. Contributions are calculated using prevailing wage and benefit rates that are stipulated in each prevailing wage contract. Contributions are subject to certain limitations. Contributions can be deposited into the health savings account or the retirement plan at employee election starting in 2017. Effective January 1, 2021, the Plan adopted an amendment which modified the designation of prevailing wage contributions from “employer nonelective” to “qualified nonelective” contributions. This amendment was made to allow for the treatment of prevailing wage contributions to be consistent with the provisions of the plan document under the previous trustee.

Contributions (continued):

Employer Discretionary Profit-Sharing Contribution – Each year, the Company may make a discretionary profit-sharing contribution to participants who are eligible to share in the profit-sharing contribution. In order to share in the profit-sharing contribution, a participant must be actively employed on the last day of the plan year and must have completed 1,000 hours of service with the Company during the plan year. The profit-sharing contribution consists of two separate contributions, using two different methods of profit sharing. The first method allocates a contribution among participants based on their compensation as a percentage of all participants' eligible compensation. The second method contributes based upon a participant's hours worked, at "rate times hours worked." Rates will be determined each plan year and may vary between participants' job descriptions. Employer profit-sharing contributions are allocated to the individual accounts of qualifying individuals using individual allocation groups in which each qualifying participant constitutes a separate allocation group. Contributions are subject to certain limitations.

Employer Nonelective "CORE" Contribution – Effective October 1, 2017, the Company amended the Plan to provide an incentive contribution "CORE contribution" to employees who had been employed at least 90 days and who met safety and production milestones at a rate of \$1.00 - \$2.00 per hour based on worker classifications, which could be deposited in either the health savings account plan or the retirement plan at employee election. Participants are immediately 100% vested in these contributions. The "CORE" contributions were suspended in 2018 through a Board resolution.

Participant Accounts:

Individual Plan accounts are maintained for each participant of the Plan. Contributions are credited to the participant's account and are invested at the participant's discretion in the Plan's designated investment fund options. Each participant's account is credited with (a) the participant's voluntary 401(k) contribution, (b) the employer's discretionary matching contribution, (c) the employer's discretionary profit sharing contribution(s), (d) the employer's nonelective "CORE" contribution, (e) the employer's prevailing wage contribution, (f) allocation of investment earnings, (g) allocation of forfeitures of terminated participants' nonvested accounts and (h) an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately and 100% vested in their rollover contributions, voluntary 401(k) contributions, prevailing wage contributions, and employer CORE contributions plus actual earnings thereon. Vesting in the employer matching and profit-sharing contributions portion of their accounts, plus earnings thereon is based on years of continuous service. The vesting schedule is as follows:

To earn a year of service for vesting purposes, a participant must be credited with at least 1,000 hours of service during the plan year.

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant will be entitled to receive 100% of his or her account balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Distributions:

Effective June 5, 2018, the Plan was amended to provide a provision for participants to withdraw funds from their account provided a financial hardship was experienced. A hardship distribution may be taken only for qualified expenses, which include but are not limited to medical care, post-secondary education and certain damages to a primary residence. The amount of funds available for hardship distribution are limited to the amount of the vested portion of an individual's account for both employee elective deferrals and employer contributions.

Forfeited Accounts:

As of December 31, 2023 and 2024, forfeited, non-vested accounts totaled \$0 and \$14, respectively. Forfeitures may be used to pay for administrative expenses related to the Plan. Forfeited, non-vested accounts of \$167 and \$100 were used for administrative expenses for the years end December 31, 2023 and 2024, respectively.

Administrative Expenses:

Administrative expenses include primarily plan administration fees and accounting/auditing fees.

Plan Administration:

Effective July 15, 2022, the Plan entered into an agreement with a third party to provide advisory services in selecting and monitoring the investment options of the Plan. The agreement automatically renews for 1 year terms unless either party cancels at least 30 days prior to renewal.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Reclassifications:

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform with the presentation in the current year financial statements.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Income Tax Status:

Effective May 31, 2021, the Plan was restated by adopting pre-approved prototype plan document sponsored by Ascensus, LLC, who received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself did not receive a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan sponsor and administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been made in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax positions that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the statute of limitations for the Form 5500 for years 2021-2023 remains open with the Internal Revenue Service.

Payment of Benefits:

Benefits are recorded in the period the Plan receives the distribution request from the participant.

Cash and Cash Equivalents:

The Plan considers cash and cash temporarily invested with original maturities of three months or less to be cash equivalents. There were no cash equivalents as of December 31, 2023 and 2024.

Investment Valuation and Income Recognition:

Investments are reported at fair value, which may differ from the amount ultimately realized at the time of sale. The difference may be material. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See **NOTE H** for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE H – FAIR VALUE OF FINANCIAL INSTRUMENTS

Generally accepted accounting principles define fair value, establish a framework for measuring fair value, and establish a fair value hierarchy that prioritizes the inputs to valuation techniques. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market. Valuation techniques that are consistent with the market, income or cost approach are used to measure fair value.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

Level 1 – These inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – These are inputs (other than quoted prices included within level 1) that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, default rates and other similar data.

Level 3 – These are unobservable inputs for the asset or liability and rely on management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. The unobservable inputs should be developed based on the best information available in the circumstances and may include the Plan’s own data.

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net assets value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The common collective trust fund is valued based on the readily determinable quoted market price that each fund publishes at the end of each day. While the underlying assets are actively traded on an exchange, the common collective trust funds are not and, therefore, are classified as level 2 assets in the fair value hierarchy.

NOTE J – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Plan investments are managed by Ascensus and, therefore, those transactions qualify as party-in-interest transactions. For the years end December 31, 2023 and 2024, accrued expenses includes \$4,668 and \$0, respectively, of expenses due to Ascensus.

Ascensus Trust Company collects 12b-1 fees, commissions, sub-transfer agency fees and other fees from Plan investments. These funds are credited to an Administrative Fee Credit Account (“AFCA”), which is maintained for the benefit of the Plan. At the Plan sponsor’s discretion, these funds can be used to pay Plan recordkeeping and administration fees. As of December 31, 2023 and 2024, the AFCA balance was \$140 and \$119, respectively. AFCA funds of \$638 and \$717 were used for administrative expenses for the years end December 31, 2023 and 2024, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE K – SUBSEQUENT EVENTS

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the audit report was available to be issued.
