## Independent Auditors' Report

To the Plan Administrator, Participants, and Beneficiaries of the  
EHS Technologies 401(k) Retirement Plan

We have performed audits of the accompanying financial statements of EHS Technologies 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of EHS Technologies 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Principal Trust Company as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate. For the year ended December 31, 2023, certifications were obtained from Principal Trust Company, stating the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EHS Technologies 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about EHS Technologies 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules Schedule H, Line 4i - Schedule of Assets (Held at Year End) as of December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we

compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the EHS Technologies 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Transfer of Assets

On November 30, 2023, the Plan transferred \$8,820,400 from Ascensus Trust Company to Principal Trust Company as part of a change in service providers. The transfer did not impact the net assets available for benefits.

General

The Plan is a defined contribution plan that was established on January 1, 2009. The plan covers all employees of EHS Technologies Corporation (the "Company") who are not considered excluded employees as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian of the Plan is Principal Trust Company ("Principal") and the recordkeeper is Principal Financial Group. Prior to the transfer, Ascensus Trust Company ("Ascensus") acted as the custodian and Ascensus, LLC provided recordkeeping services.

Contributions

Each year, participants may contribute up to the maximum allowable amount as mandated under the Internal Revenue Service Code. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. Each participant may elect to reduce compensation, as defined by the Plan by a specific percentage or dollar amount and have that amount contributed to the Plan on a pre-tax basis as a salary deferral. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover). Participants direct the investment of participant and Company contributions into various investment options by the Plan and monitors investment performance.

The Company matches 100% up to 6% of a participant's salary deferral under the Plan's safe harbor match provision. For the year ended December 31, 2024, the Company made matching contributions in the amount of \$508,749. Matching contributions are invested as directed by the participant.

Additional profit sharing amounts may be contributed at the option of the Company's management and are invested as directed by the participant. No discretionary profit sharing contributions were made for the Plan year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions, the employer safe harbor matching contributions, and the actual earnings thereon. Vesting in the Company's additional profit sharing contributions and earnings thereon are as follows:

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Loan terms may not exceed five years except when the loan is used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% as published in the Wall Street Journal. Interest rates on outstanding loan balances range from 4.25% to 9.50% for the years ended December 31, 2024 and 2023, respectively. Principal and interest is paid ratably through semi-monthly payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Forfeited Accounts

There were no forfeited nonvested accounts or participant forfeitures as of and for the years ended December 31, 2024 and 2023, respectively.

For the year ended December 31, 2024, there were no forfeitures used to offset employer contributions. For the year ended December 31, 2023, forfeitures in the amount of \$6,003 were used to offset employer contributions. Employer contributions on the statement of changes in net assets available for benefits is shown net of this amount.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Terminated participants may receive the value of their vested account upon the date of severance from employment. If the vested account balance is greater than \$1,000, the participant may leave their account with the Plan. Distributions due to death, disability, or normal retirement (age 65), shall begin as soon as practicable after the date of the qualifying event. Participants may receive in-service distributions of their vested account on or after the attainment of age 59 1/2. Distributions are in the form of a lump-sum distribution. The Plan provides for hardship withdrawals under the provisions of the Internal Revenue Code ("IRC").

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**NOTE C - INVESTMENT CERTIFICATION**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Principal Life Insurance Company, the custodian, has certified to the completeness and accuracy of all investments and related investment activity, notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at year end) as of December 31, 2024.

Ascensus, as agent for Ascensus Trust Company, the custodian, has certified to the completeness and accuracy of all investments and related investment activities, notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of November 6, 2023, the date of the transfer of assets.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standard Board's ("FASB") Accounting Standards Codification 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the assets and liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: The Plan's investment in Pooled Separate Accounts are valued at net asset value practical expedient (NAV practical expedient) as reported by the fund manager. The NAV practical expedient is based on the fair value of underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a pooled separate account is calculated based on the compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

Common/Collective Trust (CCT): Valued at NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The primary investment objective of the fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E - Guaranteed Investment Contract with Insurance Company**

In 2024, the Plan entered into a fully benefit-responsive investment contract (FBRIC) with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semiannual basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Benefit payments to participants for plan benefit events are made without any surrender charge or early termination charge. Investment transfers to a competing guaranteed investment option are not allowed. Indirect transfers to a competing investment option are subject to an equity wash. An equity wash requires transfers be directed to a non-competing investment option for 90 days before a subsequent transfer can be made to a competing investment option.

Certain events may limit the plan's ability to transact at contract value, including plan termination, significant layoffs or employer-initiated workforce reductions, bankruptcy or insolvency of the plan sponsor, mergers or acquisitions involving the plan sponsor, and early retirement incentive programs. While these events are listed as potential limitations, they are generally considered unlikely to occur under normal circumstances.

**NOTE F - TAX STATUS**

On August 14, 2023, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase with Cash or Deferred Arrangement ("CODA") sponsored by the Principal Life Insurance Company. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation.

**NOTE F - TAX STATUS (continued)**

On May 15, 2022, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase with Cash or Deferred Arrangement ("CODA") sponsored by the Paragon Alliance Group, LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter.

However, the Plan administrator believed that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statement. The Plan is subject to routine examinations by taxing jurisdictions: however, there are currently no examinations for any tax periods in progress.

**NOTE G - RELATED PARTY TRANSACTIONS**

Under agreement with Principal Life Insurance Company, the Plan is subject to fees based on a percentage of plan assets for annual plan and service fees, advisory services and education and plan services. These fees are deducted directly from participant accounts. Fees for these services amounted to \$34,532 for the year ended December 31, 2024.

While under management of Ascensus Trust Company, no fees were incurred by the Plan for these services for the year ended December 31, 2023. Fees incurred by the Plan for the investment management service are included in net appreciation in fair value of the investment. Fees paid for advisory services amounted to \$12,030 paid to Lane Hipple Wealth Management for the year ended December 31, 2023.

The plan sponsor pays directly all other fees related to the Plan's operations.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**NOTE J - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

**NOTE K - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
