## Independent Auditor's Report

Trustees and Board of Directors  
Miracapo Pizza Company LLC Employee Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Miracapo Pizza Company LLC Employee Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **Note 1. Plan Description**

The following description of the Miracapo Pizza Company LLC Employee Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and covers employees of Miracapo Pizza Company LLC (the Company) who have met the eligibility requirements as defined by the Plan. Employees are eligible to participate in the Plan upon their hire date. However, an employee is not eligible to participate if: (a) represented by a bargaining unit that has bargained with us in good faith on the subject of retirement benefits; (b) a nonresident alien with no U.S. income or all such income is exempt from U.S. income tax; (c) a leased employee; or (d) considered an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee of the Company.

**Contributions:** Each year, participants may contribute but cannot exceed the lesser of 100% of pre-tax annual compensation or the annual dollar limit on salary deferral contributions, as defined by the Plan. The Plan excludes post-severance compensation from contributions. All employees who are eligible to make elective deferrals under this Plan and who have attained age 50 before the close of the plan year are eligible to make catch-up contributions in accordance with, and subject to the limitations of, the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a matching contribution each year in an amount to be determined by the Company. For 2024, the Company's matching contribution was equal to the participant's contribution up to a limit of 3% of eligible compensation. Contributions are subject to certain limitations. The Company may also, at its own discretion, make profit-sharing contributions to the Plan to be allocated to each eligible participant, as defined, in proportion to the employee's compensation for all eligible employees. The Company did not make discretionary profit-sharing contributions during 2024.

**Rollovers:** The Plan accepts rollovers from a qualified retirement plan of a prior employer with approval from the Plan Sponsor.

**Participant accounts:** Each participant's account is credited with the participant's contribution and Company matching contributions, if any, and an allocation of plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon.

Participants vest in the Company matching contribution and earnings thereon in the following manner:

3 years	75%
4 years	100%

**Investment options:** Upon enrollment in the Plan, a participant may direct employee contributions and Company matching contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Note 1. Plan Description (Continued)**

**Payment of benefits:** Vested benefits are payable as soon as practicable after termination of service or plan termination. On termination of service, a participant may receive a lump-sum cash distribution.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Each note will bear interest at the prime rate on the date that the note is originated. Notes must be paid within five years by equal bi-weekly payments. However, notes used to buy a participant's principal residence may be paid over a reasonable period which may exceed five years. Principal and interest are paid ratably through payroll deductions.

**Forfeited accounts:** At December 31, 2024 and 2023, there were no forfeited amounts. During the year ended December 31, 2024, nonvested forfeited accounts approximated \$63,000, and the Plan used all amounts to reduce Company match contributions.

**Note 2. Significant Accounting Policies**

**Basis of accounting:** The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported as net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Valuation of investments and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determine the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Any capital gains or losses are included in net appreciation or depreciation.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted participant loans are reclassified as distributions if the participant met criteria for payment of benefits (Note 1) based upon the terms of the plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions are recognized when declared by the Company.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

**Note 3. Information Certified and Provided by Empower Trust Company, LLC (Empower), the Current Trustee, and Principal Trust Company (Principal), the Former Custodian**

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Units of common collective trusts at practical expedient:** Valued at the total of the NAV of shares of mutual funds and cash held by the account. The Plan's interest is valued based on the information reported by the investment advisor. The NAV is used as a practical expedient to estimate fair value. The NAV of the common collective trust account itself is not publicly quoted but the values are not dependent on the input of any significant judgments or assumptions by management.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Party-in-Interest Transactions**

Certain plan investments consist of shares of registered investment companies managed by the current trustee of the Plan, and therefore, these transactions qualify as party-in-interest. Furthermore, the recordkeeper provides administrative services to the Plan.

Certain investment and administrative expenses are paid by the Plan, and the total amounted to \$10,610 for the year ended December 31, 2024.

Certain employees of the Company provide trustee and administrative services to the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

On December 13, 2024, the Plan changed its custodian from Principal to Empower as the trustee of the Plan. Effective December 13, 2024, the Plan adopted a preapproved plan document that has received an opinion letter from the IRS dated November 14, 2022, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2021.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
