Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of New World Travel 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of New World Travel 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Note 1. Plan Description

The following description of the New World Travel, Inc. Employee 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of New World Travel, Inc. (the “Company”) who have completed one year of service and are age twenty-one (21) or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of their annual pretax compensation, as defined in the Plan and subject to the limitations imposed by the Internal Revenue Code, subject to certain discrimination tests prescribed by the Internal Revenue Code. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the plan. The Company contributes 100% of the first 10% of the base compensation that a participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. The Plan may accept rollover contributions. Rollover contributions represent distributions received from other "eligible retirement plans," as defined in IRC section 401(a)(31)(E). Distributions from other plans are subject to certain conditions to be eligible for rollover into the Plan.

Participant accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, Plan earnings and charged with an allocation of investment gains or losses, withdrawals and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The only benefit to which a participant is entitled to is that benefit that can be derived from that participant’s account.

Vesting

The participants are immediately vested in their voluntary contributions and any rollover amounts from another plan, plus actual earnings thereon. Vesting in Company contributions is based on years of continuous service. Each participant vests in 20% increments for each of the five years of credited service commencing from year two after completion of one full year of service.

Participants' Loans Receivable

Participants may borrow from their fund accounts a minimum of \$1,000, and up to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as transfers between the investment fund and the participants' loan account. Loans must be repaid within 5 years, with a longer term for the purchase of a primary residence upon approval from the plan administrator. The loans are secured by the balance in the participants account and bear interest at a rate of 4.25% - 7.25% as of December 31, 2024 and 2023. Principal and interest are paid ratably through Semi-monthly payroll deductions.

Payment of Benefits

On termination of service due to retirement, disability or death, a participant or his or her beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of services due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

Forfeitures of non-vested employer matching contributions are used to pay for administrative expenses of the Plan and then to reduce future matching contributions. For the year ended December 31, 2024 and 2023, \$9,856 and \$4,856, respectively, were used to reduce employer contributions and pay administrative fees. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$17 and \$5,816, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

Accounting Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Income Recognition

Purchase and sale of securities are recorded on the trade date. Dividend income is recorded on the ex-dividend date and interest income is recorded on an accrual basis. Realized gains and losses are calculated as the difference between the proceeds from sales and related investment's fair market value at the beginning of the Plan year, or acquisition cost if acquired during the year. Unrealized appreciation and depreciation is calculated as the difference between the fair value of investments at the end of the year, less their fair value of investments at the end of the year, less their fair value at the beginning of the year, or acquisition cost, if acquired during the year.

Investment Valuation

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2- Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the plan:

Mutual Funds

The fair values of mutual fund and common stock fund investments are determined by obtaining market prices from reputable securities exchanges (level 1 assets).

Self Directed Brokerage Account

The fair values of Brokerage account assets are valued based on prices provided to the brokerage firm from external pricing sources and based on market prices.

Participant Loans

Participant loans are reported at cost. The fair value of participant loans is not reasonably able to be estimated due to the restrictions placed on the transferability of the loans.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the plan are paid by the sponsor and are not included in the statements of changes in net assets available for benefits. All reasonable administrative expenses, including those involved in retaining necessary professional assistance, may be paid from the assets of the Plan.

During the year ended December 31, 2024 and 2023, the Plan’s investments (including gains and losses on investments bought and sold, as well as held during the year appreciated (depreciated) in value by \$1,540,641 and by \$2,210,096, respectively.

Note 4. Information Prepared and Certified by the Trustee

Voya Trust (“Voya”) is the trustee of the plan’s assets, which managed and executed all investment transactions during the years ended December 31, 2024 and 2023. The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya has certified that the following data included in the accompanying financial statements is complete and accurate with respect to investments.

- Investments at fair value
- Changes in fair value of investments
- Interest, dividend, and gains (losses) on investments
- Schedule of assets (held at end of year)

The Plan’s independent auditor did not perform any auditing procedures with respect to this information, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

Note 6. Tax Status

The Plan has adopted a prototype cash or deferred profit-sharing plan and trust sponsored by Voya. The prototype plan obtained a determination letter dated March 31, 2014, in which the Internal Revenue Service Stated that the Plan, as then designed was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Company and the Voya believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan sponsor believes it is no longer subject to tax audits for the years prior to 2020

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Voya. Voya is the custodian as defined by the Plan which is managed by Ascensus, therefore, these transactions qualify as Party-in-interest transactions. Fees paid by the Plan for the management services amounted to \$6,771 and \$5,955 for the years ended December 31, 2024 and 2023, respectively.

Note 9. Subsequent Events

Subsequent events have been evaluated for potential recognition or disclosure through October 15, 2025, which is the date the financial statements were available to be issued. There are no events to disclose.
