Notes to Financial Statements

1. Description of Plan

The following description of the Marshall Wace North America LP 401(K) Profit Sharing & Trust (the Plan) provides general information only. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

Effective January 1, 2004, Marshall Wace North America LP (the Employer or the Company) established the Plan. The Plan is a defined contribution 401(K) plan covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of the Company, as defined in the Plan document, must be 21 years of age or older to be eligible to participate in elective deferral contributions and receive matching contributions. Additionally, employees who are aged 21 or older are eligible to participate in profit-sharing contributions. Employees subject to a collective-bargaining agreement, leased employees, and non-resident aliens are not eligible to participate in the Plan.

Participant Contributions

Eligible employees are automatically enrolled in the Plan at 10% of the employee's pre-tax wages unless the employee affirmatively elects not to participate. The Plan allows each participant to contribute from 1% to 80% of his or her annual compensation, as defined, up to the maximum annual amount allowed by law. If participants elect a deferral percentage of less than 10%, it will automatically be increased to 10% on the first day of the following calendar year unless the participant explicitly elects the deferral percentage of less than 10% during the Plan sponsor's annual open enrollment period. Rollovers, Roth contributions, and catch-up contributions are allowed. In-plan Roth rollovers, as defined, are allowed.

Employer Contributions

The Employer makes a matching contribution on elective deferral contributions or catch-up contributions, or a discretionary profit-sharing contribution to the Plan, which is allocated to the eligible accounts based on an integrated allocation formula, as defined in the Plan document. The matching contribution is calculated at 100% of up to 10% of participant deferrals. For the year ended December 31, 2024, the employer matching contribution totaled \$3,759,063. No discretionary profit-sharing contribution was made for the year ended December 31, 2024.

Participant Accounts

The Plan is a participant-directed account plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants' accounts are credited with participant contributions, rollovers, and an allocation of any Employer contributions. Plan earnings are allocated to participant accounts based on the earnings of the specific mutual funds selected by the participant, and administrative expenses are allocated based upon a participant's account balance in proportion to the balances of all participants' accounts. The benefit

to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Vesting

Participants are always 100% vested in their elective deferrals, rollovers, catch-up contributions, and after-tax contributions, plus actual earnings thereon. Participants become fully vested in the Company's matching contributions and profit-sharing contributions and earnings after one year of service.

Participants who reach the normal retirement age, as defined by the Internal Revenue Code (the IRC), and who are still employed with the Company at that time, become 100% vested in their account balance. In addition, participants who die or become disabled while still employed with the Company become 100% vested in their account balance.

Investment Options

Contributions are invested by Ascensus Trust Company (Ascensus or the Trustee) according to the options elected by the participants. All participant and Employer contributions are directed by the participant among the available investment options. Investment earnings are automatically reinvested into the fund or portfolio from which they were derived.

Notes Receivable from Participants

Participant loans are allowed at a minimum of \$1,000 not to exceed a maximum of \$50,000 or 50% of the participant's account balance, excluding participant Roth deferrals and earnings, whichever is less. The loans are secured by the participant's vested account balances and, except for loans used to acquire a principal residence, must have a repayment period of no greater than five years. Loan transactions are treated as a directed investment from the participant's account under the Plan. Interest is calculated at the prime rate, as determined monthly by *The Wall Street Journal*, plus 2% at the time of the loan. At December 31, 2024 and 2023, all loans bear interest ranging from 5.25% to 10.5%. Principal and interest are paid ratably through payroll deductions every pay period. No more than one note is allowed at any time and repayment of the entire balance is permitted at any time. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC.

Payment of Benefits

Participants' benefits under the Plan are payable to participants or their beneficiaries upon termination of employment, normal retirement, disability, financial hardship, or death. Benefits are payable in one lump-sum payment. Partial or installment payments are permitted only to satisfy required minimum distribution rules. Hardship withdrawals are available, as are in-service distributions to participants who have attained the age of 59½. Corrective distributions are made, returning contributions to participants, when employee contributions exceed contribution limitations imposed by the Department of Labor's (DOL) regulations. If a participant's employment terminates with the Employer, the Plan permits distribution of the participant's account, not in excess of \$5,000, to be cashed out or transferred to an individual retirement account (IRA) without the participant's consent.

Forfeited Accounts

Forfeitures may be used to pay Plan expenses or to reduce Employer contributions. During the year ended December 31, 2024, \$9,001 was forfeited by withdrawing partners and the forfeiture account earned \$1,592. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$35,231, respectively. For the year ended December 31, 2024, forfeitures used to offset Employer matching contributions were \$45,824.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and when applicable, disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Transfer of Assets to a New Trustee

On December 31, 2024, in preparation for a change in trustee effective January 1, 2025 (see Note 9), the Plan liquidated certain investment holdings totaling \$19,820,021 into cash, and recorded this amount as noninterest-bearing cash on the statement of net assets available for benefits at December 31, 2024. The remaining investments totaling \$35,982,756 were transferred in-kind to the new trustee.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants and beneficiaries are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and the Trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts, including loans, withdrawal fees, Plan administrative fees, and investment management fees. Certain investment expenses that are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

Direct compensation paid by the Plan as administrative expenses totaled \$952 for the year ended December 31, 2024, which consisted of third-party administrative fees.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds - Money market funds are valued at the daily closing price as reported by the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to noninterest-bearing cash, investments, and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, a qualified institution.

5. Tax Status

The Plan uses a pre-approved plan document sponsored by Ascensus. Ascensus received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes

that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risk and Uncertainties

The Plan invests in various publicly traded mutual funds and a money market fund. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right at any time to terminate the Plan in accordance with ERISA by delivering to the Trustee and third-party administrator written notice of such termination. Upon termination of the Plan, no further contributions will be made to the Plan and all participants' accounts will become fully vested and shall be distributed in accordance with the provisions of the Plan.

8. Related Parties and Parties-in-Interest

The Company; Ascensus, the Trustee; the Vanguard Group, the record-keeper; and Retirement Resources Investment Corporation, the investment advisor, are parties-in-interest with respect to the Plan under the provisions of ERISA. The Plan also issues loans to participants, which are secured by the vested balances of the participants' accounts. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Fees incurred by the Plan for the investment management services are included as a reduction in the net appreciation in fair value of investments.

9. Subsequent Events

The Plan's administrator has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan changed trustee from Ascensus to Fidelity Management Trust Company (Fidelity). All net assets of the Plan were received from Ascensus and invested by Fidelity in January 2025. Effective January 1, 2025, the Plan adopted a pre-approved plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. The restated adoption agreement permits after-tax participant contributions.
