Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sacramento Native American Health Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1: Description of Plan

The following description of the Sacramento Native American Health Center 403(b) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2007, to provide eligible employees of Sacramento Native American Health Center (the Organization) with retirement benefits in accordance with section 403(b) of the Internal Revenue Code (the IRC).

Eligibility

Employees who are not non-resident aliens or students providing services to the Organization are eligible to make elective contributions upon reaching 18 years of age, have completed 3 months of service, regularly work more than 20 hours per week, and whose compensation is greater than \$200 annually.

Contributions

Employees may elect to make pre-tax contributions in an amount up to 100% of their annual eligible salary, not to exceed \$23,000 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Each participant may elect to have their individual account invested in any combination of funds held by the Plan's custodian.

The Organization makes a matching contribution equal to 100% of the participant's salary deferral, not to exceed 3% of participant compensation if they have been employed for less than 5 years, or 4% of the participant's compensation if they have been employed for 5 years or more.

Participant Accounts

Each participant's account is credited with the participant's and employer's contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

Vesting

Participants are vested immediately in their salary deferral contributions, qualified rollovers or transfers from other retirement plans, and employer matching contributions, plus earnings thereon. Non-elective and matching contributions are subject to a three year cliff vesting schedule.

Note 1: **Description of Plan (Continued)**

Payment of Benefits

Upon termination of employment a participant may be entitled to a distribution from the Plan as soon as administratively feasible. Generally, the only distribution option under the Plan is a lump sum distribution which can be received in cash or rolled over to an IRA or another qualified plan. All or a portion of an employee's salary deferral, matching, or employer contribution may be withdrawn while still employed if the participant is at least age 59½ years at the time of distribution.

Notes Receivable from Participants

Participants are allowed to borrow a minimum of \$1,000 up to one-half of their vested balance, up to a maximum of \$50,000. Participants may only have one loan outstanding at any time. Loans bear a reasonable fixed-rate of interest, which is determined by the Plan custodian. Generally, loans must be repaid over a maximum of five years. Loans to participants are stated at the principal amount outstanding, which approximates fair value. The loans are secured by the participant's balance.

Forfeitures

Upon termination of employment, the unvested portion of a participant's employer contributions account is forfeited. Forfeitures are kept in a separate investment account and are applied first to reduce administrative expenses and then employer contributions. The forfeiture account balance was \$81,398 and \$66,243 at December 31, 2024 and 2023. During the year ended December 31, 2024, \$29,780 of the balance was used.

Administrative Expenses

The Organization, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participants' accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodian in the performance of their duties.

Note 2: **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value and contract value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Subsequent Events

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through October 13, 2025, the date these financial statements were available for issuance. As of such date, management is not aware of any events requiring additional disclosure.

Note 3: **Information Certified by the Custodians**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company and Ascensus Trust Company (the custodians of the Plan).

Note 4: Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Organization reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would be first used to pay expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

Note 6: Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 29, 2024, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: **Party-in-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by Ascensus Trust Company and American Funds. As Ascensus Trust Company and American Funds are the custodians of the Plan, transactions with these entities qualify as exempt party-in-interest transactions.

Note 8: **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: **Non-Exempt Transactions**

During the year ended December 31, 2024 and 2023, the Company failed to remit to the Plan's custodian employee contributions totaling \$235,645 and \$179,725 respectively, during the period prescribed by the Department of Labor regulations. Delays in remitting the contributions to the custodian were due to administrative errors. Management made corrective contributions associated with the late remittances of 2023 during the year ended December 31, 2024. Management intends to correct the 2024 late remittances during 2025.
