Opinion

We have audited the financial statements Colorado Sheet Metal Workers' Local 9 Medicare Retiree Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Colorado Sheet Metal Workers' Local 9 Medicare Retiree Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Colorado Sheet Metal Workers' Local 9 Medicare Retiree Plan (the Plan) have been prepared using the accrual basis of accounting.

Health Reimbursement Arrangement (HRA) Accounts - Net assets available for benefits include amounts available to reimburse participants for qualifying medical expenses, totaling approximately \$762,000 and \$408,000 as of December 31, 2024 and 2023, respectively. Claims payable from the HRA accounts totaled \$0 and \$1,100 at December 31, 2024 and 2023, respectively.

Revenue Recognition - Transfers are routinely made from the related Family Health Plan, at which time the funding is credited into the HRA accounts of Plan participants, as described in Note 5. The Plan carries out its purpose described in Note 2 within a jurisdiction primarily located in Colorado.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Benefit Obligations - Plan benefits are primarily provided through a defined contribution (HRA) arrangement, in which the Plan maintains an individual account for each participant. The Plan has terms that specify the means of determining the contributions to participants' accounts, rather than the amount of benefits the participants are to receive. The HRA benefits a participant will receive are limited to the amount contributed to the participant's account and expenses. Therefore, because the Plan's obligation to provide the HRA benefits is limited to the amounts accumulated in an individual's account, information regarding benefit obligations is not applicable. Benefit obligations related to the payment of future death benefits are immaterial in nature and are therefore not presented.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Reclassifications - Certain prior year amounts have been reclassified to conform with the current year's presentation.

Subsequent Events - Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established January 1, 2012, to provide a health reimbursement arrangement (HRA) program for Medicare eligible retirees and their Medicare eligible dependents. Retirees are those individuals who are eligible to receive a pension from either Sheet Metal Workers' Local No. 9 Pension Trust or Sheet Metal Workers' National Pension Fund, who were eligible for benefits under the Family Health Plan at the time of retirement.

The Plan is intended to provide a program that reimburses retirees and their dependents for premiums paid to purchase individual insurance policies designed to supplement Medicare, and for certain other qualifying health care expenses. The Plan also provides for death benefits for Medicare eligible retirees, which are provided on a self-funded basis. The Plan is a multiemployer defined contribution welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Death benefits provided by the Plan are considered to be a defined benefit feature of the Plan.

A retiree or retiree's spouse becomes eligible to participate in the Plan upon becoming eligible to receive Medicare benefits, provided that the retiree maintains continuous coverage in an insured Medicare supplemental plan. An eligible participant will lose coverage immediately if participation in a Medicare supplemental plan is no longer maintained, if any work is performed for a non-contributing employer in the sheet metal industry, if the retiree becomes eligible for benefits under the Family Health Plan following a return to covered employment, or upon death.

An HRA is an account that the Plan sets up and maintains on behalf of participants to keep track of contributions, reimbursements and available balances. Each account is funded exclusively through contributions at rates determined by the Board of Trustees. The HRA benefit to which a participant is entitled is the benefit that can be provided from the participant's HRA account. Participants are not vested in the contributions made on their behalf, and their available balance may be used only for certain qualifying health care expenses. These expenses are first used towards premiums for coverage under a Medicare supplemental plan, and remaining amounts are used to pay for qualifying healthcare expenses. No earnings are credited to a participant's HRA. Any unused amount each year may be accumulated in the participant's HRA account for future periods if the participant maintains eligibility.

Amounts remaining in the HRA account of a participant whose eligibility has terminated are forfeited on April 1 of the year following the termination of eligibility. When an HRA account is forfeited, the balance is not reallocated among other participants' accounts but is added to the unallocated net assets of the Plan to be used for purposes of funding HRA account fees and administrative costs of the Plan and to pay insurance premiums for life insurance benefits provided to eligible participants. During the years ended December 31, 2024 and 2023, amounts forfeited totaled approximately \$1,800 and \$3,500 respectively.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA) was adopted by the Plan.

Beneficiaries of Plan participants are entitled to a death benefit of \$5,000.

Participants should refer to the summary plan description for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the Plan.

Note 4. Tax Status

The Internal Revenue Service has advised that the trust established under the Plan is exempt under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving the notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Funding Policy

The Trustees have exclusive discretion as to the frequency and level of funding of the Plan. The Plan is funded through transfers from the related Family Health Plan.

HRA accounts are credited in the amount of \$235 per eligible family member, per month. In the event that a family includes more than one eligible HRA participant who is Medicare eligible, the participant's HRA account will be credited at the monthly rate for all such participants in the family. The total amount funded in this manner during the years ended December 31, 2024 and 2023 was \$857,750 and \$814,510 respectively.

The level of additional funding for the Plan, through an allocation of the hourly employer contribution rate negotiated for the related Family Health Plan, is determined based upon an estimate of reserves required to operate the Plan. There were no allocations of the hourly employer contribution rate for either of the years ended December 31, 2024 or 2023.

Participant contributions generally are not allowed under the Plan, except pursuant to the requirements of COBRA.

Note 6. Related Organizations

The Plan shares certain common governance with a number of related organizations including a local union, a pension plan and an apprenticeship fund, all of which are tax-exempt. Additionally, the Plan is related to another welfare plan, the Family Health Plan, as described below.

Family Health Plan

The net assets of the Family Health Plan, together with the net assets of the Plan, comprise the Colorado Sheet Metal Workers' Local 9 Health Fund, a tax-exempt trust. In accordance with generally accepted accounting principles, however, the financial reporting entity is the plan, and not the trust established to hold plan assets. Therefore, the Plan prepares separate financial statements and files a Form 5500 annual report separate and distinct from the Family Health Plan. The trust files a Form 990 that consolidates the financial activity of both the Plan and the Family Health Plan.

The Family Health Plan funds the HRA accounts on a monthly basis based on the number of participants. Transfers from the Family Health Plan are generally made net of expenses initially paid on the Plan's behalf. At December 31, 2024 and 2023, a total of \$503,457 and \$668,522 respectively, was due from the Family Health Plan for net amounts owed to the Plan. Any employer contributions made pursuant to collective bargaining agreements are held by the Family Health Plan prior to their allocation, as described in Note 5.

Common Administrative Expenses

Clerical and management expenses are incurred jointly with the related local union. These expenses are initially paid by the local union and are allocated monthly. Clerical and management expenses allocated to the Plan for the years ended December 31, 2024 and 2023 totaled \$934 and \$1,536 respectively.

Note 7. Unallocated Net Assets

Net assets available for benefits include amounts that are not allocated to the participants' HRA accounts. The unallocated portion at December 31, 2024 and 2023 was approximately \$238,000 and \$354,000 respectively. These amounts represent the accumulation of discretionary allocations of employer contributions as well as forfeitures, and are intended to be used for the payment of future HRA account fees, death benefits and administrative expenses incurred by the Plan. Discretionary allocations are made periodically and were last made in 2021.
